1. Heard learned counsel appearing on behalf of the parties.
2. Issue notice.
3. Learned counsel appearing on behalf of the respondent-PCI accepts notice.
4. Learned counsel appearing on behalf of the parties state that the controversy involved in the instant petition stands covered by the decision dated 26.05.2023 passed by this court in W.P.(C) 6540/2023 and other connected matters.
5. The order dated 26.05.2023 reads as under:-

"1. Learned counsel appearing on behalf of the respondent-Pharmacy Council of India, on instructions, submits that as per the directions given by the Hon'ble Supreme Court in various other cases to consider the approval which was granted to institutions for the academic year 2022-23, for the

academic year 2023-24, the respondent-Pharmacy Council of India (PCI) is considering to grant the approval to the petitioner-institutions for the academic year 2023-24.

2. *In view of the aforesaid, no further directions are required to be passed. However, the respondent-PCI is bound by the statement made by the learned counsel appearing on behalf of the respondent-PCI.*

3. *Let the necessary steps be taken within 15 days from the date of receipt of the copy of this order.*

4. *With aforesaid directions, the petition stands disposed of."*

6. In view of the stand taken by the counsel for the respondent-PCI that the application of the petitioner is being considered for grant of approval for the Academic Year 2023-2024, no further directions are required to be issued.

7. Respondent-PCI is bound by the statement made by learned counsel appearing on behalf of it.

8. Respondent-PCI is directed to take necessary steps within 15 days from the date of receipt of copy of this order.

9. In view of the aforesaid, the instant petition stands disposed of.
