1. Heard learned counsel for the petitioner and Shri Raghvendra Singh, holding brief of Shri Ravi Singh, learned counsel for the respondent no.3.
2. The present petition has been filed challenging the order dated 19.07.2023 whereby an approval sought by the petitioner from the respondent no.3 was cancelled solely on the basis of letter dated 22.05.2023 issued by the U.P. Board of Technical Education, Lucknow.
3. The contention of the counsel for the petitioner is that in similar matters where a similar order dated 22.05.2023 was passed in respect of similarly placed Institutions. This Court had entertained writ petitions and one of the order was passed in Writ - C No.7191 of 2023 on 22.08.2023, the leading case being Writ - C No. 4953 of 2023. It is argued that the case of the petitioner is separated and distinct from the said case only inasmuch that in the present case, the approval has already been rejected by the Pharmacy Council, whereas in the other cases, no decision was taken by the Pharmacy Council of India, which was directed to be taken by 30.08.2023.
4. Without going into the merits of the contention. As in the interim order passed on 22.08.2023 and another writ petitions,
