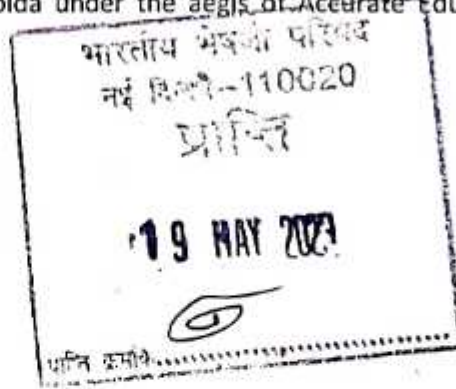
Subject: - Submission of demand draft for applying of new pharmacy college (Pushpa College of Pharmacy).

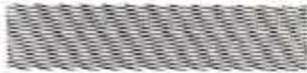
