4. GENERAL BODY -

5. CHAIRMAN & GEN SECRETARY -

- (a) The Founder Member ship shall consist of the following

 - (ii) Vice-Chairman
 - (iii) General Secretary
 - (iv) Treasurer



(b) Meeting of the Founder Member

The founder member shall meet once in a 3 calendar month. However at-least 4 such meeting shall be held in 3 year.

(c) Powers and duties of Chairman General Secretary:-

- (i) To purchase acquire, got allotted, take over any land or building or lease mortgage, hypothecate or otherwise and to hold, manage, supervisor and control all such institution or other properties for the furtherance of the aim and object or the society or the basis of no profit no loss.
- (ii) To determine all question relating to the policy and all matters pertaining the functioning of the society.

- (iii) To exercise various means and device for realizing the subscription and donations, loans, grants, aids.
- (iv) To open various bank accounts for the progress of the society and educational institution and other institution under its control and management.
- (v) To select bankers for the society.
- (vi) The Chairman & Gen Secretary shall have the write to add any new condition of modify or change the exciting condition for the benefit of the society to achleve its aims and objectives.
- (vii) To invest and keep invested the societies property in the best way possible in order to get the maximum return of that for the furtherance of objects of the society.
- (viii) To dispose of exchange or otherwise transfer any movable or immovable property if it be in the interest of the society.
- (ix) To let out demolish and immovable property comprised the basis of such terms and condition as the Chairman & Gen Secretary in their absolute decision shall think fit.
- (x) To appoint remove suspend, terminate any teacher/lectures or principal/Professor and other employees or servent of the society and institution under its control.
- (xi) To appoint and fix the duties power and remuneration for the teacher including their increment and other employees and to make rules for their leave etc.
- (xii) In special case to allow free ship and scholarship to deserving students.
- (xiii) To prepare annual accounts.
- (xiv) To control administration and manage all the affairs of the society its property and funds.
- (xv) To make rules for the management of institution under its control necessary for implementing the Government requirement and to constitute management body accordingly.
- (xvi) To prepare curriculum of the studies.
- (xvii) To decide the nominator of any institution and places under the control and supervision of the society In the name of the donor or any other person or as decided by Chairman & Gen Secretary.

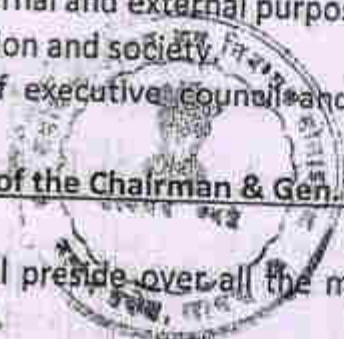

- (xviii) To do or to perform all such Acts and thinks that may be necessary in the interest of and for the benefit of the society.
- (xix) To take loan either secured or unsecured in order to means the finance of the society and the institution controlled by it.
- (xx) To collect finance by all means of fees subscription, donations, grants, aids, loan from an individuals. Association of persons firms, companies, societies, trust Government aids etc.
- (xxi) To give donations aids for upliftment of the poor and down trodden class of the society.
- (xxii) To frame sub-rules, regulations and by-laws for it self and for the institution under its control and management within the framework of the society.
- (xxiii) All documents required to be executed by the Chairman & Gen Secretary in exercise of power conferred above may be executed under the signature of all the Chairman & Gen Secretary for and on behalf of the society both for internal and external purposes.
- (xxiv) To approve the budget of institution and society.
- (xxv) To approve the expenditure of executive council and society of institution.

6- Duties and powers of the office bearers of the Chairman & Gen. Secretary:-

(a) The Chairman: -

- (i) The Chairman of the society shall preside over all the meeting and general body of the society jointly.
- (ii) To call and keep all record of the proceeding of the society meeting. To maintain a general supervision control of all the affairs as-well-as over the employees of the society and Institution under its control.
- (iii) To manage the affairs of the society and other institution under its control in accordance with the direction of Chairman & Gen Secretary.
- (iv) The Chairman and General Secretary will have jointly inherent executive power to supervise and control the functioning of the society and various institutions.
- (v) The Chairman and General Secretary can open or close any/or all accounts of the society jointly.

(b) Vice-Chairman :-

The Vice-Chairman shall perform the duties of the Chairman in his absence.

(c) General Secretary:-

- (i) To keep all the correspondence on behalf of the society.
- (ii) To approve appointment and termination of the services of the employees this is decided by Chairman & Gen Secretary.
- (iii) To realize to receive and disperse money with the permission and signature of the other Chairman.
- (iv) General Secretary will be the whole time office bearer of the society as-well-as to look after in entire affairs. The remuneration and such other expenses and allowances will be approved by Chairman.

(d) Treasurer :-

The treasurer of the society shall be responsible for keeping the accounts and getting them audited every year by the chartered accountants as appointed by the Chairman & Gen Secretary. The audit report shall be presented in the annual meeting of General body by the treasurer.

7- Modification of rules & regulations by laws of the society :-

Any amendment in the constitution of the society shall be made according to Section 12 of the societies regulation act XXI of 1860.

8- FUND OF SOCIETY :-

The fund and other assets of the society shall vest in the Chairman & Gen Secretary of the society. The fund shall be kept in any bank as any bank as may be decided by the Chairman & Gen Secretary. The account shall be operated jointly by Chairman General Secretary.

All the funds raised by the society members from the public and from the fees donations, aids, grants, loans and earning through the society surplus investment of any other resource of income shall be deposited in the societies account.

The fund of the society shall be utilized solely for the purpose of attainment of aim and objectives of the society and banner approved by jointly by Chairman & Gen Secretary.

9- Maintenance of Account and Audit:-

- (i) The entire financial power are vested in the Chairman & Gen Secretary of person authorized by them.

- (ii) The Balance Sheet and profit & Loss account of society shall be prepared from 1 April to 31 March every year. The account of the society shall be audited by the Chartered Accountant appointed by Chairman & Gen Secretary.
- 10- The Chairman and General Secretary of the society shall be legal representative of the society as for the court of law. A society may sue and be sued in the name of the Chairman & General Secretary.

11- Dissolution of Society :-

The society shall be dissolved accordance of the section 13 and 14 of the society Registration Act XXI of 1860.

(In the event of dissolution or winding up or closure of Society, the Funds, Assets and all Properties of Society will be transferred only to some other Trust/Society/~~Non Profit Company~~ having similar or charitable objectives.)

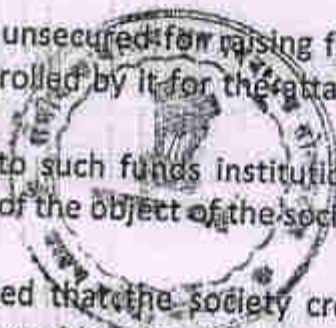
- 12- A part from the otherwise provided herein above mentioned all the matters, Chairman & Gen Secretary of the society will also do such other things to attainment of object of the society, in a charitable way. The society may also do the following for the attainment of its aims and objectives in a charitable way with the permission of Chairman & Gen Secretary.
- (a) Society is established as a nonprofit making education organization devoted to the poor class of society by catering them professional and job oriented education awareness in the field of pharmaceutical sciences. Management Computer service and application, finance & Accountancy, International Marketing, Hotel Management Export management, Medical science, Tourism, Food Science, Laboratory, Production of food by bio-chemical and other allied fields throughout the counting in a charitable way.
- (b) To improve decision making working skills and administrative competencies of the practicing manager professionals administrators entrepreneur promoters and planners.
- (c) To open manage assist and run schools, College, Hostels, Farm Gardens, Workshops Stadium libraries, Reading rooms, Auditorium and other forms of the same nature for the attainment of the objects of society on no profit no loss basis.

- (d) To arrange lectures, Seminars, Symposium, exhibitions debates for attainment of the object of society.
- (e) To undertake any constructions, Repairing, Alteration, Improvement, Notification or Building of any immovable property for the attainment of the objects of the society.
- (f) To purchase take on hire/lease or loan, acquire any movable or immovable property Rights. Trademarks copy right and to manage the same for the attainment of the object of the society.
- (g) To enter into contract or arrangement with Individuals firms, corporate bodies, association, Center/State Government for the attainment of the objects of the society.
- (h) To collect finance by means of fees, subscription, donations, Grants, aids, Endorsement Foreign Aids and Foreign Donation for individual firms corporate bodies, association, center/state Government Local Municipal Corporations for the attainment of the object of the society.
- (i) To take loan either secured or unsecured for raising finance for the society and the institution controlled by it for the attainment of the object of the society.
- (j) To give donations aids Grants to such funds institutions which are totally setup for the attainment of the object of the society.





13- Irrevocability:-



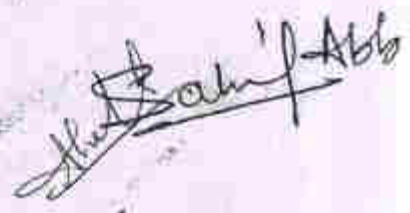
