Sub:- Transfer of 23 acres of waste land in Northern Doab Division to D.N. Polytechnic, Meerut.

Sir,

VAN (EHA) VIJHAG With reference to your letter No.A-197-O/2-21(13) dated December 8, 1963, on the above subject, I am directed to convey the sanction of the Governor to the lease of 23 acres of forest land in Rithani Block along Meerut-Delhi Road in district Meerut in favour of Deva Nagri Polytechnic, Meerut, for a period of 30 years on an annual rent of Rs.10/- per acre and a premium at the rate of Re.1/- per sq. yard on the condition that the land shall not be used for any purpose other than construction of buildings, playgrounds, etc., for the Polytechnic and shall revert to Forest Department when no longer required for the purposes of the Polytechnic.

2. A draft lease deed may please be submitted to Government for approval and the lessee may please be asked to deposit Rs.32/- as conveyancing fee under the Head of Account "XVII-Administration of Justice - Miscellaneous - D - Fees received by Government Servants for work done for private bodies" and to send a receipted copy of the Treasury Chalan to the Government Conveyancer, U.P.

3. The receipt on the above account may be credited under the relevant primary unit subordinate to the receipt head "LI-Forst" in the budget.
