This DEED OF TRUST is executed on this 9th day of May 2008 by Dr. Narendra Kumar S/o late Ch. Sukhbir Singh R/o Ch. Man Singh Bhawan, Fawara Choak, Kairana Road, Shamli Dist. Muzaffar Nagar (U.P.) hereinafter called as AUTHOR of the one part which expression shall wherever the context so admits or requires to be deemed to include the said Settler and survivor or survivors and the heirs, Executors & Administrator of such survivor or his assignees and the Settler).

2. WHEREAS the AUTHOR of the Trust has been cherishing desire of setting up a fund for charitable objects and benefits ensuring to the public at large specified hereinafter.
3. WHEREAS the AUTHOR in fulfillment of his desire to the public at large with the charitable objects specified hereinafter, has set apart a sum of Rs. 10000.00 (Rupees Ten thousands only) as the initial corpus fund of the trust to hold the same unto the Trustees with the powers and subject to provisions hereinafter contained concerning the same.
4. WHEREAS the said sum would vest in the Trustees as a legal obligation that they would hold it, and apply to the objects of the Trust and the said fund shall include all accretions thereto by way of gifts, contributions, donations in cash or in kind or any other form either in the corpus or otherwise.
5. WHEREAS the name of the Trust shall be DR. S.N.DEV CHARITABLE TRUST with its office at Dr. S.N.Dev Ashram, Near Knowledge Park, Lancer's Public School, Sikka, Shamli (Muzaffar Nagar) U.P., or any other place or places which the Trustees may decide from time to time.





- (c) Awarding scholarship and fellowship in cash or in such other form on such terms and conditions as the Trustees may think fit for the purpose of undertaking, pursuing and encouraging studies PROVIDED THAT such scholarship and fellowship shall be awarded to such needy or deserving students and scholars studying in schools, colleges, universities and other educational institutions in India or abroad.

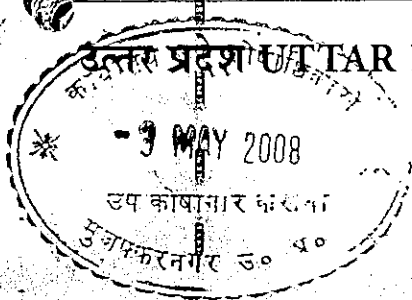

- (d) To pay tuition fee , examination fees , boarding and lodging fees to deserving students and to supply books , stationary , uniforms and other equipments necessary for their education free of cost to such needy students.
- (e) To make monthly or other periodical or lump-sum grants and contributions for the advancement of education to educational institutions.
- (f) Any other object which is incidental to above of public utility in the field of education.

2. MEDICAL RELIEF:

- (a) To set up, maintain and contribute to Hospital, Nursing Homes and other Institutions providing medical aid of any nature or of any kind to the public at large.
- (b) Endowments to hospitals, infirmaries, maternity homes, orphanages, sanatoriums and charitable dispensaries.
- (c) To set up, maintain or contribute to Medical & Pharmacy Institutes providing aid to the disabled persons suffering from any nature.
- (d) To render financial help to needy and deserving persons to enable them to obtain medical treatments either in India or abroad in cash or other forms and on such terms and conditions as Trustees shall deem fit PROVIDED HOWEVER that in case of medical treatment and medicines etc. to be obtained abroad, financial help should be rendered in India.
- (e) To set up maintain or contribute to any organizations , institutes, trusts, etc. engaged or impart naturopathy or self healing techniques such as Health-Clubs, Yoga, Meditation or self realization techniques

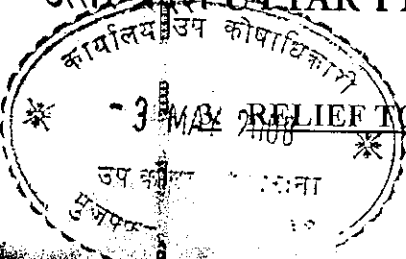

RELIEF TO WEAKER SECTION:

- (a) To aid and help the weaker section suffering from poverty, unemployment.
- (b) To distribute blankets, rags, woolen clothing, clothes or cotton, woolen, silken and other varieties of clothes to the weaker section or needy.
- (c) Establishing or rendering help to any institutions for eradication of human suffering or poverty.
- (d) Setting up or helping by endowments orphanages, old age homes, widows' ashram or houses for the benefits of orphans, elderly persons, widows and persons of weaker section.

4. ANY OTHER OBJECT OF GENERAL PUBLIC UTILITY:

- (a) To distribute food/clothes/medicines/shoes etc. to the needy people.
- (b) To give aid to handicapped persons such as artificial limbs, wheel chairs and to help spastic, deaf, dumb and blind people and their Institutions by way of grants, contributions, loans and advances with the object of helping the handicapped and their rehabilitation or occupational training.
- (c) To take over, acquire, manage, control, donate or aid any existing Institution or Institutions having objects either wholly or in part similar to the objects of this Trust and on such terms & conditions as may be thought expedient.
- (d) To spend on any cultural events of benefit to general public at large such as Ramlila, Jagrans or to contribute for statue in temple or for upkeep and maintenance of the same.

- (e) To undertake any programme of rural development including any programme for promoting the social and economic welfare of, or the uplift of the public in any rural area.
- (f) To contribute for road development activities in the area for the benefit of public at large.
- (g) To contribute for Dharmshala or public hall or community centre for the benefit of public at large.
- (h) To take-up, maintain and assist any relief measure in those parts which are subject to natural calamities like famine, fire, flood, drought, earthquake etc. or riots.
- (i) To contribute for any sport events for the upliftment and betterment of the society at large.
- (j) To contribute for the marriage of needy girls directly or through any organization or institution or to aid an organization, institution or set up engaged in the welfare of girls, women and their rehabilitation or occupational training so as to enable them to earn their livelihood.

8. THAT the Trustees shall be entitled to accept and receive donations in the shape of cash or in kind will keep Trust funds in such securities as may be permitted under the Income Tax Act from time to time. The donations received in kind will be got converted in to money securities as permissible under the provisions of Income Tax Act or prevailing laws at the earliest possible. The Trustees shall be entitled to receive donations from other Charitable Institutions also and vice versa.

9. THAT all moneys forming part of the Trust Fund and requiring investment shall be invested in the name of Trust in such manner as may be prescribed under the law/regulations, applicable from time to time.

10. THAT the Trustees shall be entitled to appoint additional Trustees, but in no case, total number of Trustees shall exceed nine.

11. THAT the Trustees shall be empowered to appoint agents and servants and to remove them subject to the provisions of the Trust.

12. THAT the Trustees shall do all such other lawful acts as may be incidental in conducting the attainment of objects of the Trust.

13. THAT all records, minute books, title deeds, securities, account books, vouchers, papers and documents, relating to the Trust shall remain in the custody of such person or persons and at such place or places as the Trustees may from time to time determine.

14. THAT the Trustees shall keep proper books of account in which all receipts and out-goings relating to, the Trust shall be entered and such books shall be kept at the office of the Trust. The Trustees shall at the end of March every year make and prepare all proper accounts of receipts and out-goings in connection with the Management of the Trust for the preceding year and shall get it audited by the Chartered Accountants appointed from time to time by the Trustees.

15. THAT the Trustees shall be entitled to make rules and regulations for the management of the Trust and all matters concerning the Trust including conduct of meeting of the Trustees provided such rules and regulations shall not be repugnant to the provisions hereof or offend against the purposes of the Trusts or be inconsistent therewith.

16. WHEREAS the number of Trustees shall be at least three which may be increased to nine depending upon the requirement by the existing Trustees. Two third of the Trustees shall form a quorum at all meeting of the Trustees.

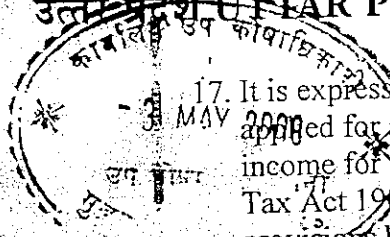

17. It is expressly declared that no part of the trust property or its income shall be applied for any purpose which is not a public charitable purpose in law and or its income for any non-charitable purpose or contrary to the provisions of Income Tax Act 1961 or any statutory modifications thereof. All the powers and provisions hereof shall be construed as being subject to the restrictions and limitations herein contained.

18. WHEREAS the Trustees will have the following enabling powers for the smooth functioning of the Trust and its activities.

Apart from the management and control of the Fund, the Trustees will have the power: (A) To buy and maintain agricultural land, farms and orchards and to earn the income from sale of the agricultural produce to use income to fulfill its objects in the field of education, medical relief, help to weaker section of society and other objects of general public utility.

(B) To enter into any financial transaction or contract with regard to acquisition or transfer of movable/immovable assets, except the corpus fund for the objects of the Trust. (C) To appoint the Manager and employees as may be required for the management of the Trust.

(D) To receive/ accept grant of donations or to donate funds to other Funds or Trusts or Institutes whether in cash or in kind.

(E) To receive / accept loans / funds / money from any Bank, financial institution, person to acquire, purchase any immovable or movable property for establishment, erection, equipment and maintenance any school, college or technical & professional education institution.

(F) To mortgage or pledge or give security of the movable or immovable property of the Trust to any bank or banks for the money borrowed or loan received for fulfillment of the objects of the Trust.

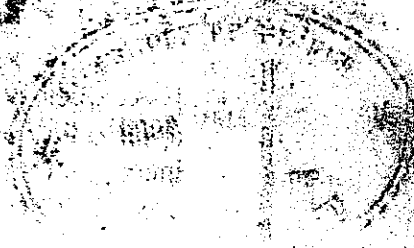

(g) To invest and manage the Trust fund in the Government Securities or permitted modes of investment as per Income Tax Act, 1961 or any Act applicable to the management of the Trust.

(h) To open accounts in the Bank of Banks in the name of Trust. The said account shall be operated by two Trustees of the Trust or persons authorized by the Trustees in writing in this behalf. The funds of Trust should not be kept or invested in the Private Companies or Private Concerns other than recognized Banks/ the Nationalized Banks or Financial Institutions set by the Government.

(i) To sell, dispose of, alienate or otherwise deal with any property movable or immovable comprising the Trust fund. However, the immovable property of the Trust shall be sold only in contingency and/or distress.

(j) To let out any immovable property comprised in the Trust Fund, for such period and at such rent and on such terms & conditions as the Trustees in their absolute discretion shall think proper.

(k) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding the Trust properties.

(l) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for management of the affairs thereof and of running any Institution in furtherance of the objects of the Trust.

19. Whereas the Settler, Dr. Narendra Kumar shall be life Chairman of the Managing Committee of the Trustees and in consultation with other trustees if he wish in his life, he will have power to nominate a Chairperson of the managing committee and he would be responsible for overall management and control of the functioning of the Trust with reference to its objects.

20. Whereas the Chairman would have the power to nominate any other trustees but the number shall not exceed nine.

21. The Trust, if for any remote reasons, be dissolved, all its corpus on the date of its dissolution shall be transferred to any Trust having the similar objects as that of the Trust as may be decided by the Chairperson and the trustees.

22. WHEREAS Trustees shall not be entitled to any remuneration except that they would be reimbursed all the expenses actually incurred by them in connection with the work or activities of the Trust.

23. This Trust is irrevocable and the paramount intention of the Settler is to execute a Trust of public charitable nature. However, the Trustees shall at any time be entitled to alter, amend or change or add to the objects of the Trust, which are of a public charitable nature and utility as and when they think fit and they are in consonance with the social structure and requirements of the public.
