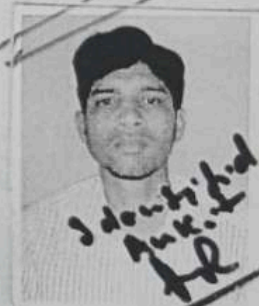

THIS INDENTURE is made at Moradabad this 1<sup>st</sup> day of March, 2012, among Ashish Agarwal resident of Kha-56, Naveen Nagar, Kanth Road, Moradabad Indian Resident, hereinafter referred to as "THE SETTLOR" (which expression shall unless it be repugnant to the context or meaning thereof be deemed to include his heirs, executors or administrators) of the One PART, AND

(1) Mr. Ashish Agarwal s/o Shri Sunil Kumar Agarwal resident of Kha-56, Naveen Nagar, Kanth Road, Moradabad AND (2) Mr. Ankit Agarwal s/o Mr. Sunil Kumar Agarwal resident of Kha-56, Naveen Nagar, Kanth Road, Moradabad and hereinafter referred to as "THE MANAGING TRUSTEE" (which expression shall, unless repugnant to the context or meaning thereof, be deemed to include the survivors or survivor of them and the heirs, executors or administrators of the last survivor and the trustee or Managing Trustees for the time being of the trust hereby declared and their heir or assigns) of the Second Part.

WHEREAS the Settlor is desirous of settling for public charitable purposes, of his

AND WHEREAS THE SETTLOR above named has settled a sum of Rs. 50,000.00 (Rupees Fifty Thousand only) as a fund.

AND WHEREAS the Managing Trustees of the said trust have individually and jointly have agreed to act as Managing Trustees of the Trust, proposed by the party of the First Part.

AND WHEREAS THE TRUSTEES named are willing to accept the office of the Trustees for the purpose of carrying out the wishes of the SETTLOR of the trust under the provisions and directions set forth herein, so as to enable to pursue its vowed objects.

AND WHEREAS nothing contained in this deed shall be deemed to authorize the managing trustees to do any act which may in any way be construed statutory modifications thereof and all activities of the trust shall be carried out with a view to benefit the public at large, without any profit motive and in accordance with the provisions of the Income-tax Act, 1961 or any statutory modification thereof.

AND IT IS HEREBY DECLARED that the charitable objects hereinabove mentioned shall not be limited or restricted to any particular religion community caste or creed;

**THIS INDENTURE WITNESSETH AS FOLLOWS**

- 1. NAME :-** The name of the Trust shall be **MAA GAYATRI EDUCATIONAL TRUST.**
- 2. PLACE :-** The principal office of the Trust shall be situated at **Kha-56, Naveen Nagar, Kanth Road, Moradabad** or such other place as the Managing Trustees may from time to time decide. The Trust may also carry on its work at any other place or places, as decided by the Managing Trustees.
- 3. Area of Work - All India.**

**4. OBJECTS**

- (1) To provide education to the general public without distinction and discrimination of any kind on the grounds of religion, religious community, caste and creed of blood. Scholarships shall be granted to the poor-cum-intelligent students.
- (2) To the establishment, acquisition, maintenance and support of Schools, Colleges, Vidyapiths, Bal Mandirs, Study Centres, Research Institutes, Universities, Technical Institutes, Poly techniques, Traing Centre, Internship Centre and other institutions or funds imparting education and training of students.
- (3) To the establishment of Schools of state/regional boards as well as CBSE and ICSE board etc.
- (4) Grant subscription and donations to hospitals, dispensaries - convalescent homes, asylums, nursing homes and other public institutions for administering medical relief upon such terms and conditions and for such period as the Managing Trustees may think fit.
- (5) To spread general awareness amongst the public for preserving and storing the Rain water and promoting Rain Water Harvesting. The Trust will implement Rain Water Harvesting in all its establishments.
- (6) To the establishment and support of Professorships, Lectureships, Fellowships, Scholarships and prizes and establishment of endowments at any schools, colleges, universities or other Institutions for promotion of education and knowledge.
- (7) To the establishment and maintenance of Hostels and/or Boarding houses and Grants of Free Boarding Lodging to students or scholars upon such terms and for such period in such case as the Managing Trustees may deem fit.
- (8) Grant of monetary assistances from time to time to any Schools, Colleges, Universities, Vidyapiths and other institutions which impart or provide education in any branch of knowledge and for such period and upon such terms in each case as the Managing Trustees may deem fit.
- (9) Award of Scholarships, Fellowships and Grant by way of loans and otherwise and on such terms and conditions as the Managing Trustees may think fit for purpose of undertaking persecution and encouraging research in any branch of knowledge.
- (10) Grant of monetary assistance including scholarships and/or loan to students or scholars whom the - Managing Trustees may deem to be deserving thereof to enable them to receive such education training and qualification as the Managing Trustees may approve including academicals, professional, vocational, technical and

- upon such-terms and for such period in each case as the Managing Trustees may deem fit.
- (11) Supply of books, food and clothes and fees to students or scholars or grant of monetary assistance to them for such purposes as aforesaid.
  - (12) To the establishment, maintenance and support of libraries museums, reading rooms and other facilities means for advancement of education and knowledge.
  - (13) Promotion of education and learning in all branches of knowledge.
  - (14) To establish cultural and religious centre to spread ethics among the society and specially new generation.
  - (15) Establishment, maintenance and support of dispensaries and hospitals with or without medical schools or colleges and nursing institutions for treatment of patients suffering form diseases of any kind and accident.
  - (16) Establishment acquisition and maintenance and support to hospitals, dispensaries, maternity homes, sanitariums, study centers, medical schools, or colleges or institutions imparting medical knowledge.
  - (17) Grant of medical help during epidemic, famine, flood, or earthquake or any - unforeseen occurrence or an act of God or war like operations, riots, civil-commissions and such and similar - occurrences.
  - (18) To orgainse the cultural, religiolus and educational tours.
  - (19) To construct, maintain and manage community halls, meditation halls, halls for lectures, discourses and debates for advancement of knowledge and gaining mental health, peace and stability.
  - (20) To establish, maintain and manage libraries and reading rooms.
  - (21) To start and manage centers for training youths in self-employment and job-oriented courses.
  - (22) To assist unemployed person in starting their own business by making Self Help Group under NABARD, National Women Fund, Banks etc.
  - (23) To canvas and to have programs for afforestation and ecological balance.
  - (24) To have programs for all-round development of villages and rural communities.
  - (25) To grant scholarships and freeships and free food to the poor and deserving students.
  - (26) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

- (27) To grant relief and assistance to the needy victims during natural calamities such as institutions. Establishments or persons engaged in such relief work.
- (28) To communicate with and keep liaison with Central Government, State Governments and any other concerned departments and authorities in India and abroad on all subjects relating to activities of the Trust.

Provided always and it is hereby declared that if any one or more of the objects specified above are held not to be objects of the public charitable trust, the Managing Trustees and Trustees shall not carry out such objects or objects, as if the same are not incorporated in these presents but the validity of the Trust created by these presents as a Trust for public and charitable purposes shall not be affected in any manner.

#### **5. FUNDS**

The Managing Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind, including immovable property without any encumbrance, but the Managing Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Managing Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

#### **6. INVESTMENTS**

- i. All monies, which shall not immediately required for current needs shall be invested by the Managing Trustees in eligible securities and investments, or in banks. Such investments shall be in the name of Trust or Managing Trustees.
- ii. That the Managing Trustees shall invest the trust fund, carry on any business with the trust fund and/or enter into partnership on behalf of the trust, as they may deem fit.
- iii. That the Managing Trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or management thereof.
- iv. IT IS DECLARED that the Managing Trustees shall each year apply the residue of the income of the Trust Estate and may at their discretion at any time and from time to time apply also Trust Estate or any part of the Trust Estate in or towards all or any one or more of the aforesaid categories of public charitable purposes aforesaid And without prejudice to generality of their powers and subject to the limitations or conditions contained above,

- in or towards any one or more of the following and in such proportion and manner as the Managing Trustees in their absolute discretion may think proper.
- v. That the Managing Trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.
  - vi. IT IS HEREBY FURTHER AGREED AND DECLARED that the surplus and unapplied portion of the said income, if any, arising in any one or more year or years shall be accumulated by investing the same and the resulting income thereof from time to time in any of the investments in which the Trust Funds are directed or authorised to be invested and shall be credited to an account to be called "**Surplus Account**" and the Managing Trustees shall have power in any subsequent year or years to expend and employ the same in the same manner and to the same extent as if such accumulations or parts thereof had been part of the income of the year in which the same are or is sought to be expended and employed as aforesaid subject to the provisions of Income-Tax Laws or any other laws that may be in force from time to time.

**7. BOARD OF TRUSTEES**

- (i) The affairs of the trust shall wholly and exclusively be governed by a board of trustees, (hereinafter called the Board) which shall consist of not less than two and not more than twenty members; (hereinafter called the Managing Trustees and Trustees)
- (ii) Mr. Ashish Agarwal, the Managing Trustee (Founder) shall act as President of the Trust and preside at all the meetings of the trust.
- (iii) The board of trustees may nominate any other person to the board of trustees, if it deems fit.
- (iv) On account of death of any Managing Trustee, his/her eldest son or his/her nominee shall become the Managing Trustees in his/her place. Otherwise his legal heir or the wife of the deceased member shall be eligible to become Managing trustee.

**8. POWER AND DUTIES OF MANAGING TRUSTEES**

That Managing Trustees shall be entitled to utilise and disperse either the net income of the trust estate and/or parts of the corpus thereof for maintaining and/or conducting establishments for the charitable purposes and trust hereinabove set out and also as they in their discretion deem fit and proper to make contribution and/or donations to charitable institutions and/or establishments having one or more of the charitable objects hereinabove set out;

1) The Managing Trustees shall have power and shall be entitled to collect, recover and receive dividends, rents, profits interest and other income of the **TRUST ESTATE** (hereinafter referred to as the "**Trust Income**") and to pay there out all taxes, rates, assessments, expenses and outgoings for a collection in respect thereof and for the management of the **TRUST ESTATE** and for administering and carrying out the trust hereof.

2) The Managing Trustees shall be entitled from time to time to accept from any person or persons desiring to make gifts or donation upon the TRUSTS and subject to the terms, provisions, powers and conditions contained therein such money or properties as the donors desire from time to time to give on the aforesaid trust and on the terms and conditions herein contained.

3) It shall be lawful for the Managing Trustees at any time and from time to time to borrow moneys as well as to sell, mortgage, assign, transfer, demise or let or lease for any period for however long or otherwise dispose of and deal with the **TRUST ESTATE** including any immovable properties comprised therein or any part thereof either by public auction or by private contract and on such terms and conditions as they the Managing Trustees think fit with liberty to the Managing Trustees to buy rescind or vary any contract for sale, mortgage, transfer, assignment, lease or other disposition without being answerable for any loss occasioned thereby and with power also to execute all necessary assignments, conveyances, mortgages, transfers, leases sub-leases and other deeds and assurances for the same and to give receipts and discharges for the consideration moneys and all other moneys. All moneys, arising from any such sale, mortgage, transfer or other disposition shall be deemed to be part of the said estate and shall be dealt with accordingly.

4) The receipt of the Managing Trustees for the purchase money of any property hereby directed or authorised to be sold, or for any other moneys, stocks, funds, shares, securities or investments paid delivered or transferred to them or him by virtue of these presents or in the execution of the Trusts or powers hereof shall effectually discharge the person or persons having delivered or transferring the same there from and/or from being bound to see to the application or being answerable for the loss or misapplication thereof.

5) The Managing Trustees for the time being of these presents shall be respectively chargeable only for such moneys and securities as they shall respectively actually receive, notwithstanding their respectively signing any receipt for the sake of conformity and shall respectively be answerable and responsible only for their own respective acts, receipts,

omissions, neglects and defaults and not for those of each other, nor for that of any bankers, brokers, auctioneer, or other person with whom or into whose hands any trust moneys or securities shall be deposited or come, nor the insufficiency in title or deficiency in value or any investments nor any other loss, unless the same shall happen through their own willful default or himself or pay and discharge out of the Trust Estate all expenses incurred in or about the execution of the Trusts or powers to these presents.

6) The Managing Trustees for the time being of these presents shall have full power to compromise or compound all actions, suits and other proceedings and all differences and demands and to refer any such differences or demand to arbitration and to adjust, settle and approve all accounts relating to the Trust Estate and to execute releases and to do all other things relating thereto without being answerable or accountable for any loss occasioned thereby.

7) If and so often as any of the Managing Trustees hereunder appointed or any future Managing Trustees, or Trustee of these presents shall die or shall leave India for more than one year or shall desire to retire from or refuses to act or become incapable to act in the Trusts of these presents or otherwise, it shall be lawful for the surviving or continuing Managing Trustee or Managing Trustees for the time being of these presents (and for this purpose to act in the execution of this power be considered to be continuing Managing trustee) or for the proving executors or administrators of the last surviving Managing Trustee to appoint a new Trustee who will be only the successor or legal heir of the existing Managing Trustee. The person appointed in place of Managing Trustee will also be called Managing Trustee.

8) Any Managing Trustee or Trustee may at any time resign by giving One month's notice to any Managing Trustees and upon expiry of such period, he shall be deemed to have vacated his office.

9) If Managing Trustee (Founder) deem fit they can include as many Managing Trustee as they mutually decide. While the number of Trustees can be increased or decreased as the Managing Trustees may decide.

10) The Managing Trustees shall determine all questions and matters of doubt in the execution of the Trusts, including the meaning and constructions of any of the articles and provisions herein contained and do all acts and execute all the trusts, powers and authorities appertaining in these presents, unanimously and in case of disagreement, by majority, each Managing Trustee having one vote only. The Managing Trustees shall be at liberty to make rules and bye-laws for the due administration of the Trust provided such rules and bye-laws are not inconsistent with what is herein contained.

11) For the purposes mentioned above or any of them, the Managing Trustees shall be at liberty to enter into, sign execute and deliver all such contracts, deeds, assurances and writings as they may deem necessary or expedient. The Managing Trustees shall also be entitled to incur all legitimate expenses which they consider to be beneficial to and in the interest of the Trust.

12) The Managing Trustees shall be entitled to invest the Trust Estate or such other funds of the Trust as are not immediately required, in any of the investments which is mentioned under the head "INVESTMENT" in this deed as per the laws of the nation may suggest. The Managing Trustees shall also be at liberty to invest the Trust Estate or any part thereof on the Mortgage of any immovable property situated in any part of the Republic of India (*either of Free Hold or Lease-Hold or any other tenure*) and the Managing Trustees shall also be entitled to purchase immovable properties, including vacant land of any tenure and to construct buildings and other structures thereon as the Managing Trustees may consider necessary and in the interest of the Trust and they shall also be entitled to pull down and demolish and to-rebuild any building or erection as they may consider - necessary and in the interest of the trust, AND the Managing Trustees shall have power to alter, vary or transfer the investments from time to time in such manner as the Managing Trustees may think fit and proper and in the interest of the Trust.

13) The Managing Trustees shall be entitled to obtain tenancies and/or take on lease any premises and/or properties as they may consider proper and in the interest of the trust.

14) The Managing Trustees may give or consent to give for advancement of any object of the Trust any loans to deserving and needy persons and shall have power in their discretion to charge or forego interest and/or to allow the repayment of the loans by such installment and/or in such manner and upon such terms and conditions as the Managing Trustees may in

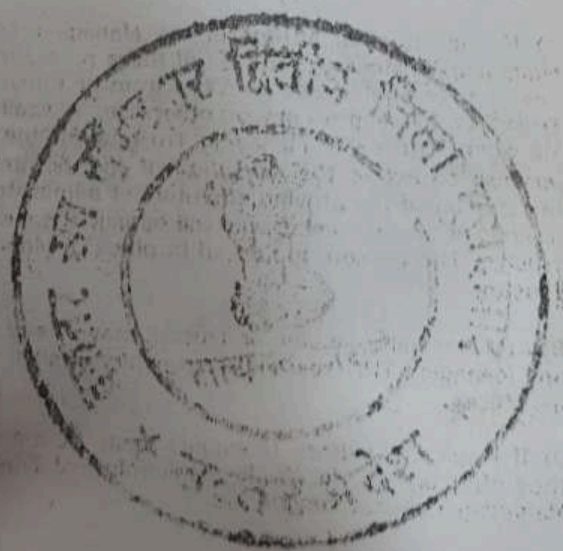
