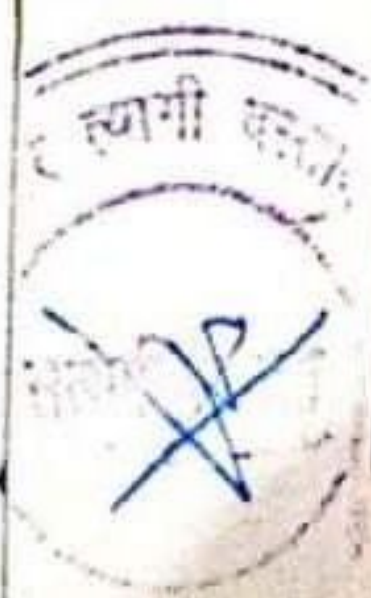

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-

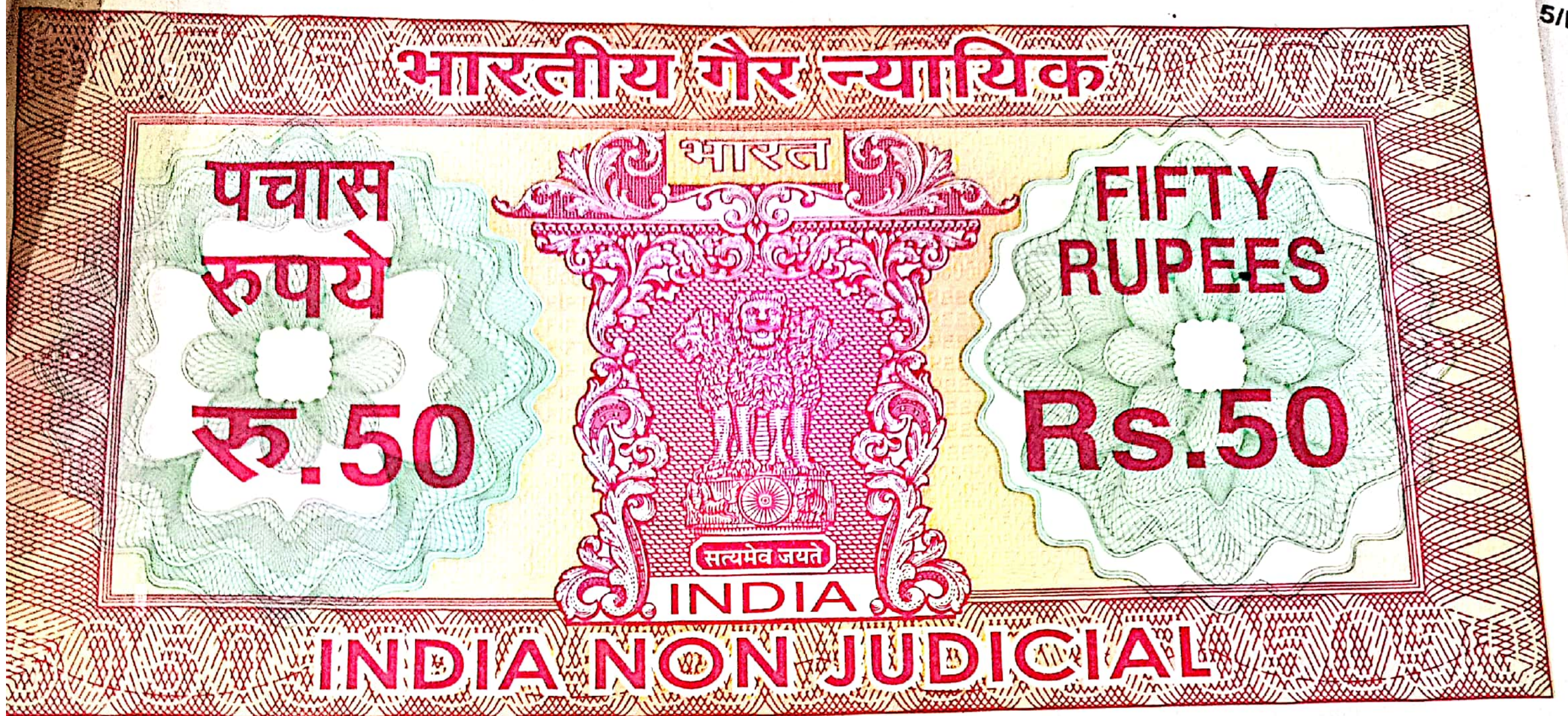

2. The name of the TRUST shall be SHRI JAGANNATH JI EDUCATIONAL TRUST.
3. The head office of the TRUST FUND shall be at Vill. & P.O. Sikri Kalan, Teh. Modinagar, Distt. Ghaziabad (U.P.) or at such other place or places in India as the trustees may from time to time think fit.

 - To establish, maintain and or grant aid in cash and or kind to hospitals, medical school, medical colleges, engenering colleges, nursing Institutions, sanitoriums, charitable and or travelling disp;ensaries, after care clinics, maternity homes and or child welfare centres, orphanages, widows homes and or out post nursing homes and or such other simlar institutions for the benefit and use of the public in general.
