AND WHEREAS as accordingly the General Council in its meeting has granted permission to register the deed under the law of Centre as educational trust and authorized to issue this Certificate to the said Trust deed with the following terms and conditions.

THE TRUST DEED TERMS

1. The name of the Trust shall be **ALY AHMED EDUCATIONAL TRUST.**
2. The registered office of the Trust shall be at Farvada Villa, Opposite Alya Samaj Mandir, Station Road, Ahera (J.P. Nagar). The Trustees are at liberty to change the Registered Office to anywhere else in India.
3. Trust Property : In order to effectuate the above referred decision of the settlor of the Trust, the settlor of the Trust had made over to the Trustees the sum of Rs. 20,000/- (Rupees Twenty thousand only) to hold the same together with all additions and accretions there to and all the properties that may be acquired

4. OBJECTS OF THE TRUST :-

The Principal aims and objects of the trust are to promote the education of art, commerce and Science.

- (i) To establish and maintain a Kindergarten, Elementary, Primary, Middle, Secondary, and Senior Secondary School.
- (ii) To establish and maintain Colleges, Hostels, Boarding Homes, Crèches and allied Institutions.
- (iii) To establish and maintain B.S.A., M.B.A. and Engineering Study Institution.

(iv) To supply and maintain the personnel thereof and of all other things necessary to carry out the objects of the TRUST.

2. TO ATTAIN THE ABOVE SAID OBJECTS THE TRUST IS AUTHORIZED.
- To lease over and manage all the existing institutions.
  - To establish and control new institutions or other service institutions or activities anywhere in India and manage the same and if circumstances warrant suspend or close any such institutions or activities at such places as necessary.
  - To incur all kind of expenses whether of capital or revenue in nature for maintaining the personnel including the expenses of their recruitment, education training to them.
  - To establish and assist in educational institutions and for this purpose to employ necessary staff of teachers, principals and other staff.

- e. To take over any amount of assets of any institution or activity under the Aley Ahmed Educational Trust and make use of the same elsewhere for the better achievement of the objects.
- f. Grant of educational help to the poor and deserving persons.
- g. Grant of subscription, contribution and donation to any institution registered for the same purposes.
- h. To establish, manage and run nursery, primary, middle, secondary, senior secondary school, and B.A., M.A. and Engineering colleges.
- i. To establish and maintain college, hostel, boarding house, library and allied institutions.
- j. To provide funds or subsidy or advances to various educational institutions as circumstances warrant.

6. BOARD OF TRUSTEE :

(a) The Trustees shall be :

Shri Adil Perwaiz	Managing Trustee/1st Trustee
Shri Aley Ahmad	2nd Trustee
Smt. Rana Perwaiz	3rd Trustee

(b) Whenever new persons are elected or appointed as successors to the above said trustees, the new ones will take charge in the place of outgoing Trustees.

(c) All the Trustees shall be jointly known as ALEY AHMED EDUCATIONAL TRUST, hence "Board of Trustees".

(d) The head of the Board of Trustees shall be known as Shri Adil Perwaiz, hereinafter called the Managing Trustee and others as Trustee thereafter who among the trustees will be elected as Managing Trustee shall act as Managing Trustee of the Trust.

(e) The number of Trustees shall be minimum two and shall not exceed five.

(f) Within six months of every financial year ending & meeting of the Aley Ahmed Educational Trust shall be held to consider and approve the audited accounts of the trust.

7. POWERS OF THE TRUSTEES AND THEIR DUTIES :

Subject to the limitations and procedures provided in the constitution and articles the trustees shall have following powers and duties:

- (i) To gather funds towards corpus or otherwise for the Trust by way of Donations, Grants, Subsidies or otherwise from Friends well-wishers, Native or Foreign either in cash or in kind for the purpose of the Trust.
- (ii) To take over, purchase or accept as Donation or Gift Assets or properties both, movable or immovable from any other society or Trust having similar nature of aims and objects.
- (iii) To spend income earned or the income of the future for or all of the objects of the Trust either directly or by contributing to other genuine institution to spend for the purpose of Trust.
- (iv) To accumulate income if necessary for attaining the objects of the Trust in future and to set apart the whole or part of the income for the corpus of the Trust Fund for any of the objects of the Trust.
- (v) To take loans from any person, bank or institution with or without interest whether pledging the assets of the Trust or otherwise in the best interest of the Trust.
- (vi) To acquire, by purchase or construction, immovable properties and alter, extend, demolish any of such property and even to dispose off the same in the best interest of the Trust.
- (vii) To sell, alter, vary, transpose, dispose off, alienate or otherwise deal with any property movable or immovable, comprising the Trust

funds or any investment representing the same and to reinvest the same in any manner as the trustees may think fit.

- (viii) To let out or demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the trustees think fit.
- (ix) To make, vary alter, modify schemes, rules and regulations for carrying out objects of the Trust and for the management of the affairs thereof and for running any institution in furtherance of the objects of the Trust or otherwise for giving effect to the objects of the trust.
- (x) To print and publish books, pamphlets etc. or purchase and distribute literature either free or at concessional rate.
- (xi) To appoint a person as sub-committee to manage the day to day affairs of the Trust or for any particular activity if necessary.
- (xii) To appoint, authorise or give Power of Attorney to others to represent the Trust in any matter connected with the affairs of the Trust.
- (xiii) To join, co-operate, or amalgamate this Trust with other trust fund having same kind of allied objects, upon such terms and conditions as the trustees think fit, subject to the approval of the Board of Trustees.

8. POWERS AND DUTIES OF THE MANAGING TRUSTEE :

Subject to the limitations and procedures provided in the constitution and at times the Managing Trustee shall have following powers and duties.

- (a) To work, manage, control and supervise all the affairs and the management of the properties now and hereinafter belonging to the institution of Trust and develop them.
- (b) To enter into any contract or agreement for and on behalf of the Trust for any of the purposes concerning to the affairs of the institutions of the Trust which are beneficial to the interest of the Trust.
- (c) To appear and act for and on behalf of the Trust in all legal proceedings before any competent authority.
- (d) To appoint and constitute advocates and other Attorneys whenever necessary and to remove them whenever he feels such removal is necessary.
- (e) To take loans or borrow money as decided by the Board of Trustees and execute promissory notes, bonds for the same and to discharge the same by repayments.
- (f) To do any and all Acts, deed and things necessary for the efficient Management and Administration of the Trust and for other properties of the Trust.

- (g) The Managing Trustee shall have the power to delegate his duties and functions to any other member of the Board of Trustees.
- (h) All the Acts, deed and things lawfully done by the Managing Trustee by virtue of this Trust deed shall be binding on the Trust.

9. BANK ACCOUNTS :

The Board of Trustees shall decide to open one or more bank accounts in one or more banks in the name of the Trust and these shall be operated jointly or severally as decided by the Board of Trustees.

10. SAVING CLAUSE :

- (a) It is expressly declared that this is an Educational Trust and no part of the trust property or its income shall be applied for any other purpose.
- (b) It is further provided that the provisions in the constitution as amended from time to time shall be binding on this trust as well as on the members of the trust.
- (c) The trustees are at liberty to register this Trust, as a whole, or to register any particular institution or activity of this Trust separately.

11. WINDING UP :

When the trustees feel that it is better to wind

12. AMENDMENTS :

Any provision in this deed except the object Clause No.4 may be amended, annulled or substituted by the Board of Trustees at any time.

The initial value of this Trust Fund is Rs.20,000/- (Rupees Twenty thousand only) and no other property neither movable or immovable is involved as part of this Trust Deed.






