1. For education;
2. For medical relief;
3. For the service of humanity and the eradication of every form of human suffering, the establishment of different institutions to be engaged in development and social welfare in India and abroad.

AND IT IS HEREBY DECLARED that the charitable objects here in above mentioned shall not be limited or restricted to any particular religion community caste or creed;
