- d. That it is reiterated that Board of the trustees of the Late Amar Nath Anand Trust shall be supreme Governing Body of all the institutions, which shall be established under this trust deed, Hostel, Boarding House etc. establish or run by at and its Fund. Management of various institute and colleges, hostel establish or run by the Board Trustee shall work under supervision, control and direction of the Board of Trustees. No person or body shall have the power to alter this Supremacy.
- e. The Board of trustee shall have the power and discretion to accept any donation or contributions (Whether such donation or contributions be in cash or in form of immovable or movable property).

10. POWER & DUTIES OF THE TRUSTEES:

- a. The trustees shall purchase a piece of land and shall erect a building suitable for Institutions/ Colleges/ School, Hostel and Boarding House in accordance with the plan passed by the competent authority.
- b. The trustees shall employ such staff as they think necessary for giving Technical, Non-Technical and Vocational Education to the students as well as to develop their physique and character on such salaries as they think fit and replace them whenever they think necessary. The trustees shall also employ and remove other servants which they consider necessary for the purpose.
- c. Out of the income of the trust fund the trustees shall defray the expenses for running the Institute/College/School, Hostel and Boarding House as aforesaid and expenses for erecting building of the Institutes/ Colleges/ Schools, Hostel and Boarding House, but if the income is insufficient for that purpose the trustees may use such portion corpus of the Trust fund as may be necessary.
- d. The trustees shall have the power to borrow money on the security of trust property and to alienate the trust property for necessary purpose.
- e. The trustees may invest the surplus funds in their hands in such securities as they deem fit.

11. MANAGEMENT

12. ACCOUNT

That the Account of the Late Amar Nath Anand Trust shall be opened in the Scheduled bank with the consent of all the Trustees of the Board of Trustees of the Late Amar Nath Anand Trust wherein all the income and donation shall be deposited (after meeting day to day expenses.) Any balance after payment of Govt. revenue, cesses, taxes, Licenses fees for all the purposes and all expenses of collection shall be deposited in such bank and invested as the trustees may consider proper.

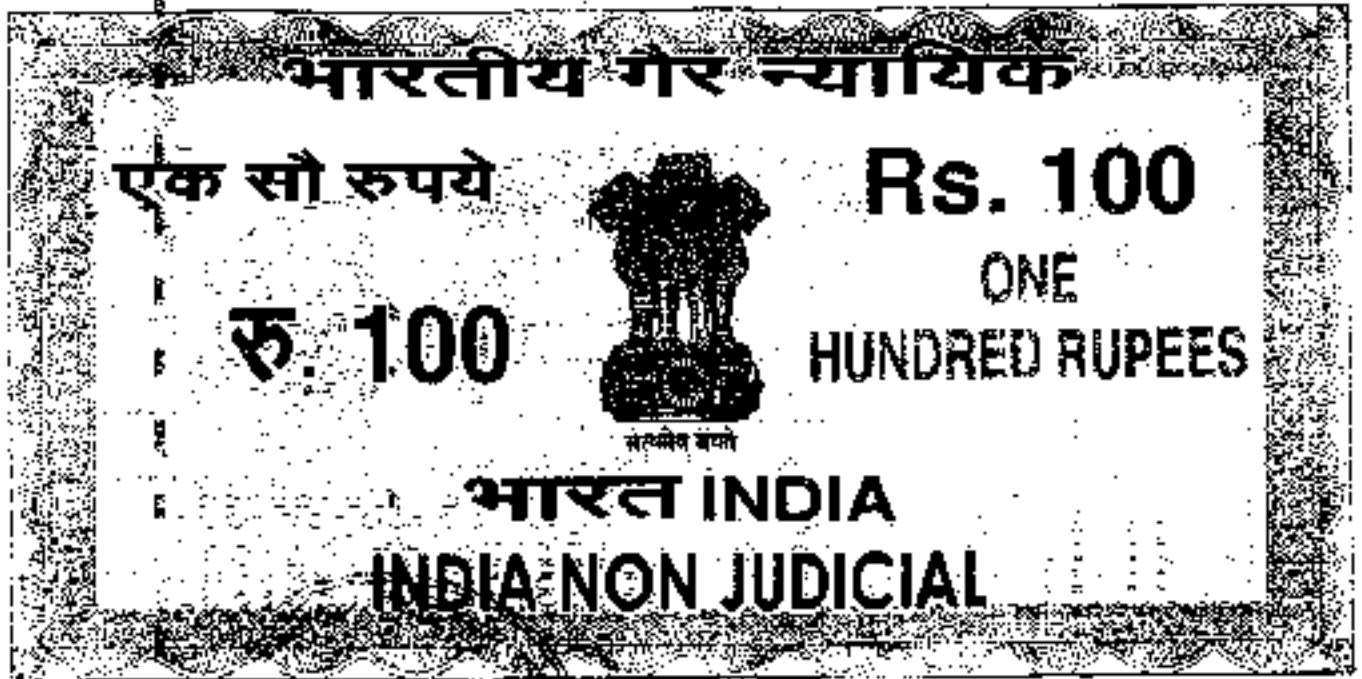


