DEED OF DECLARATION OF PUBLIC CHARITABLE TRUST THIS TRUST DEED OF KRITIKA CHARITABLE TRUST made on 2.5. day of july, 2015. TRUSTEES ARE-

Herein after known as the trustee of the Board of Trustees(which expression shall unless repugnant to the context be deemed to include their Survivor, or survivors)

have already set apart a sum of WHEREAS We the said Authors Rs.11000/- in cash towards constituting a public charitable trust and handed over the same to the triptees liciein before appearing:

AND WHEREAS the trustees have also accepted the trust fund as stated above AND WHEREAS it has become necessary to declare the objects and terms of the Trust *KRITIKA CHARITABLE TRUST

NOW THIS TRUST DEED OF the KRITIKA CHARITABLE TRUST WITNESSES as under

- The name of the trust shall be KRITIKA CHARITABLE TRUST and its office shall be for the present at Kopal Hospital Suresh Sharma Nagar Bareilly and at such other place or places as the trusters herein may decide from time to time.
- 2. The first trustees of the trust thall be as -taled above.
- 3.Sri Krishan Pat Gangwar shall be designated as the Managing Trustee, who shall be in charge of the day to day affairs of the Trust.
- 4. The Managing Trustee is empowered to co-opt 4 trustees for trust and fix the terms of their appointment.

5. The Managing Trustee shall have power to administer the funds of the Trust and any power exercisable by the Board of Trustees may be delegrated to the Managing Trustee.

- The Managing Trustee shall hold office for life or until he resigns there from.
- The Managing Trustee shall have power to fix the terms of the other trustee of the Trust.
- A. The Managing Trustee during the lifetime shall name the successor to the Managing Trustee and on his failure to do so, may be appointed by the Board of Trustees, on such terms and conditions as the Managing Trustee or , as the case may be, the Board of Trustees deem fit.
- 9. The Managing Trustee shall have overall power of superintendence over the affairs of the Trust and shall have in particular, the power to operate the bank accounts, borrow monies for the trust and carry out the objects of the trust.
- 10. Proper accounts for the trust shall be kept at the office of the trust.
- The initial contribution of Rs.11000/- made by the author of the trust shall hereby vest in the trustees and shall constitute the initial trust fund.
- 12. The trust fund may be augmented by the income from the initial fund and also by donations and other centributions from time to time.
- 13. The funds of the trust shall not be applied for any purpose other than the object of the trust stated in para 14 below.

14. This trust is created for carrying out the following objects in public charity within India and for the benefit of the members of the

general public without any distinction of caste, colour, breed, sex or any other natural or man made difference;-

- a) To provide general relief and for upliffment of General education, general, technical education to establish and maintain School, College, Institutions general institutions, or in their support maintain funds or for any act of medical relief and general education.
- b) To give relief to the weaker section of the society including the establishment, maintenance and support of the institution for their relief.
- c) For the advancement and propagation of education and learning including the establishment maintenance and support of collages, schools or other educational institutions, profesorships, lecturerships, scholarships and prizes or any type of professional and non professional institutions.
- d) For erecting or helping in the erection of buildings or otherwise providing housing accommodation to or for the benefit of poor persons at any place in India at cheap rates.
- c) For making available to poor persons the benefit of a sanitarium or health home or home for rest and recreation at any place in India of otherwise making available to poor persons the benefit of a change of air or rest which they are unable to secure by their own private means.
- t) To grant relief by way of giving donations, contributions, subscriptions, monetary or financial assistance or aid to the dimb, blind deaf, orphans, widows and poor or needy persons or to any organization or institutions established in respect thereof.
- g) To establish, dig. construct, start, run, maintain, and/or to provide ponds tube wells, tanks, hand pumps, pools, etc. at any place or places in India for the use and benefit of the public in general.
- h) To construct, establish, run to maintain and/or grant financial aid or assistance by way of contributions, subscriptions or donations to Dharamshalasm, Gaushalas, similar other institutions.
- i) For giving montary aid or other help for relief from natural calamities like famine floods, cyclone/tempest, earthquake or otherwise.

- To help poor society without any caste or creed, monetarily, food, clothes and general help.
- k) To provide scholarship, loans and financial help to poor and needy students.
- To construct and maintain temples, dharamshalas, poor houses, orphanages or any other type of charitable activity.
- m) And generally to do all other acts, and things as may be to the attainment and furtherance of any of all of the above objects and purposes of the trust and/or in any other way similar to them or incidental or relating thereto for the benefit of general public without any cast or creed.
- b) FOR AND GENERALITY FOR THE FULL FILLMENT OF ABOVE OBJECTIVES to acquire Govt, or semi-Govt, fand or building or to take as long term—lease. Purchase or rent any movable or immovable property from any party or take help or give help any charitable institution of the same objectives.
- The said trustees shall also be entitled to take over the management of any trust or charitable institution as well as carrying out the trust under any deed or trust or charitable purposes or under any will or testamentary writings. On such terms and conditions, it any, as may be thought fit by them in carrying out public charitable purpose the benefit whereof is not restricted to an class or community.
 - 16 The trustees bereby appointed or any of them or any future trustees or trustee will loose his membership in the case of:
 - a. Acceptance of resignation
 - b. Loosing Indian Nationality
 - c. Becoming insance
 - d. Death

17 That on the event of death of any trustee his or her one legal heair will automatically become the trustees but he will not hold post till he/she is elected by the other trustees.

18 it shall be lawful for the trustees from time to time to frame such rules and regulations for the management and administration of the charities as they shall think fit and to otter or very the same from time to time and to make new rules and regulations with the terms and conditions of these presents.


19 The affairs of the trust and the trust fund shall be under the management and control of the trustees.


20 in case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have a discretionary power the votes of the majority of the trustees for the time being voting in the matter shall prevail and be binding on the minority as well as those trustees who may not have voted, and if the trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the president.

21 The trustees shall keep or cause to be kept a minute book of their proceedings and proper books of accounts shall be audited by professional auditors.

22. The trustees shall be emitted from time to time to open and maintain a banking account or accounts in the name of trust or in the name of the trustees at such bank or banks as they may from time to time decide and may at any time pay or cause to be paid any moneys forming part of the trust fund or in the moome thereof to the credit of any such account accounts and either by way of fixed deposit or current accounts or any other account. Any such account may be operated by any two of the trustees, out of president, secretary and treasurer.

23 Subject to the other previsions of these presents the tratees shall be at liberty to keep the trust fund in any manner as:







- By way of fices deposit or current account or otherwise with any scheduled or nationalized bank or banks or in any other form permitted by the provisions of the lacome Tax Act 1961 and amended thereof from time to time.
 - II. In acquiring by purchase or on lease or otherwise any irrans vable properties of any tenure or rights in such property and in case of vacant land the trustees shall be at liberty to erect belickings thereon out of the trust fund.
 - UL in lending moneys on mortgage of any immovable property of any treure including leasehold or any interest therein is any part of India and

That the trustees shall maintain regular account books for the incomings and outgoings as per firancial year hash and will be audited regularly.

24 it shall be inwful for the trustees to pull down, renovate, rebuilt, after, adapt, improve, add it develop or repair any immovable properties comprised in the trust or the income thereof as they may think fit.

25 It shall be lawful for the rustees at such time or times as they may in their absolute discretion think fit to sell by public auction or private contract or eachange or transfer or assign or grant leases or sub-leanes for any their bowever long of or otherwise dispose-off all or any part of the trust fund including the introvable properties compromised therein and on such term and conditions relative to title or otherwise in all respects as they may think proper and to buy in, reseind or very any contact for sale, exchange, transfer, assignment, lease, or other disposition and to resell the same or enter into a fresh contract for exchange, transfer, assignment, lease or or other disposition without being answerable for any loss occasioned threeby and for such purposes to execute all necessary convergence deed of exchange, transfer, assignment, lease, sub-lease, convergence deed of exchange, transfer, assignment, lease, sub-lease, convergence and other assumance and to pass give and execute all necessary receips referees and discharges for the consideration moneys or otherwise.

27 The trustees may authorize to any one of the trustees to act in their personal name or in the name of the trust before any court or courts of law in any action, suit, proceedings, dispute, claim, demand or hearings relating to these presents pending and that the trustees or trustee so acting in their personal name, or the name of trust shall not be personally liable in any such action, suit, proceedings, dispute, claim, demand or things relating to these presents.

It is expressly declared that the Trust is irrevocable and a Public Charitable Trust and all the provisions of this deed shall be constructed accordingly.
- It is burby declared that this trust is individual Trust and it is not associated with any institutional body.
- It is also declared that at the time of execution of trust ,it does not have any mesable or immovable property except Rs.11000/-(Rs. Eleven thousand) cash only as initial fund.
