BY LAW OF THE TRUST

1. **Name of The Trust** : ASHOK KUMAR SINGH EDUCATIONAL & CHARITABLE TRUST
2. **Address (Head Office)** : Village and post Mahroopur, district-Jaunpur Pin code 222180 (UP)
3. **Area of activity** : all over India
4. **Type of membership** :
 - a. **Founder of trustee:** the member whose name have been incorporated in the trust deed.
 - b. **Life Trustee:** the members who are blood relation of the founder trustee who have been admitted for life jointly by the president and the secretary/manager after the incorporation of the trust with voting right.
 - c. **Ordinary members:** the members who have been admitted by the president/secretary on the recommendation of the founder trustees (and in their absence by life trustee) for the benefit of the trust, but who will have no voting rights, and whose appointment shall be valid for 5 years only. Their membership may be renewed on recommendation of secretary.
5. **Number of trustees** : maximum 7 (seven)
: minimum 2 (two)
6. **Number of ordinary members** : maximum- no limit
: minimum- Zero
7. **Eligibility of the trustee/members**
No person being-
 - a. An undercharged insolvent; or.
 - b. Convicted for offence involving moral turpitude; or
 - c. Of unsound mind; or.

8. Ceasing of trusteeship/membership:

A person shall, cease to be a member in any following events

- If he/she dies; or
- If he /she becomes bankrupt; or
- If he /she become in same or otherwise in capable to act; or.
- If he/she Resigned his office and the resignation is accepted by the secretary.

9. Managing committee:

Founder, trustees will form the managing committee and the office bearer of the trust shall be office bear of the managing committee. The following trustees shall be the first committee member.

- Ashok kumar Singh, village and post Maharoopur Jaunpur (UP) (vice president)

- Manoj kumar Gautam, 25 M near line bazar police station matapur Jaunpur UP (member)
- Devansh Singh, village and post Maharoopur Jaunpur (UP) (member)
- Smt. Priya Singh, S-1 / 306 sarswati sector D-6, vasant kunj, New Delhi- 110070 (member)

10. Meeting:

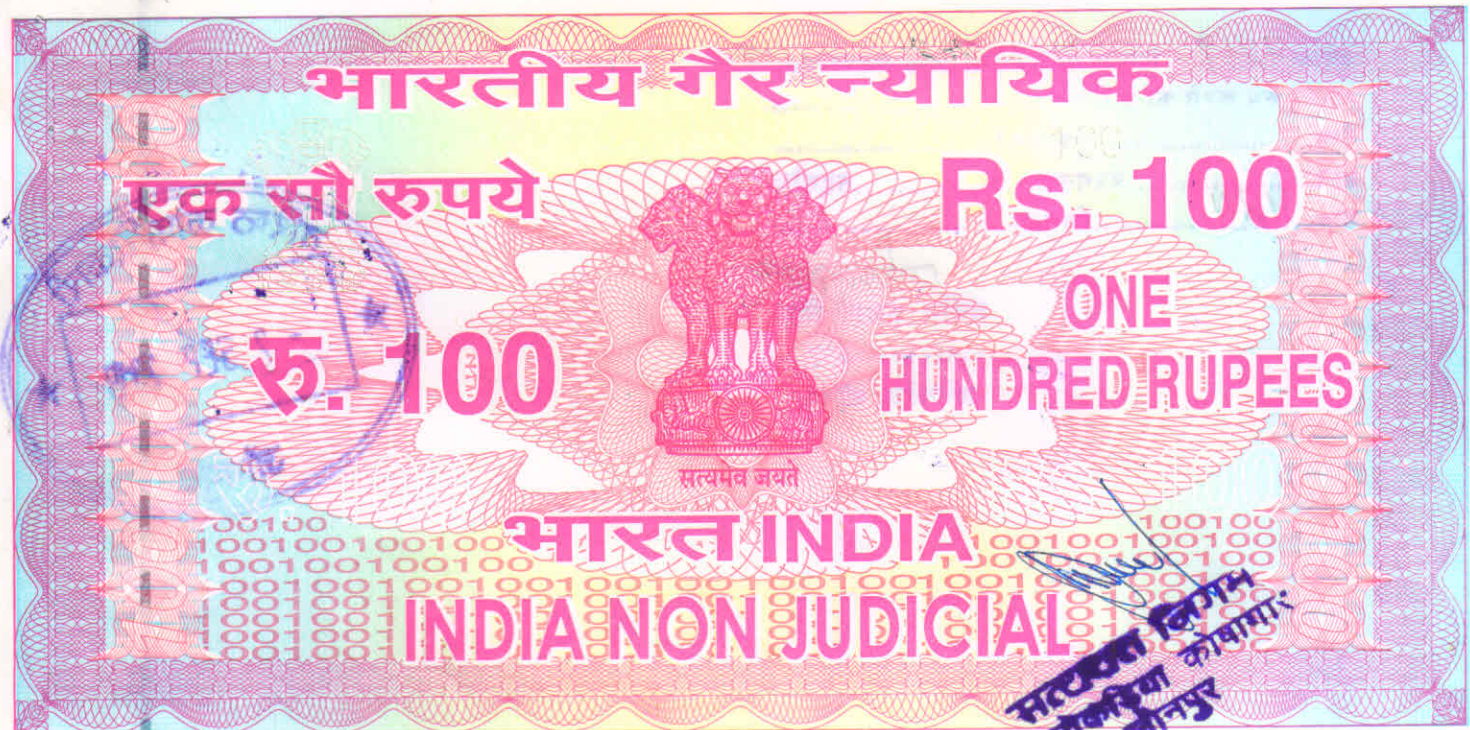
General meeting of the managing -committee shall be held at least once a year. However with the consent of the president /secretary, meeting can be called upon at any time by the secretary/ manager.

11. Periods of Notice:

The notice period shall be pf minimum seven days; however, it can be reduced on the event of any emergency, with the consent of the president

12. Quorum

Presence of 1/3 of the managing committee shall be Quorum. In case the present members are less than 1/3 the meeting shall be adjourned for one hour, after which it can be held on the same place for which no Quorum shall be required

13. duties and right of the managing committee

- a. modification of the constitution of the Trust by 2/3 majority.
- b. To take decision in respect of opening of hospitals, schools, graduate and post graduates colleges, engineering/ management/ law/ teacher education colleges, pharmacy college etc.
- c. managing community shall have right to, forms sub communities as needed for any purpose in which all the office member of the managing committee shall be the member of such committee.
- d. for running any education institutions stabilized by the trust, where it s required to form a separate management community, the president and secretary (manager) of the trust shall be the president and secretary of the community of the institution respectively.
- e. in case of death of founder trustees the remaining founder trustees with consents of secretary will nominate the founder trustees form his family.

14. power and duties of the office bearers of the committee of management: President

- a. the president will hold office for life founder trustees Shree Raghvendra Prasad Singh will be the president.

15. Right and duties of president:

- a. the president shall preside over the meeting of managing committee.
- b. If the managing committee/board of the trust or the institutions run by the trust is divided equally in any resolution in the meeting or on any decision the president is entitled to the casting vote.

2. Vice-President:

- a. in the absence of president, he/she will act as president.
- b. to exercise and perform all such powers and duty as may be delegated to him by the president in writing for a specific period.

3. Secretary (Manager):

- a. the secretary will hold office for life. Founder trustee Shree Harsh Pratap Singh shall be secretary, after that the office of the secretary shall be assumed by the son of the secretary.
- b. in case the son is minor, then his legal guardian shall be in charge of the secretary till the attainment of the age of majority of the eldest son after him. the said office shall devolve/ upon his wife after her upon his sun failing thereof may next male line of succession failing thereof such succession, or any person nominate by him by deed, will or otherwise.

4. Rights and duties of the secretary:

- a. shall operate and executer all working the Trust. He will be principal officer of the trust.
- b. shall keep and maintain minute-books of the meeting and maintain members register of the trust.
- c. the manager will conveys the meeting of the board on his own motion or at the requisition of the president. In the absence of president, secretary preside the meeting.
- d. all the funds of the trust and other institution governed by the trust shall be operated by the secretary.
- e. All deposit and accounts example - saving account, fixed deposit, cash certificate and other investment of all kinds will stand in the name of secretary.
- f. to watch over the finances of the trust and institutions run by the trust and exercise the general control over the executive administration of the trust and institutions.
- g. to conduct correspondence on behalf of the management committee.
- h. all the documents and records of the trust or institutions managed by the trust i.e. membership registered, notice register, proceeding register, stock register, cash book its salary kept by the secretary.
- i. the committee of the management shall appoint an auditor at the end of the financial year to audit the account of the trust and institutions.

j. the secretary shall have the power to institute to conduct- defend, compromise, referred to arbitration are legal proceeding and claims by or against the trust, institutions, or the managing committee.

k. any amendments alteration or addition to the rules and regulations for the benefit of the trust or running institutions by the trust shall be made by majority of 2/3 member of total strength of trustee.

l. secretary with in consultancy with managing committee can frame any new rule for the benefit of the trust or abolish any rule which against the trust by secretary.

m. to purchase or sale any property of trust or mortgage or lease will be done by secretary.

5. Deputy Secretary:

In the absence of secretary, He/ She will act as secretary.

6. the managing committee member will not be entitled to receive any remuneration but the managing committee may reimburse themselves all expense actually incurred by them, in connection with the trust or their duties relating there to.

7. The number of member of the managing committee shall not less than two and more than seven, if the numbers of the members shall fell below two, the trustee shall not, except for the purpose of filling any vacancy, act so long the numbers below the said minimum.

8. every trustee will be at liberty to resign and giving one month notice of his/her intentions of doing so.

9. the managing committee shall form time to time frames rules for the conduct and regulation of the meeting of the trustees in the absence of the such regulation.

a. all members will be decided mutually by the managing committee, resolution pass without any meeting of the managing committee, but by circulation thereof and the evidence in writing under the hand of 1/3 of the trustee including the president shall be as valid and effectual as a resolution duly passed at a meeting of managing committee.

10. the accounting year of the trust shall be the financial year ending 31 march every year.

11. the trust and the trust funds shall be irrevocable for all times.

12. the head office of the trust shall be situated at village and post mahroopur, dist-jaunpur pin code number 222180 (UP) unless changed by the founder trustee by a 2/3rd majority.

13. the objects and/by-laws of the trust can be altered or modified or changed within the charitable purpose 2/3rd majority of the trustees in general meeting.

14. It is explicitly declared that no [part of trust property or its income or any accretion thereto shall be applied for any purpose outside India or the benefits of any trustee members or for any purpose which is not charitable purpose which is not charitable purpose in law, and all provisions thereof shall be construed accordingly.

15. In case of dispute, the place of jurisdiction will be Jaunpur, U.P. (INDIA) in witness whereof the parties have here unto seen and subscribe their respective hand on the day, month and first mention here in above.

W.r.t the trust deed registration on 30 oct 2018 (as bahi No 4 jild No 139 serial No. 263) following points are added in in the original deed as fallows-

1. Irrecoverability clause

The trust hereby formed shall be irrecoverable

2. Beneficiary clause-

The benefit of the trust are open to all citizens of India irrespective of caste, creed, race, colour, religions, sex, etc

3. Dissolution clause-

On dissolution of the trust the net asset of the trust shall be transferred to an association of persons or trust or society having similar objects of the trust.

4. Utilization clause-

That the trust funds or trust income can be utilized to any one or more of the objects of the trust.
