- i) To renovate or repair any temple, mosque, gurudwara, church or other places notified by the Central Government in official gazette to be of historic archaeological or artistic importance or to be a place of public worship.
- j) To help the preservation of cattles and animals.
- k) To publish books, pamphlets, periodicals and news papers in India or at side for the spread and advancement of education and culture.

4. That if any one or more of the objects described in clause (3) herebefore and held not to be objects of the public charitable nature, the same may not be carried out by the trustees as if the same is not incorporated in this deed. However, the validity of the trust created for public charitable purposes shall not be affect in any manner.
5. That the trustees may accept any donation or contribution in cash or cheque or in kind of any person, firms, company, corporation, association or trust for the furtherance of the objects of the trust upon such terms and conditions as they may think fit and consistent with the objects of the trust the trustees

6. That the trustees shall from time to time after meeting the expenses of and incidental to the management of the trust properties and of the trust of the trust decide the particular object or objects for which the income or corpus of trust fund shall be utilised and applied.
7. That the Trustees shall maintain and accurate accounts of the money received and spent and for all matters in respect thereof the course of management of the trust properties or in relation to the carrying out of the objects and purposes of the trust as well as of all the assets, credits and effects of the trust properties and shall keep on account records with any nationalized bank or banks, operated by the trustee jointly.
8. That if the income of form the trust property in a particular year is not fully utilised, the unexpended income shall be carried over to the next year subject to the provisions of Income Tax Act applicable to the trust and spent in such subsequent year for the advancement of the trust.
