7. That Shri Hari Shanker Gangwar shall be lifelong patron of the Trust.



Rules for the Management of Sadar Ballabh Bhai Patel Degree College

The Sardar Ballabh Bhai Patel Degree College will be establish and run by the Sardar Ballabh Bhai Patel Educational Trust duly registered under Act 10 of 1908 and where the framing of the rules for the management of the said College and it's funds in conformity with the provisions of the U.P. State University Act and Statute of M.J.P. Rohilkhand is necessary and are framed accordingly.

POWERS AND FUNCTIONS OF THE MANAGING COMMITTEE

Subject to the supervision, control of the Trust there shall be a Managing Committee for managing the College and it's affairs as herein provided. The Managing Committee shall be the Management of the said College as defined in U.P. State universities Act and shall exercise all powers and functions as are provided to be exercised and performed by the management as per U.P. State Universities Act and Statute of the M.J.P. Rohilkhand University.

That subject to the provision of preceeding rule, the Managing Committee shall perform the following functions and exercise the following powers with regard to the College:

- (i) To administer the funds of the College with regard to budget and the money available and to carry out the policy laid down by the trust in accordance the regulations of the University.
- (ii) To invest after meeting out all legitimate charges, all surplus money that can be so disposed of in the bank or Banks or in any Government Securities as approved by the managing Committee.

- (iii) To submit to the Trust at its Annual meeting or earlier if so directed by the Trust the reports and accounts.
- (iv) To appoint, suspend and dismiss, terminate, remove or punish the Principal of the College in accordance with the provisions of U.P.
- (v) To appoint, suspend and dismiss, terminate, remove or punish the Principal of the College in accordance with the provisions of U.P. Higher Education Service Commission Act, Statutes of MJP Rohilkhand and UP State Universities Act 1973 or any other law hereinafter applicable.
- (vi) To decide in regard to the appointment suspension, dismissal of the teaching and ministerial staff as per provision of the Status of Rohilkhand University and Acts as applicable.
- (vii) To arrange for the Annual Audit of accounts.
- (viii) To make recommendations to the Trust.
- (ix) To administer the property of the College on behalf of Trust.
- (x) The Secretary of the Managing Committee shall represent the Managing Committee in all suits or legal proceedings by or against the College or the institution and to take all steps for effective prosecution or defense of the suits or other legal proceedings. However it is clarified that the direction of the Trust shall be binding in the Secretary in this regard.
- (xi) To constitute the following Committees besides other committees and such other Sub-Committees as considered necessary from time to time subject to the provisions of the U.P. State University Act and Statutes esp. the Finance Committee.

Constitution

- (a) SSAll the Trustees of the Trust or their respective representative.
 Note: However the representative under clauses (a) may be recalled by the Trustee who had nominated them as representative at any time and replace the same by another person. Subject to the provisions of the previous Rules no two members of the Management shall be related to each other within the meaning of Explanation to Section 20 of the State Universities Act.
- (b) Principal of the College.
- (c) 25% of the members of the management shall be the teachers of the College including the Principal.
 Note: The teachers excluding the Principal referred to in the preceding clause shall be the members in the Managing Committee for a period of One year by rotation in order of Seniority.
- (d) One representative of non-teaching staff of class III to be nominated on the basis of seniority for one year by rotation in order of Seniority.

No change in the constitution of the managing committee which is inconsistent with the provisions of the U.P. State Universities Act and Statutes of the MJP Rohilkhand or relative Education governing bodies shall be made.

1. If any question arises whether any person has been duly chosen or as is entitled to be a member or office bearer of the Managing Committee or whether the Managing Committee is legally constituted the decision of the Vice- Chancellor shall be final.

That the College is prepared to place before any person or person authorized by the Vice-Chancellor or before the panel of inspections appointed by the Vice-Chancellor original documents pertaining to income and expenditure of the College including the accounts of the Trust.

1. That the income from endowment funds referred to in the Statute 11.6 of the MJP Rohilkhand University shall be available for the maintenance of the College.
2. That there shall be a separate endowment fund of the College which shall be placed with the Registrar of the Rohilkhand University and which shall not be alienated so long as the College continues to exist.
3. That the President and Secretary of the trust or user nominee shall respectively be the President and Secretary the Managing Committee for a period of three years co terminus the tenure of the President and the Secretary respectively who have nominated them.
4. The terms of the Managing Committee shall be three years from the date of the constitution. In the event of a vacancy occurring due to any clause i.e. due to the death or caesura of the membership, the vacancy shall be supplied by for the remainder of the term in the same manner as the fresh appointment.
5. The meeting of the Managing Committee shall be called ordinarily one a year to pass account sand to consider the budget.

6. The Secretary on the directive of the President shall call such a meeting if a written demand is presented to him by not less than three members of the Managing Committee stating the business to be disposed off.
7. The notice of not less than Seven days for the ordinary meeting and not less than two days for an extra-ordinary meeting shall be given by the Secretary. Such notice shall contain a brief statement of business to come before the meeting. Notice for the meeting shall be served personally or by registered post or by Certificate of posting.
8. Quorum of the meeting of the Managing Committee shall be majority of its total strength.
9. That the President shall preside at the meeting of the Management Committee. In absence of the President the member present shall elect the Chairman for the meeting. Such Chairman shall preside only over the concerned meeting of the Managing Committee. This Chairman shall be selected by the Trustee from amongst members of the Management Committee.
