



This Deed of trust is made on this first day of April Two Thousand Six between.

Shri Attar Singh S/o Late Shri Chhotey Singh, residing at Village Rooppur, Post – Chandpur, Tehsil – Chandpur, District – Bijnor (U.P.) here-in-after referred to as the Founder, of the one part.

and

1. Shri Balram Singh S/o Shri Murli Singh, residing at Mohalla – Chaudhariyan, Sherkot, District – Bijnor (U.P.)
2. Shri Aashish Kumar Singh S/o Shri Hari Raj Singh, Residing at Near Polytechnique College, Bijnor (U.P.), and
3. Smt. (Dr.) Shikha Singh W/o Shri Dr. Navendra Pratap Singh, residing at Opp. Old Telephone Exchange, Kalagarh Road, Dhampur – Bijnor (U.P.), here-in-after jointly referred to as the trustees

Which expression shall include the survivor or survivors of them and the executors or administrators of the last survivor or the trustee or trustees for the time being of the trust of the other part.

WHEREAS the Founder is desirous of endowing a sum of Rs. 25,000/= (Rs. Twenty five thousand only) for the purposes of affording medical relief, advancement of education and for all other public charitable objects of general public utility as defined and recognized by provisions of Income Tax Act, 1961.

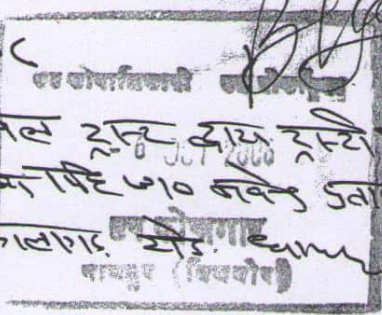
AND WHEREAS, the Trustees, at the request of founder, have agreed to carry out the trust herein created.

- 2, The objects of the trust are -
- to establish, equip, run, maintain and support hospitals, blood banks, medical colleges, paramedical institutions, child welfare centers, and / or such other similar charitable institutions for the benefit and use of general public.
 - to establish, equip, run, maintain and support schools, colleges, libraries, laboratories and other institutes of the like nature for the advancement of general public.
 - to establish, equip, run maintain and support boarding houses for the student and staff of these institutions.
 - to establish, equip, run, maintain and support homes for old aged, orphanages or other establishments for the relief and help to poor, needy and destitute people, orphans, widows and aged persons.
 - to provide relief to the poor and the needy persons and to do all such acts which are charitable in nature and for general public utility.
 - to do all other acts and things as may be necessary or conducive to the attainment of the objects of the trust.
3. The trustees shall have full power and absolute authority to add to and introduce other specific public objects which according to the advancement of time and circumstances may exist from time to time and deem

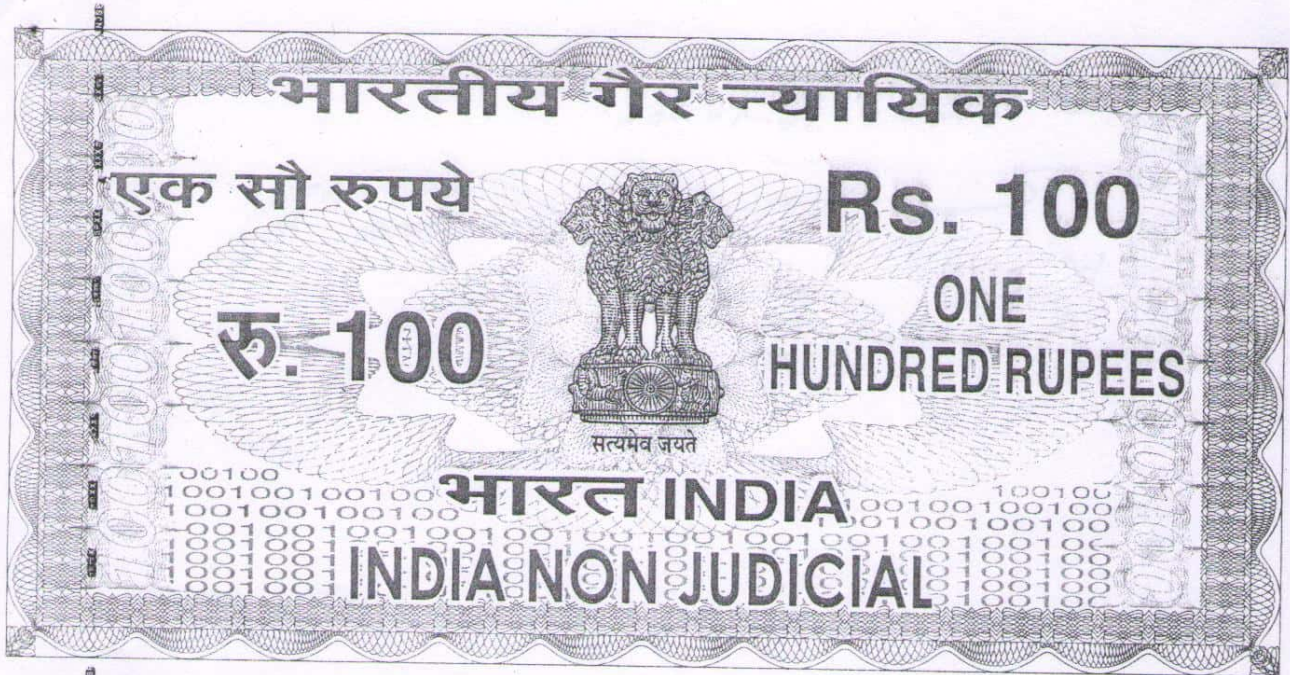

desirable. Such newly added objects will not be inconsistent with the original objects as provided in clause(2) above and shall be deemed to have been incorporated in the original objects of the trust.

4. Declaration of the trust :- The founder being the absolute owner, conveys the sum of Rs. 25,000/= (Rs. Twenty Five Thousand Only) in cash to the trustees to hold the same upon trust and use the same for purposes of the trust, under and subject to the powers and provisions here-in-contained.
5. Powers and duties of the trustees :
 - (a) The trustees shall employ such staff, including qualified medical practitioners, nurses, para medical staff, teachers and others on such remuneration as they consider appropriate to run the hospitals, blood banks, schools and / or for fulfillment of other objects of the trust.
 - (d) The trustees may spend or donate the income of the said trust as found as also the whole of the corpus of the trust fund or any portion or portions of the corpus of trust fund as they mentioned in clause (2) thereof including such other objects which may here after be added thereto under the provisions of clause (3) above, provided always that the trustees in administering any charity here under or in spending such sum or sums as aforesaid shall do so in the name of the trust.
 - (c) The trustees may accept donations to the trust from well wishers, either in cash or in kind including equipments, furniture, appliances etc., so however that these are added to the trust fund and used for the purposes of the trust.

- (d) The trustees shall have the powers to borrow money on security of the trust property and to alienate any part of the trust property for necessary purposes.
 - (e) The trustees may invest the surplus trust funds in such securities / investments as they deem fit.
 - (f) It shall be lawful for the trustees to frame rules, regulations etc for administration hereby established and for the regulation and conduct of meetings and proceedings of the trustees and to alter, vary, modify or repeal such rules and regulations from to time, if necessary.
 - (g) To open account in the name of the Trust or Institutions run by the trust with a bank or banks to operate such accounts and to instruct the banks for operations of such accounts by one or more of the Trustees.
6. The founder shall also be one of the trustees during his life time and thereafter the male member of his family shall be a co-trustee.
 7. The trustee, Dr. (Mrs.) Shikha Singh shall be the Managing Trustee with all the powers and authorities of the trustee to hold and manage the trust property during his life time. Thereafter, any other member in her family who may be fit to act as such trustee will be the Managing Trustee with the consent of all other trustees.
 - 8., In case of there arising any difference of opinion among the trustees in respect of any matter relating to the trust, the view of the majority of trustees shall be binding and be effectual and be carried out.

9. The number of trustees shall at no time be less than three and more than seven.
10. The managing trustee shall have the powers to appoint four co-opted trustees to look after the affairs of the trust for such period as he deems fit. Such co-opted trustee or trustees shall work in consultation with the trustees of the trust.
11. If for any reason a trustee resigns his position as trustee or becomes bankrupt or is declared insolvent or is incapacitated or leaves India for a period exceeding three months the remaining trustees shall be competent to co-opt a person or persons who is imbued with the spirit of service or is otherwise considered likely to discharge conscientiously, his obligation under the trust.
12. No part of the trust fund, either the corpus or the income there from, shall be utilized for any object other than that of the trust hereby created.
13. The Trustees shall always maintain proper accounts of the Trust, duly audited by a chartered Accountant. The Accounting Year of the trust shall be ending on 31st March every year.
14. The trustees shall in no case be liable personally for any expenditure of the trust or loss to the trust estate, unless the trustees are guilty of fraud.
15. This is a registered public charitable trust. The property of the trust shall in no case revert to the founder or his descendents or to any other person.






16. In case of failure of the trust for any reason, the trustees shall move the court for applying the remaining trust fund for similar objects anywhere in India.
