SCHEME

Scheme for the administration of the property of the Murlidhar Gajenand Educational Trust, Hathras, under Section 4, Charitable Endowments Act, vested in the Treasurer Charitable Endowments U.P.

III. Funds (i) The Managing Committee including co-opted members thereof shall receive the assets of the Murlidhar Gajansad Educational Trust, detailed in Annexure I, free from all encumbrances.

(ii) The Managing Committee including co-opted members thereof may receive gifts and charities for the purpose aforesaid from persons interested in the cause of education.

(iii) The Managing Committee including co-opted members thereof may receive ^{such} outright grant, grant-in-aid, loan or such other sums as may be sanctioned by the State Government or the Government of India from time to time for the purpose aforesaid and on such terms and conditions as may be prescribed by the Government concerned.

IV. Expenditure (i) The Managing Committee including co-opted members thereof shall operate on the funds of the Institution on the schemes for Technical training within the purpose aforesaid.

(ii) The Managing Committee including co-opted members thereof may delegate such general or specific powers for the management of the school to the Secretary as may be expedient from time to time.

V. Name of the Institution. Murlidhar Gajansad Technical Institution.

VI. Meeting (a) The Managing Committee including coopted members thereof shall meet atleast once in every quarter and shall decide all matters connected with the Institution including acquisition of land, construction & equipment of buildings, entertainment of staff, pay and leave rules etc., admission of students, arrangement of courses, tuition fees and all incidental matters within the purpose as specified in clause I above and subject to the terms and conditions laid down by the Government concerned under clause III (iii).

(b) The Managing Committee including coopted members thereof may meet at such place and date or time as may be fixed by the Chairman of the Managing Committee.

(c) The Managing Committee including coopted members thereof shall arrange for the preparation and audit of annual accounts of the Institution in such manner as the Treasurer Charitable Endowments U.P., may prescribe. The marble statue and tablet to be donated by Sri Gajananand Chaudhry, President, the Murlidhar Gajananand Educational Trust, Hathras, shall be placed on the right side of the main entrance hall and also two photos of himself and of his late father to be donated by him to be kept in the main hall commemorating the donation by the said trust.


