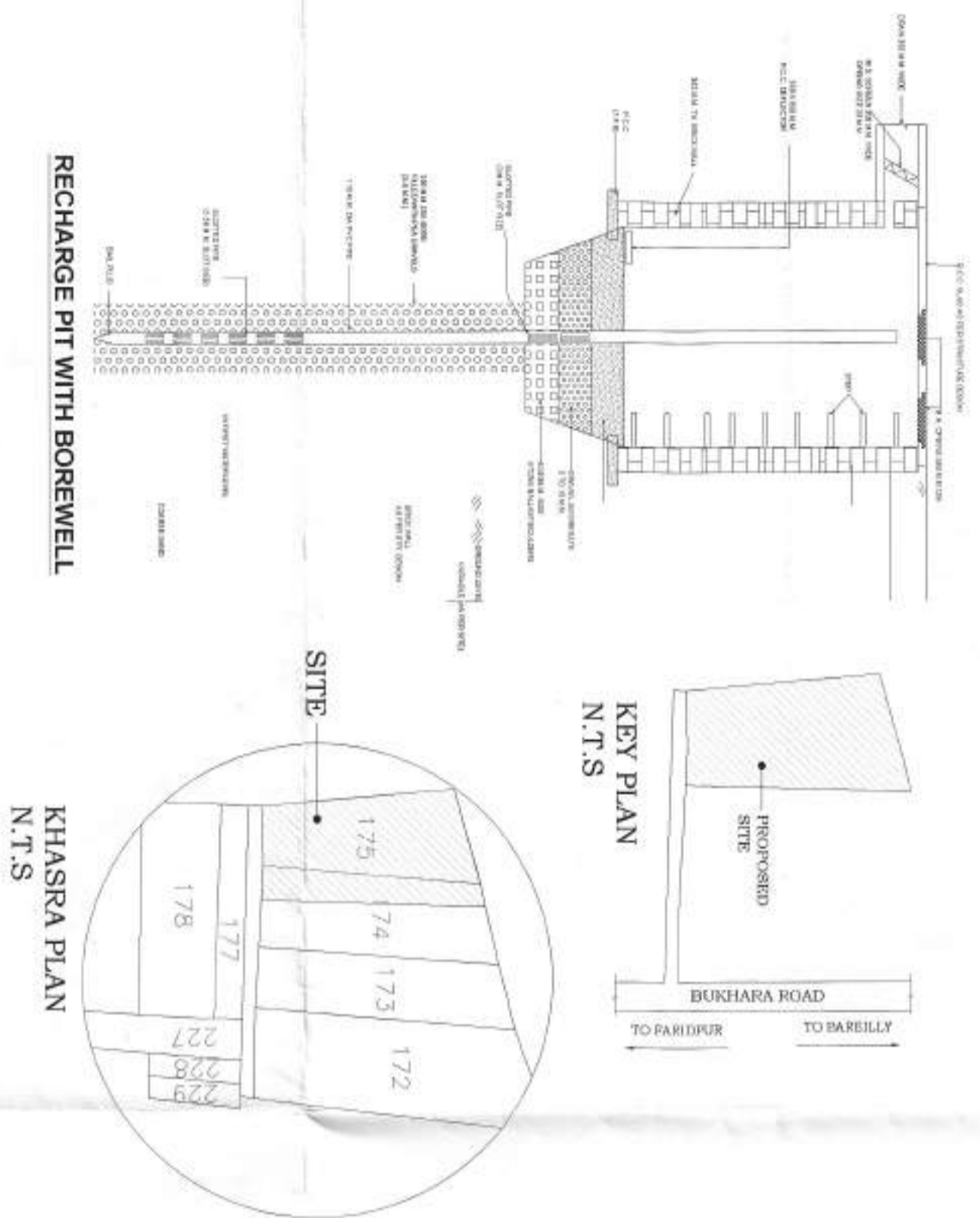

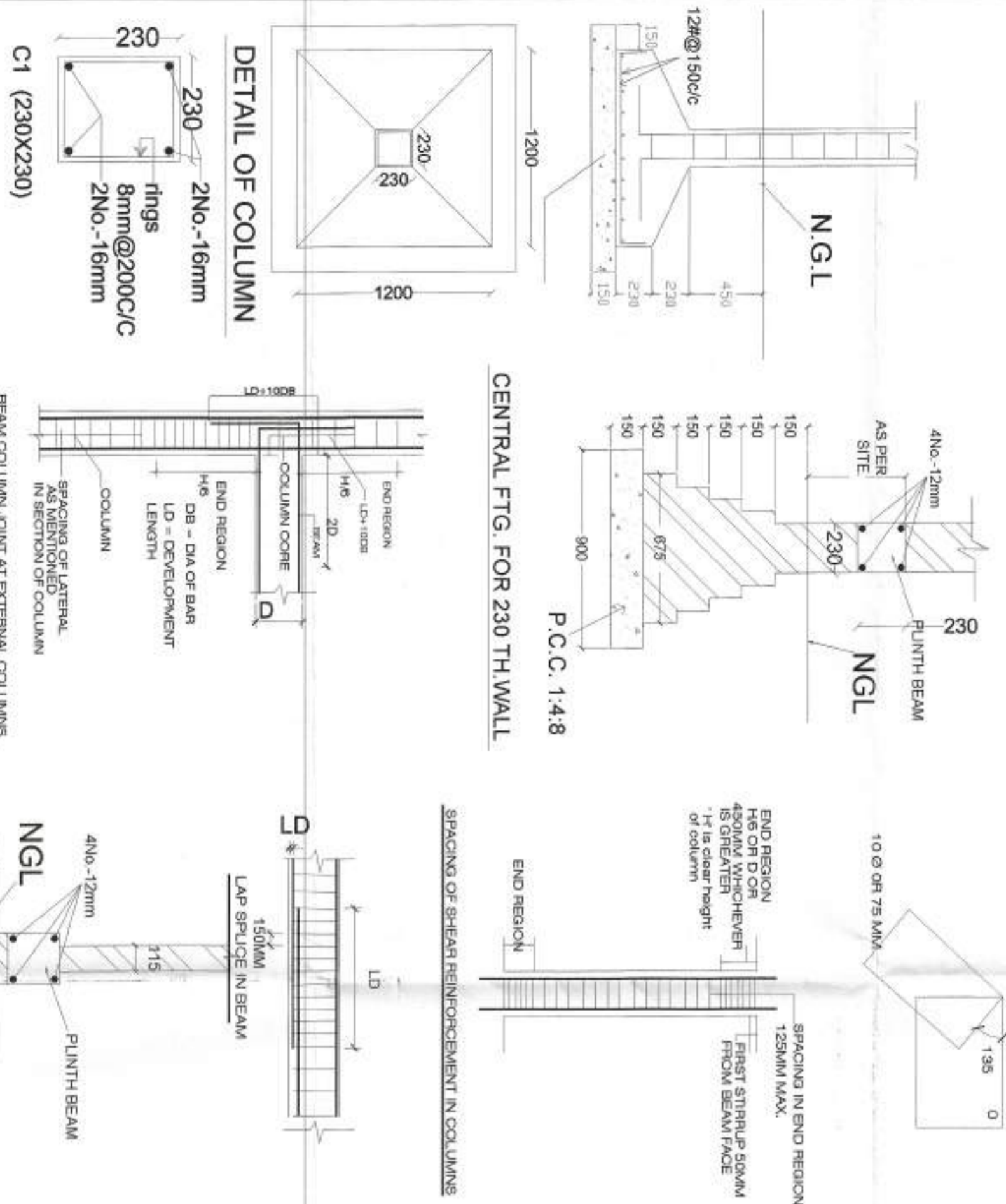


**RECHARGE STRUCTURE PROPOSED**

RAIN WATER FROM THE ROOF WILL BE DRAWN THROUGH VERTICAL RAIN WATER PIPES AND DISCHARGE THROUGH EXTERNAL STORM WATER DRAIN TO THE PROPOSED RECHARGE PIT / CHAMBER FOR RAIN WATER HARVESTING / RECHARGING. THE RE-CHARGE CHAMBER SHALL HAVE BORING OF 300 MM DIA. FILLED WITH GRAVELS AND A DEPTH UP TO 20 MM. BELOW GROUND LEVEL. THE ABOVE BORING WILL HAVE HOUSING PIPE OF 100 MM DIA WITH FILTER AT REGULAR INTERVAL. TO RECHARGE THE RAIN WATER IN TO THE SUB SURFACE AQUIFERS. FILTER MEDIA AS / REQUIREMENTS IS PROVIDE TO ENABLE THE FILTERED WATER DISCHARGES INTO THE AQUIFERS. THE ABOVE RE - CHARGE CHAMBERS WILL HAVE A PRE - CAST REMOVABLE COVERS FOR MAINTENANCE PURPOSE.

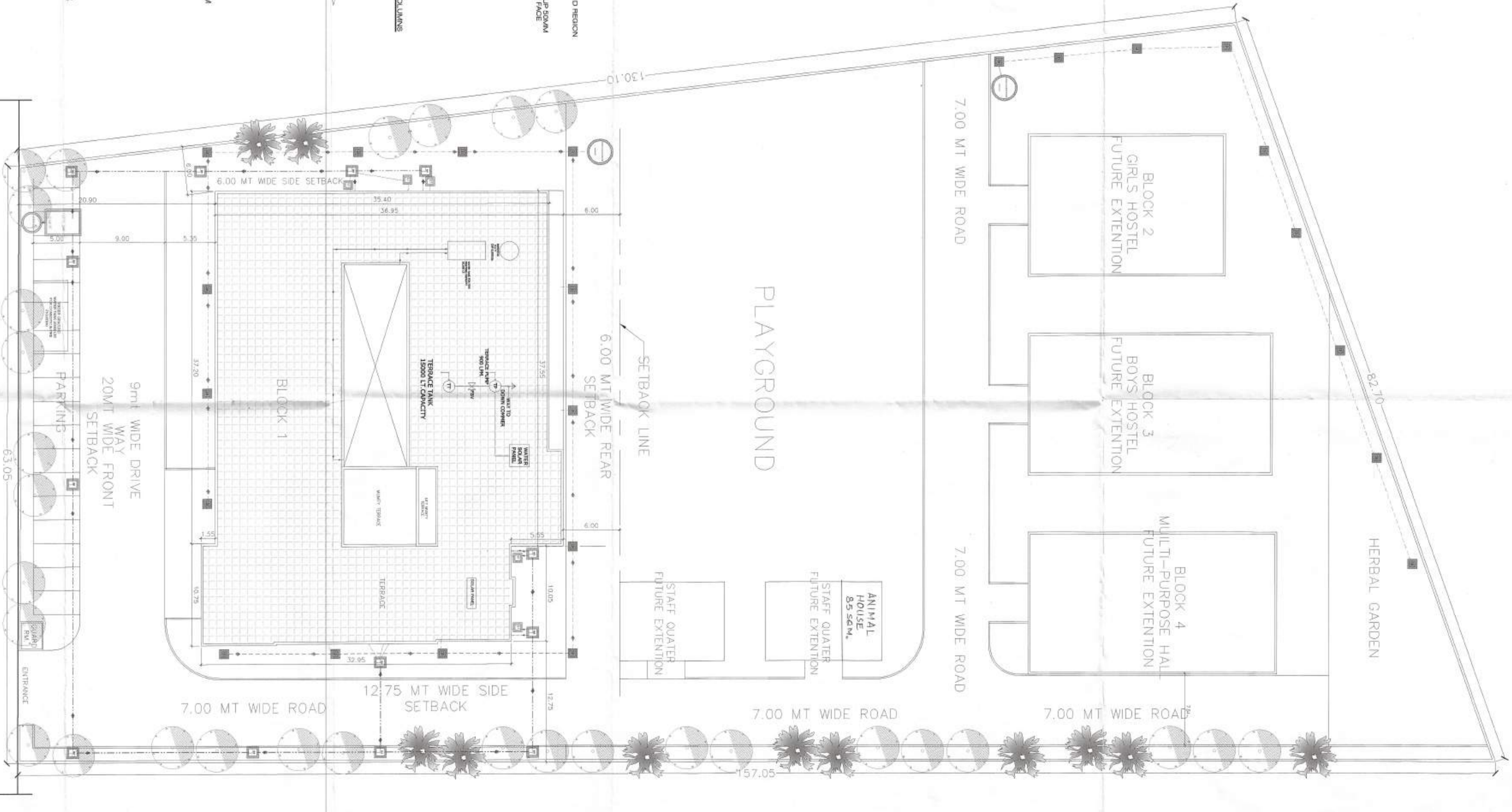

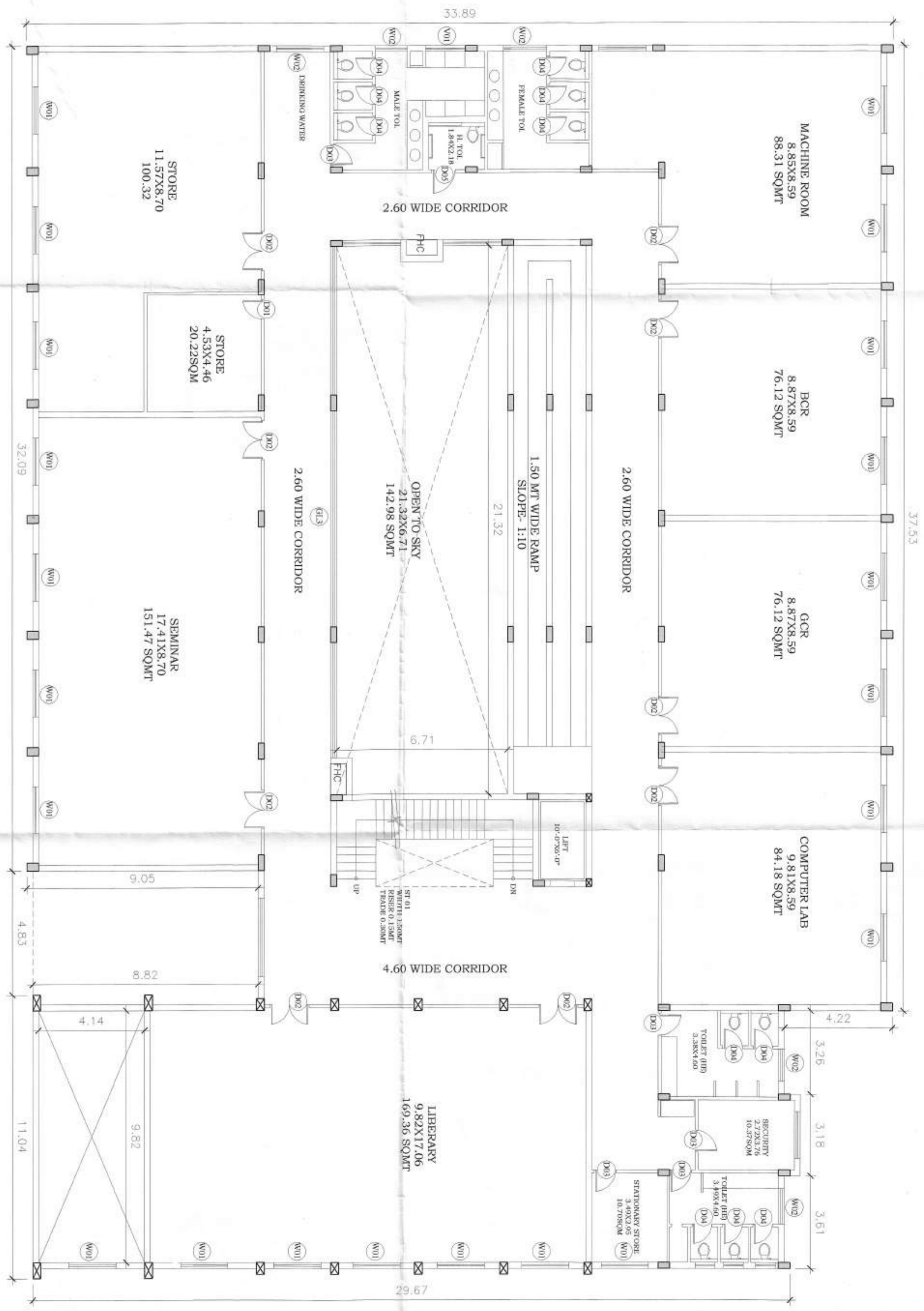

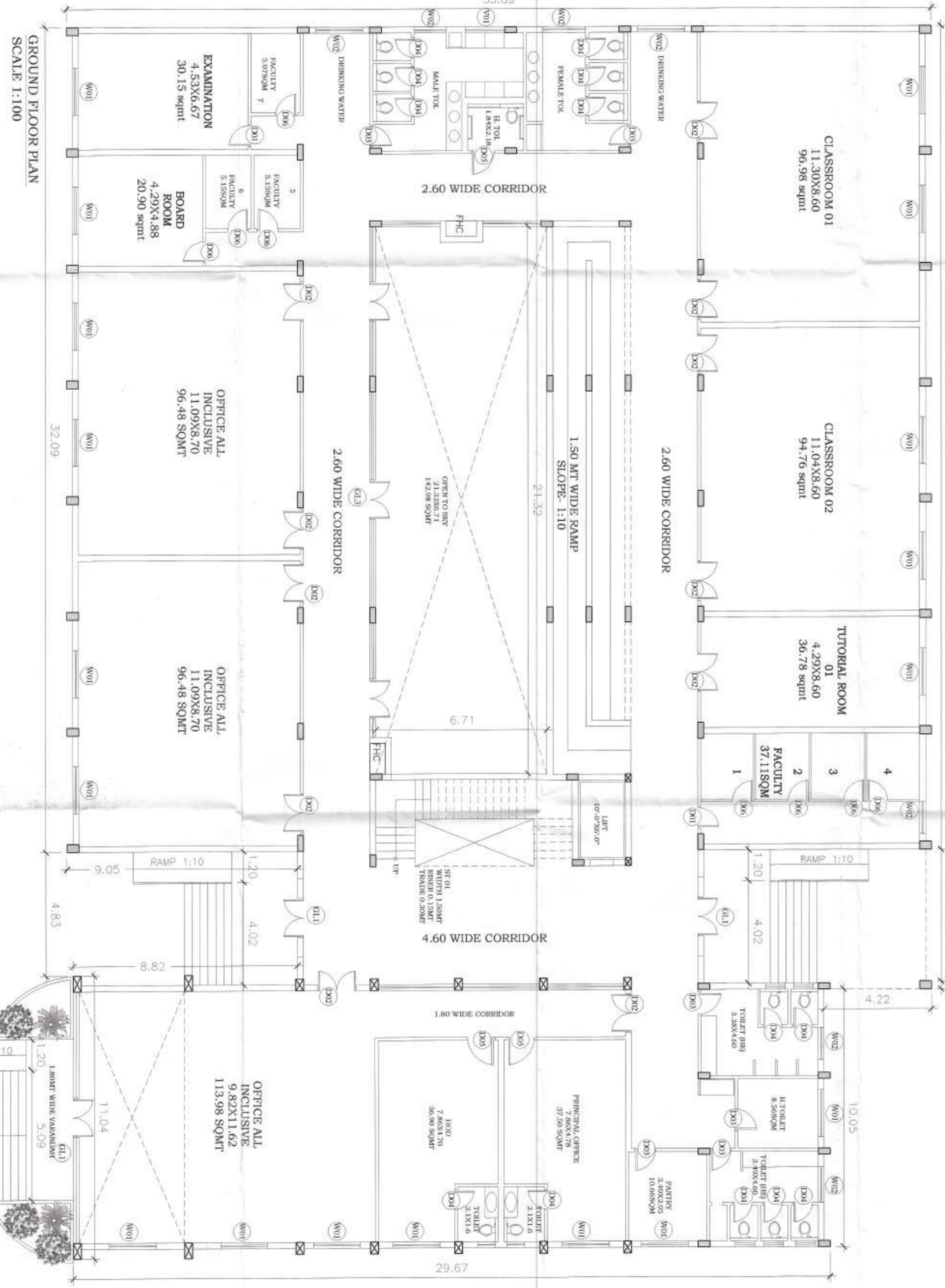




FIRST FLOOR PLAN

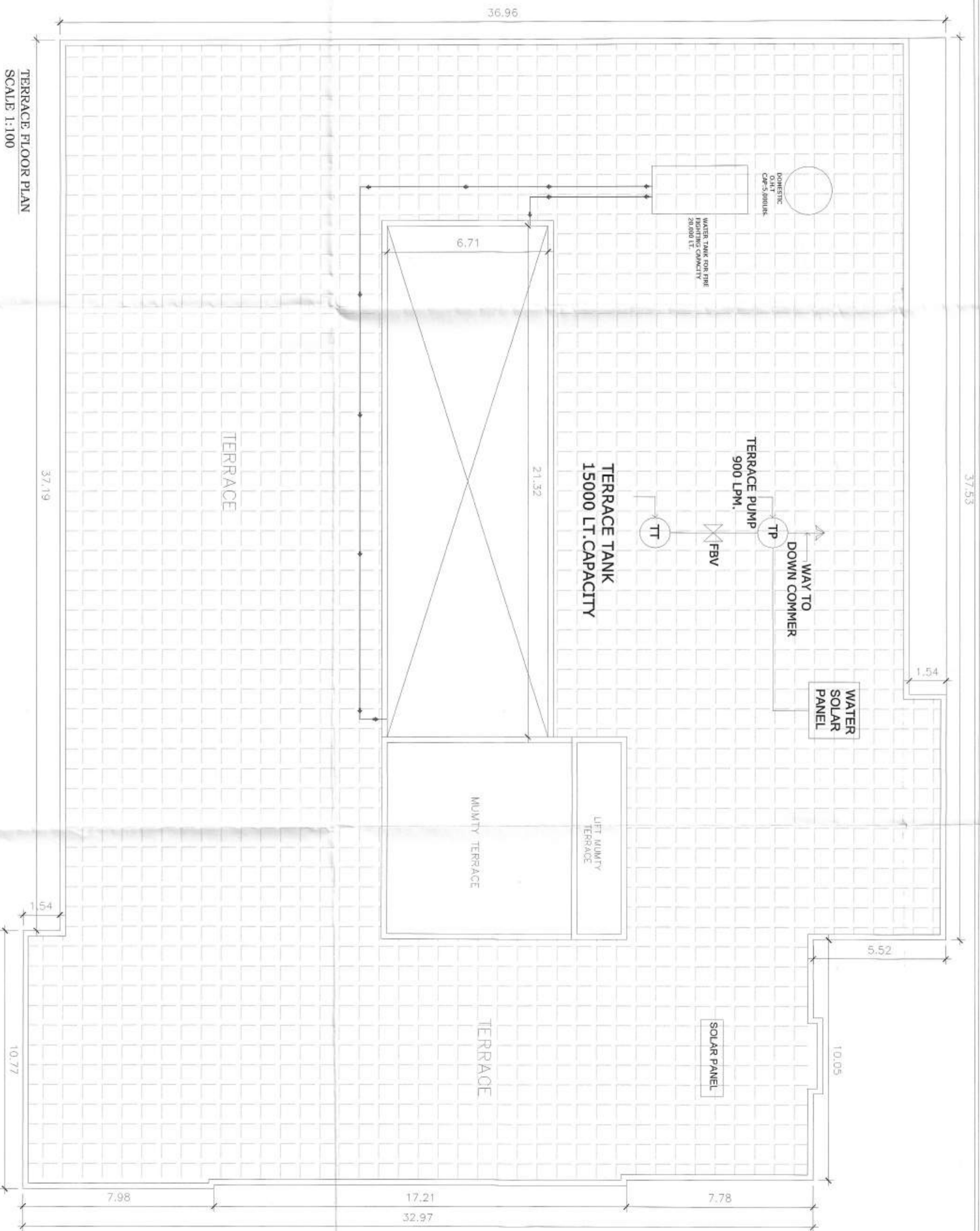

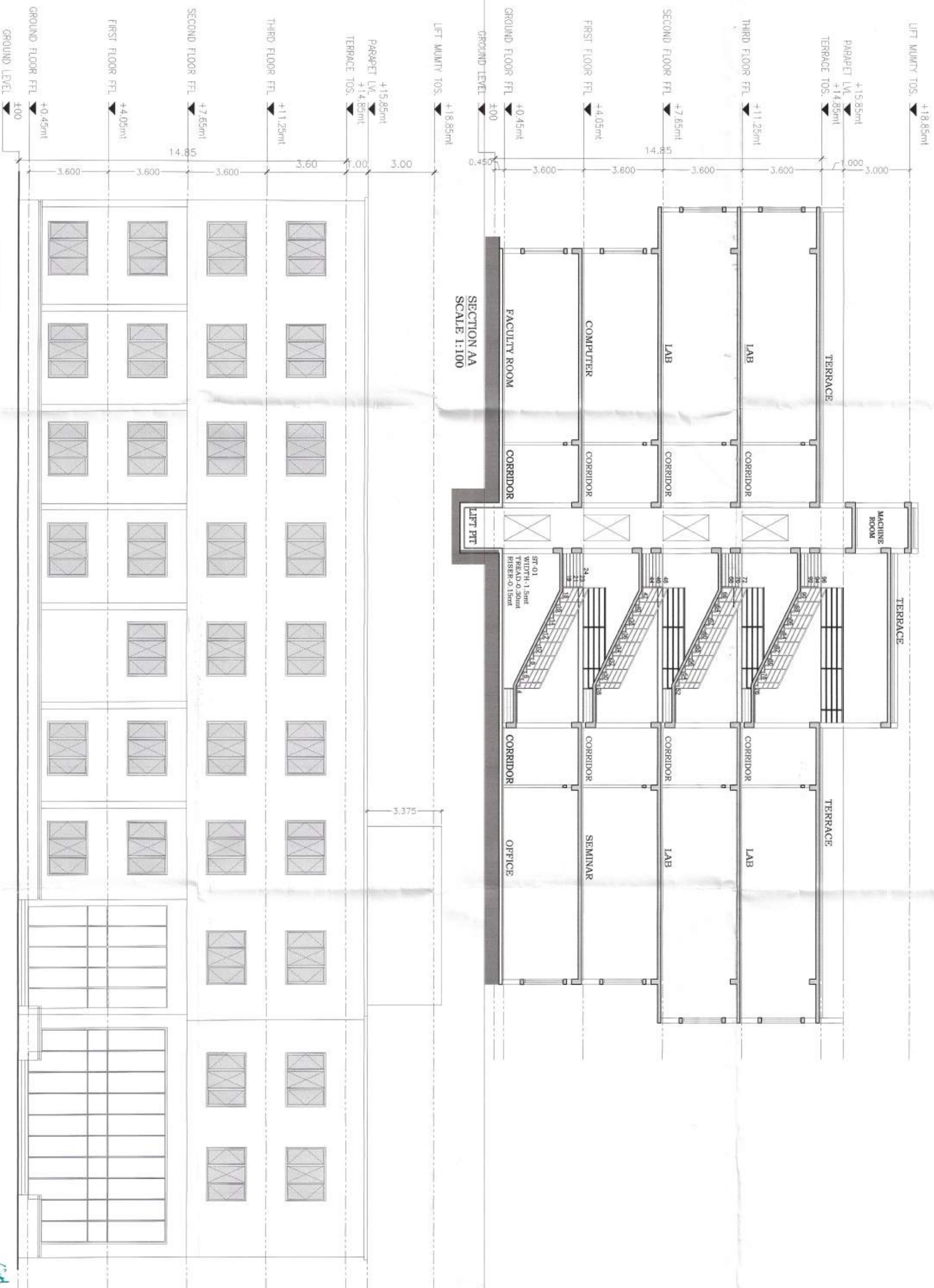

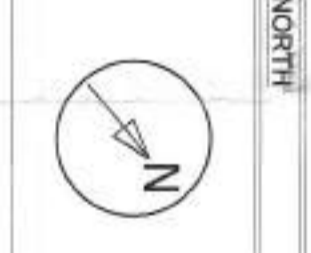
