- (vii) Water resources management - Trust being the prime need for human being trust will undertake every possible management to protect ground water and maintain water level for that purpose digging of wells, ponds and installation of handpumps etc.
- (viii) Medical management - Trust will work in field of health and family welfare everything possible starting from providing and medical aid to poor and needy persons upto establishment of hospitals and medical colleges if possible.
- (ix) Trust will take any other activity which are incidental and ancillary to the objectives mentioned above. As Board of trustees may decide from time to time.
- (x) Trust will undertake any research project on behalf of central/state govt. N.G.O's. Private organisations.

- (iv) In the event of the death or resignation of any of the trustee, the remaining trustee shall have power to admit and other person or persons in the place of the trustee dead or resigned. This person or persons nominated in the place of the former trustee of the purpose and objects of the Trust.
- (v) The no. of trustee of the said trust shall not be more than eleven but not less than seven. The trustee who is trustee in a permanent shall be the managing trustee and at all continue for his life time.

6. The Meetings :

The Board of Trustees shall meet periodically for transacting the business of the Trust. An extraordinary meeting shall be held at least once a year or more.

In case of difference of opinion or dissent among the trustees, majority of the trustees in the meeting shall prevail and shall be binding on the trustees who have not voted. In case of equal votes matter shall be decided by casting vote of managing trustee.

7. Quorum for the Meeting of Board of Trustees :

The quorum for the meeting of the Trustees shall be at least two (two) trustees.

8. Admission or Adoption of New Trustees :

The Board of trustee may have power of admitting additional Trustees to the Trust as they may desire subject to the condition that anyone to be so admitted shall be dedicated to the cause which the Trust aims to accomplish but the fee of trustee shall not be more than Rs. 1000/-.

9. Management of the Trust :

- (i) This Trust shall be managed by the Board of Trustees whose name of office shall be as follows: They may employ additional workers and staff for running the Trust and any amount of the Trust of any term and condition as the Board of Trustees may require.
- (ii) The Board of Trustees shall strive for the fulfillment of the objectives of the Trust and shall be liable to report any time or termination or removal to all shareholders.

(iii) The Board of Trustees have agreed to appoint a Managing Trustee Mr. Ram Prasad Pandey to perform all the responsibilities that may be entrusted to him.

(iv) The Board of Trustees shall open a Bank Account with a Nationalized or Scheduled Bank or Banks in the name of the Trust and all the funds of the Trust shall be credited to and operated through the said account or accounts by any two of the trustees or by Managing Trustee and secondary beneficiary to be passed by the Trust in that regard.

(v) Any investment in which the trustees may be authorized by law to invest the trust property ~~including~~ ~~the~~ ~~assets~~ ~~of~~ ~~the~~ ~~trust~~ ~~fund~~ including those in immovable property may be made or kept in the name of the trust through Managing Trustee with anyone or more trustees or be made payable to or transferable by any two or more trustees in the name mentioned herein.

(vi) It shall be lawful for the trustees at any time they may in their absolute discretion think fit to sell by public auction or by private contract or exchange or transfer or assign or grant lease or sub-lease for any term now or hereafter or otherwise dispose of all or any part of the trust fund including the immovable properties ~~mentioned~~ ~~herein~~ and on such term and condition relative to title as otherwise and in all respects as they may think proper and to buy it and receive or vary the same for sale exchange transfer assignment lease or otherwise disposition without being answerable for any loss occasioned thereby and for such purpose to execute all necessary conveyances deeds or exchanges assignments

... and to give and execute necessary receipts, returns and discharges by the consideration money or otherwise totaling to the doctrine and insurance. All money arising from any such transfer or other operation shall be paid to the trust fund and shall be applied as aforesaid.

10. The Board of Trustees may with the like powers and responsibilities for the conduct and management of the trust and for the same the increased and the raising of the funds by an unlimited liability of any assets owned or held by the company.

11. Application of the Funds and Properties of the Trust:

- i) The funds and properties of the trust shall be used, deployed and utilized for fulfillment of the aims and objectives of the trust as mentioned above and for future incidental matters.
- ii) The management, administration of the trust, the funds of the trust may be invested in movable properties of securities, bonds, stocks, shares, debentures and other investments for fulfillment of the objects of the trust.

12. Powers of the Trustees:

ii) The Trustees shall, in strict accordance with and subject to the rules, Regulations and By-Laws of the Trust and in respect the same whenever a doubt arises as to the meaning of any particular word, phrase or clause contained in any such rules, By-Laws or regulations. However, any such interpretation should not conflict with the aims and objectives of the trust.

- (iii) All resolutions and decisions of the Trustees shall be in the form of a resolution passed at a meeting of the Trustees present and voting.
- (iv) Accounts Meeting do not require quorum and such findings the subjects of the previous meetings may be taken up for discussion and decision by the Trustees present at the said meeting.
- (v) The Trustees shall have the authority to approach any public authority, Government, Trust, Charitable, Municipal Corporation or any other public authorities for fulfillment of the objects of the Trust.

52. Amendments

The Trustees shall have the powers to amend the terms of the Trust deeds, by a resolution carried by a majority of not less than two-thirds of the number of trustees present at the meeting at which such resolution is passed. However, no amendment shall be made to the Trust Deed without prior approval of the Commissioner of Income Tax.

53. TRANSFER OF ASSETS IN EXCEPTIONAL CIRCUMSTANCES

The assets and the funds of the Trust shall be administered for the objects of the Trust and for no other purpose. In the event of inability to continue the activity of the Trust, the assets remaining as on the date after meeting liabilities if any of the Trust and if all circumstances be established among the Trustees or donors, all shall be transferred to another Charitable Trust Society, Foundation or Institution whose objects are similar to those of the Trust.

14. Accounts:

The Board of Directors shall maintain correct and proper accounts of the affairs of the Trust. The accounting year of the Trust shall be from April to March of every year. The accounts of the Trust shall be audited annually by qualified accountants appointed by the Trust.

15. Objectives:

All the privileges and advantages allowed to the Trust and its functioning shall be for the benefit of the poor and the vulnerable sections of the people, including the women, children, sick and similarly situated persons who shall be served by the Trust with a sense of dedication with involvement. Service to humanity is service to God and that is the dominant objective and object of the Trust. Trust shall be not profit earning in the mind of any of the Trustees or its employees and all activities of the Trust shall be for the benefit of the Trust.

16. Suits and Proceedings:

The Trust may sue or be sued in its name and be represented in the said proceedings by a person authorized by the Board of Directors. Proceedings shall be commenced in the court of law in which the Trust is situated.

17. Application of the Funds and Properties of the Trust:

In all matters not provided by the deed, the Trust shall be governed by the provisions of the Indian Trust Act 1982 except the said provisions conflict with the objects of the deed. In the event of any such conflict, the provisions of the

These shall prevail over the provisions of the Act and in all other matters the provisions contained in the Trust Deed.

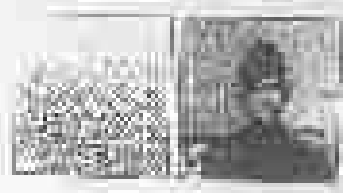

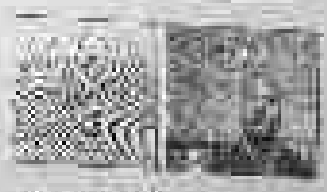
