

• All the decisions vis-à-vis the affairs of the Trust will be taken unanimously by the consent of all the board of Trustees

• In case of difference of opinion arising among the Trustees and in all matters wherein the Trustees shall have a discretionary power the votes of the majority of the Trustees of the time being voting in the matters shall prevail and be binding the minority as well as on those Trustees who may not have voted, and if the Trustees shall be equally divided in opinion in the matter shall be decided according to the casting vote of the President.

9. **Meeting of Board of Trustees:** The Trustees shall hold, and the President may convene as many meetings for transacting business, as may be necessary, but at least two meetings in a financial year shall always be held. • **Notice:** Three days Notice shall ordinary be given in writing for a meeting of Board of Trustees.

• **Quorum:** The quorum for the Meeting of the Board of Trustees shall be Two members or 1/3 of total trustees whichever is higher. Quorum is not required for a meeting adjourning for want of quorum.

10. Power & Duties of Board of Trustees:

(a) To improve and add to the Corpus of the Trust by accepting donations, contribution by way of cash or in kind in the shape of any movable or immovable assets for and on the behalf of the Trust and hold the same for the Trust; and
