- (d) To undertake the propagation of literacy and education, in particular literacy and training regarding computer science; mechanical, engineering, industrial and technical education and training and to establish, maintain, run, develop and improve, extend, grant donations in cash or kind and assist in the establishment, maintenance, running development, improvement and extension of schools, colleges, workshops, computer training centers, industrial and technical training institutes, polytechnics, programs, projects and awards under its own auspices or of other agencies, including the adoption of zones, areas, districts, institutions for the promotion and development of agriculture, institutions for conserving and promoting national heritage and the development of scientific temper, hostels, libraries, etc. for the poor and indigent students and persons, and maintain agricultural farms for the benefit of poor persons especially widows, orphans and the disabled, of the enhancement of quality of human life;

- (e) To carry out Institute, establish, maintain, run, develop and improve, extend, grant donations in cash or kind and assist in the establishment, maintenance, running development, improvement and extension of special programs and centre for the health and care of the aged, the vulnerable and dispossessed, the handicapped, the minority and backward communities, women and children and to generate employment and skills among the youth;
- (f) To carry out institute awards of excellence and scholarships for the study, research and apprenticeship and for the propagation of the highest standards in all or any of the aforesaid purposes.
- (g) To serve humanitarian cause and to help, assist, take care of disabled, needy, indigent, disable distressed and handicapped person by way of medical assistance of treatment including provisions of medicines, rendering services of professionals, doctors, providing food/shelter during such treatment, assisting with money towards cost thereof and/or to establish, run, maintain or aid hospital, Nursing Homes, Dispensaries, Clinics, Maternity Home, Health Centers, Medical Colleges, Blood Banks, Eye Banks, Ambulance division, mobile dispensaries or any other society institute for treatment of patients as well as animals and birds.

- (h) To construct, help, assist, maintain dharmshalas, ashrams, restrooms provide for drinking water, provide for general sanitation in residential localities to provide assistance in cash or in kind to people stricken and affected by natural calamities like Drought, Famine, Flood, Earthquake etc. to provide basic amenities for social good and welfare of the people and/or to promote family planning.
- (i) To undertake all acts, deeds and things connected with, incidental to and germane to the aforesaid objects.
- (j) There shall be no discrimination on the grounds of race, religion, caste, creed, community or sex in carrying out the objects of the Trust.

6. TRUSTEES :

- (A) The Ownership and control of the Trust and the Trust properties will vest in the Board of Trustees. The Board of Trustees shall comprise of not less than 3 (Three) and not more than 7 (Seven) Trustees. However, the maximum number of the Trustees may be increased by the Trustees for the time being in force and also constituting two-third majority of the board of Trustees.
