- (x) To establish maintain or support rest-houses, eating places or both, dharamshalas, convalescing homes, health and immunization camps, infirmaries, orphanages;

- (xxvii) To do all such acts, deeds and things and extend all such other assistance to the said voluntary organizations as may be necessary and incidental to the attainment of aforesaid objects.
- (xxviii) All Activities financed from the funds shall be conducted in accordance with the ideals and objects as stated hereinabove and no discrimination shall be made on grounds of religion, caste, creeds, sex or political affiliation of the implementing agency or beneficiary.


5. BOARD OF TRUSTEES.

- i. The management and control of the Trust and the Trust properties shall vest in the Board of Trustees which shall comprise of not less than two and not more than seven trustees including the Chairman and the Managing Trustees.



- ii. All other Trustees to be appointed subsequently will hold office for period of three years after which one-third of them shall retire by rotation on the basis of their seniority.


6. APPOINTMENT OF NEW TRUSTEES




7. EFFECT OF APPOINTMENT OF NEW TRUSTEES






13. POWER TO BORROW




16. OPENING BANK ACCOUNTS
