



- 2 The name of the Trust shall be **TARAWATI-TAULAYRAM EDUCATIONAL TRUST** and shall in perpetuity remain so
- 3 The Settlers of the trust shall consist of members named Shri Taulayram Gangwar, Smt. Tarawati Gangwar, Shri Rajesh Kumar Gangwar, Ratnesh Kumar Gangwar, Smt. Priyanka Gangwar, Smt. Shobhana Gangwar.
- 4 That the number of Trustees of the Trust shall be six and by resolution passed by majority of Trustees, President and secretary may at any time increase or decrease number of Trustees.
- 5 In case of death or resignation of any Trustee, such Trustee shall be succeeded by his descendant, sibling or spouse nominated by such Trustee especially for the purpose of the Trust and in it's absence on the basis of primogeniture of male descendant. In case there is no male descendant then the eldest female descendant shall be the Trustee in place of such outgoing Trustee. This rule will apply generation after generation for the Trustee.
- 6 The Trust shall consist of members coming from the families of Sri Rajesh Kumar Gangwar and Sri Ratnesh Kumar Gangwar. The succession from the families of Sri Rajesh Kumar Gangwar and Sri Ratnesh Kumar Gangwar shall be from the branches of their sons, they are holding their names high

Schedule and if such money is not sufficient from such securities or loan, advance etc as the Trustees may consider it necessary for the purpose.

13. That it is reiterated that Board of the Trustees shall be the Supreme Governing Body of the College, Hostel, Boarding house etc established or run by it and its funds. Management of various Institute and Colleges, Hostel established or run by the Board of Trustees shall work under supervision, control and directions of the Board of Trustees. No person or body shall have the power to alter this Supremacy.
14. The Board of Trustees shall have the power and discretion to accept any donations or contributions, whether such donations or contributions be in cash or in form of immovable or movable property.
15. That no any part of the Trust property can be sell out by the President & Secretary with the permission of the district judge.
16. The Board of Trustees shall frame the Rules of Management of the Colleges and other Institutions established and run by the Trust. The Rules for management of the College are as mentioned in the Appendix I. The Board of Trustees shall have the right to make such amendment, modification, addition,

substitution in rules of Management of the college as it deems fit from time to time. That the Rules of the Management of other Institutions colleges that may be established or run by the Trust shall be the same as the rules of Management of the College except that in the place of MJP Rohilkhand, relative University or other Educational Body shall stand substituted. The Trust shall be based upon mutual faith. An Appeal shall lie to the patron from the decision of any office-bearer, body or authority or employee of the Trust or College. The patron may set aside confirm or renfit the same for reconsideration. The Trust is authorized to make such amendment, modifications, substitution, additional alterations in the Rules of such other Institution as it deems fit and to fulfill the statutory requirements and conditions of the Educational bodies or Universities.

17 That the Account of the Trust shall be opened in a Bank with the consent of all the Trustees of the Trust wherein all the income and donations shall be deposited (after meetings day to day expenses) Any balance after payment of government revenue, ^{stamp} ~~cases~~ taxes, license fees for all purpose and all expenses of collection shall be deposited in such bank and invested as the Trustees may consider proper.
