- (p) To encourage the youth to develop the awareness of education and career consciousness to sponsor scholarship and nationwide/foreign trips to develop a modern and internationally compatible academic environment and research.
- (q) To provide for the well being of the public at large and ensuring their healthy development 'the Trust may open dispensary, hospitals or other medical facilities as it may deem fit.

- The Settlors of the trust shall consist of members named Shri Taulayram Gangwar, Smt. Tarawati Gangwar, Shri Rajesh Kumar Gangwar, Ratnesh Kumar Gangwar, Smt. Priyanka Gangwar, Smt. Shobhana Gangwar.
- 4 That the number of Trustees of the Trust shall be six and by resolution passed by majority of Trustees, President and secretary may at any time increase are decrees number of Trustees.
- In case of death or resignation of any Trustee, such Trustee shall be succeeded by his descendant, sibling or spouse nominated by such Trustee especially for the purpose of the Trust and in it's absence on the basis of primogeniture of male descendant.
