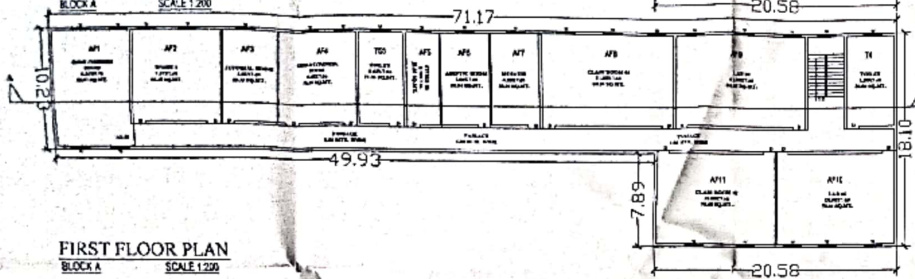
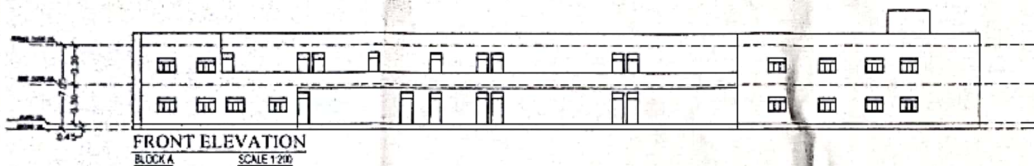


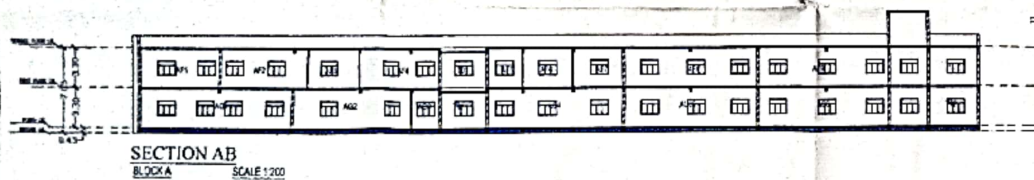
GROUND FLOOR PLAN

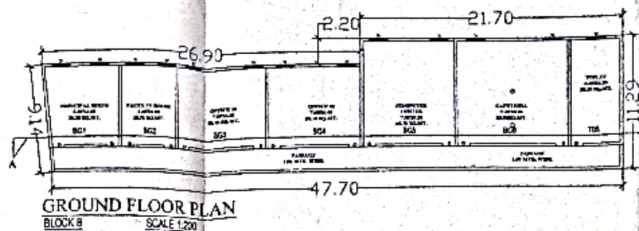
FIRST FLOOR PLAN

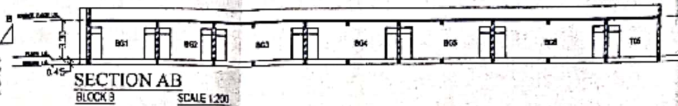

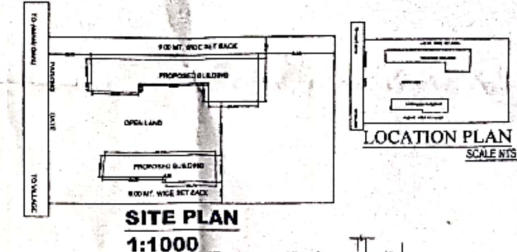
GROUND FLOOR PLAN

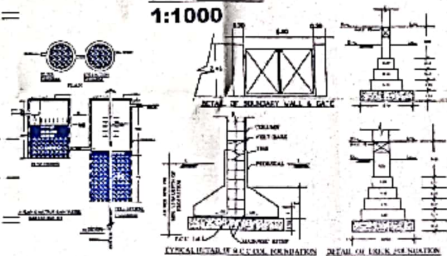
