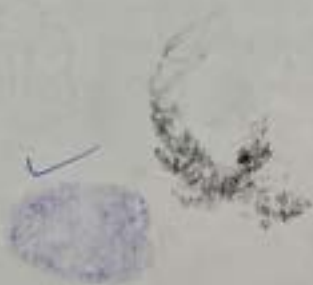

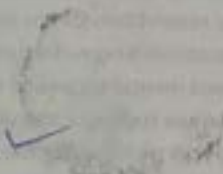

- (ix) To establish maintain and run a Boarding House and Residential Institution for the students and those connected with the Institution.
- (x) The amount of settled Rs. 10,000=00 shall be deposited in any Nationalised Bank, the chairman shall be entitled to open account related to trust in any Nationalised Bank. The amount of Trust shall be operated by chairman.
- (xi) To borrow raise loan from any persons Bank or financial institutions in such manner as the trustee shall think proper or convenient for the furtherance of object of the trust and for this purpose. The trustee may secure repayment of these loans in any manner as may be decided from time to time.
- (xii) The trustee shall be entitled and be at liberty to accept gifts, voluntary contribution from any person, firm or institutions or government and to collect subscription donation or aid from state Government, Central Government to augment the trust fund and use such money for the objects of the trust.
- (xiii) To do all necessary acts for the incidental or conducive for the attainment of above objectives of the trust.

- (C) In the event of vacancy arising in the Board of Trustees for whatsoever reasons, the remaining trustees shall co-opt another person to fill up the vacancy who may be member of the family of the said trustees temporarily likely to be permanent of ten the period of two years. Temporary trustees will not here any power to vote.
- (D) The number of trustees shall never be less then three and more than eleven.
- (E) The trustees shall work in honorary capacity but they shall be entitled for reimbursement of expenses in curred by them in the conduct of their duties or in promotion of the objects of the trust or on the behalf of the trust.

No trustees shall be entitled to take loan from the trust or take any advantage for himself or any member of his family in whatever from or manner from the trust.

- (F) If a trustee who by his conduct as a trustee or in his personal life, adversaly reflects on the reputation of the trust may be asked by the board of trustee by a resolution passed by a majority to submit his resignation, failing which he shall cease to be a trustee with effect from the date of passing of such resolution.
- (G) The trustee may institute, conduct, defend, compound or abandon any legal procedure by or against the trust or trustee and allow time and indulgence for payment or satisfaction of any debt or passing of such resolution.

- (H) The trustee of the trust may obtain payment of money from all courts and department of the state and central governments including local authority or authorities.
- (I) The trustee may purchase, construct, alter lease, rent partly or fully immovable or movable property from time to time. They shall have a power to sell movable or immovable property of the trust by passing or resolution by two third of the majority in the best interest of the trust as when necessary and to use these proceeds for the objects of the trust only.
- (J) The trustee may authorise any of the trustee to appear before the registrar or sub-registrar of any other officials appointed for registration of deeds, documents and other instruments and to execute, present admit and register or cause to be registered any deed, documents etc. in which the trust is interested or involved.
- (K) The trustee shall be empowered to employ or part time employees or professionals or re-tainer ship basis according to the requirements of various institutions time to time, the trustee shall have power to accept honorary services of any person volunteering to do the work in the trust or in the charitable institution run by the trust. The trustee shall have full disciplinary control and powers for such staff employees, workers honorary or otherwise.

(L) The trustee with 2/3 majority can add or amend or make any by-laws of the clauses of the trust as needed from time to time for smooth functioning of the trust.

**MEETINGS :-**

- (1) The trustees may meet together as and when they may think necessary, but they shall hold at least two meetings in a year.
- (2) The quorum at a meeting of the trustees shall be of two when the strength to the trustees is three. The quorum shall be three if the strength is more than three.
- (3) Sanjay Kumar (Trustee) shall be the first Chairman of the trust further he has nominated her wife Smt. Kusum Devi to be the next chairman after her retirement or death and then the elder son shall be next chairman after his retirement or death, the younger son shall be next chairman after his retirement or death, the elder daughter shall be next chairman after his retirement or death the younger daughter shall be next chairman. After they take charge in the absence of all the above persons, the trustee shall act accordingly to the decisions of the majority of the trustees when the trustees are not unanimous the chairman shall have casting in case of tie. The members of the trust shall be always appointed by blood related chairman.
