31. WINDING UP

32. GENERAL:

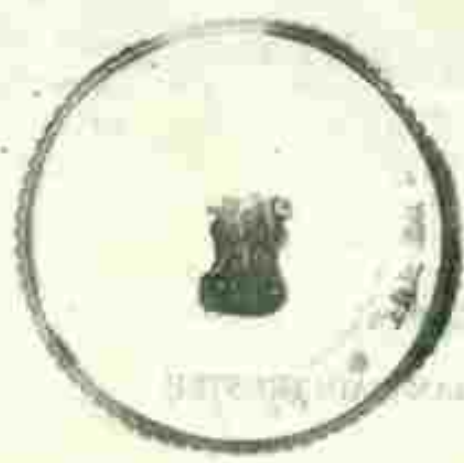
