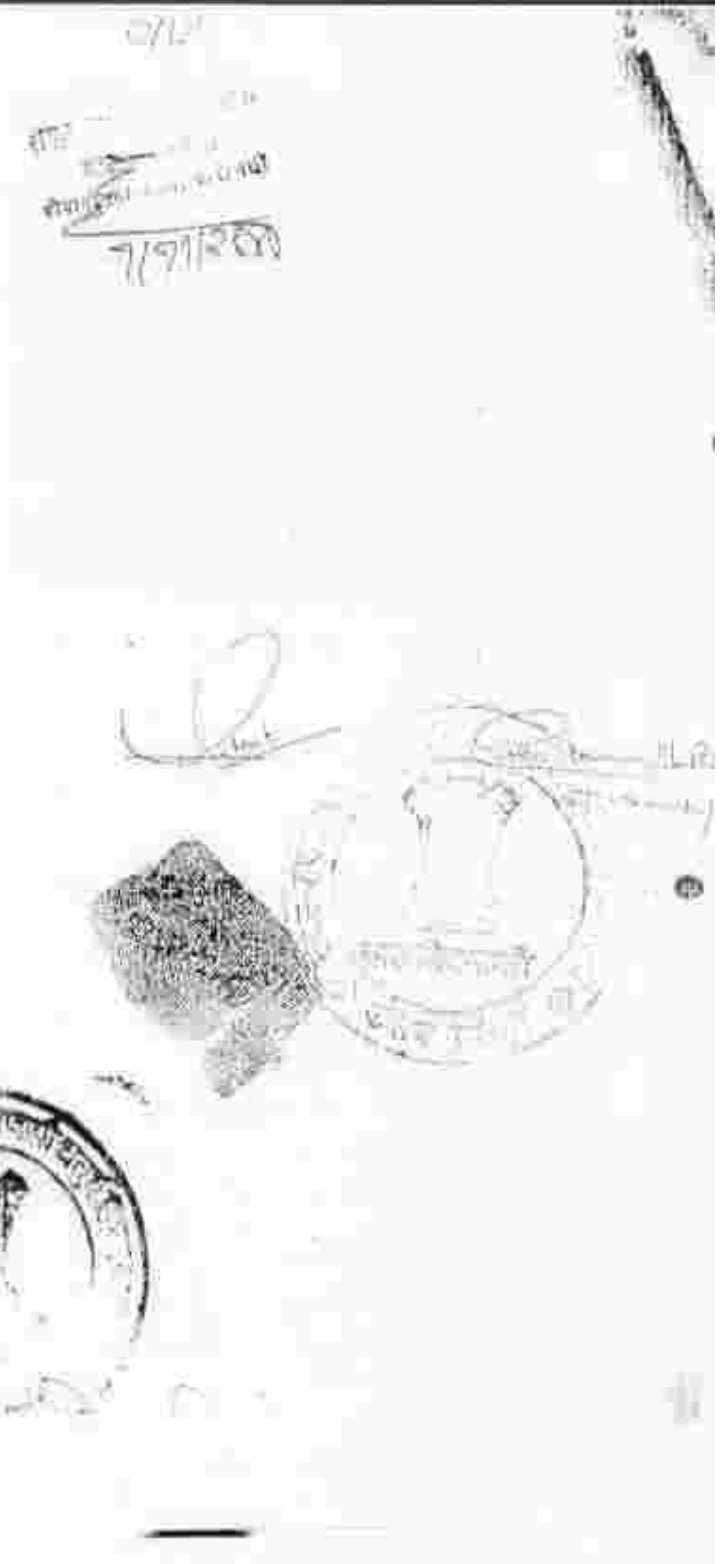

**4. OBJECTS :** That the objects for which the Trust is founded are:

P. 11/5/11

- (a) To establish, open, maintain and run Educational Institutions, Schools, Colleges, Research Institute including Medical Colleges for imparting training and education and to maintain and run it.
- (b) To appoint franchisees, agent or dealers to carry out the above activities.
- (c) To carry on the business of providing consultancy in the above fields.
- (d) To spread education and for achieving the said object to establish, maintain, run develop and improve, extend, grant donations in cash and kind and assist in the establishment, maintenance, running development, improvement and extension of Schools, colleges, workshops, industrial and technical schools, hostels, institutions for the promotion of agriculture hostels for the benefit of needy students maintain agricultural farms for the benefit of the poor.
- (e) To give Scholarship, Prizes, Awards, Loans and other assistance.
- (f) To establish, maintain or acquire library or libraries for the benefit of the student community.
- (g) To institute and award scholarships in India for the study, research and apprenticeship for all or any of the aforesaid educational purpose.

- (h) To serve humanitarian cause and to help, assist, take care of disabled, needy indigent, disable distressed and handicapped and sick person by way of medical assistance or treatment including provisions of medicines, rendering services of professionals, doctors, providing food/shelter during such treatment, assisting with money towards cost thereof and/or to establish, run, maintain or aid Hospital, Nursing Homes, Dispensaries, Clinics, Maternity Home, Health Centres, Medical Colleges, Blood Banks, Eye Banks, Ambulance division, mobile dispensaries or any other association/society, institute for treatment of patients as well as animals and birds.
- (i) To afford medical aid and relief of all kinds and varieties to infirm, poor, needy and deserving persons.
- (j) To provide help, assist, in cash or in kind, the poor families to provide food, shelter or clothing as well as to give financial assistance for the marriage of needy and poor girls.
- (k) To carry out programme for welfare of weaker section of the society and also for development of backward areas and rural areas of the country.
- (l) To assist deserving unemployed uneducated persons for setting up their own cottage industry, business or vocation etc. To enable them to staff for earning of livelihood for self and his/her family.

- (m) To construct, help, assist, maintain Dharmshales, Ashrams, Rest-rooms provide for drinking water, provide for - general sanitation in residential localities to provide assistance in cash or in kind to people stricken and affected by natural calamities like Draught, Famine Flood, Earthquake etc. to provide basic amenities for social good and welfare of the people and/or to promote family planning.
- (n) To donate/help/pay any other public charitable and religious trusts for promoting the above objects of this Trust.
- (o) To do all such things as are incidental or conducive to the attainment of the above mentioned objects or any of them; and it is hereby declared that the interpretation of any of the aforesaid objects and in the event of any ambiguity they shall be construed by the Board of Trustees in such a way so as to widen and not to restrict the objects of the Trust.
- (p) For the removal of doubts it is hereby declared that this Trust its objects and its implementation shall not be against the objects of the Trust as mentioned in above clause.

#### 5. TRUSTS :

That the Board of Trustees shall hold and stand possessed of the Trust fund upon the Trust viz.

- (a) To manage the trust fund and to collect and recover dividends, interest, rents, profits, gains and income thereof.

- (b) To pay and apply the same in the first instance from time to time towards payment of proper costs, charges and expenses of and incidental to the collection thereof and the money required for the repairs, maintenance, insurance, taxes, wages and salaries of employees and other charges in any way related to or connected with the trust property and management of the Trust Fund including the charges and expenses of and incidental to the trust and powers herein contained and the costs, charges and expenses of the appointment of the executive trustee secretary and/or additional trustees from time to time.
  - (c) That the appropriation of the income or corpus of the Trust towards any one or more of the objects mentioned herein above shall be made by the Board of Trustees from time to time.
  - (d) That the Board of Trustees shall be at liberty to utilise the income and/or the corpus of the trust for any one or more of the objects aforesaid and in such proportion as they may in their absolute discretion think fit.
  - (e) If the income, inclusive of donations and contribution to a particular year, is not fully utilised for any one or more of the aforesaid objects, the Board of Trustees shall be entitled to accumulate and carry forward the unexpended income to the next year or years.
6. That the Board of Trustees shall mean and include the Trustees of these presents, survivors or survivor of them and the Trustees for the time being of these presents. The Trustees for the time being shall be entitled to appoint new Trustees to fill up the vacancy caused by death, resignation or removal or otherwise. The minimum number of Trustees shall be two and the maximum shall be seven. The Trustees, in these presents may also nominate to his spouses or blood relation for becoming in the Board of Trustees in his place and then the nominator trustee will be no longer as Trustee.

7. Without restricting the generality of the power of the Board of Trustees, the Boards of Trustees shall be empowered :

- (a) Holding of Properties : to hold and be possessed of the Trust Fund and its properties.
- (b) Donation etc. : to invite, raise, accept and receive donations, contributions, subscription, grants, gifts, benefication etc. in cash or in kind or in immovable or movable properties for all or any of the objects of the Trust.
- (c) Nature of Receipts : to determine in case of the ambiguity or doubts whether any money or property received be considered as capital or income and whether out of the income or capital any expenses or outgoings shall be paid or borne or ought to be paid or borne.
- (d) Immovable Properties : to buy and acquire or sell and dispose off by public auction or private contract or exchange or transfer or lease or sub-lease or licence or otherwise any immovable property on such terms and conditions as they may think fit and proper from time to time and in furtherance of the above to enter into any agreements or covenants with the owners of or persons interested in any other properties.
- (e) Investments : To invest the Trust fund and all moneys in their hand which may require investment in or upon any one or more of the following securities or mode of investment with power from time to time at their discretion to vary any investments and securities held by the Trust for other objects of the character hereby authorised namely :
  - (i) Any stock or securities issued by or the payment of the principle and interest thereof shall be guaranteed by the Government of India or the Government of any State in India.
  - (ii) Debentures, Debenture-Stock or ordinary stock or shares of any company at a fixed or minimum rates of interest or dividend on which the repayment of principal of which is guaranteed by the Government of India or any State Government in India.



- (iii) In fixed or other deposits with scheduled authorities and a nationalised bank or banks.
- (iv) Any security or investment authorised by the India Trust Act, 1950 and/or Income Tax Act, 1961.

(f) Safe Custody of Documents :

To deposit title deeds, securities, investments and other documents relating to the Trust property for safe custody in a scheduled bank or banks and to make the necessary arrangements for realisation of interest or dividends on investments of the trust through bank and to pay the charges payable to the bank for services.

(g) Construction :

To construct, pull down, renovate, rebuild, alter, adopt, improve develop, repair, maintain or insure any immovable property and to authorise any other person on such terms and conditions as it may think fit to do any one or more of the foregoing acts or deeds and to do such other acts, deeds and things which are considered necessary or expedient from time to time.

(h) Endowment :

To create set-up, maintain, manage and support or help endowments, Trusts etc., whether set-up and created by this trust or otherwise for fulfillment or achievement of any one or more of the objects of the trust.

(i) Granting Donations :

To donate whether in cash or in kind any part of the trust property to any institution carrying out any one or more of the objects of the trust on such terms and conditions as it may think fit.

(j) Movable and Immovable Properties :

To acquire immovable or movable properties for the trust and like wise have to sell, lease or mortgage or otherwise deal with such properties, in the interest of the trust.

(k) Granting Loan :

To grant loan for any one or more of the purposes aforesaid and on such terms and condition as it may think fit.

(l) Resignation of Trustee :

To consider and, if deem fit to accept resignation rendered in writing by any of the trustees to these presents.

(m) Agents & Attorneys :

To appoint, employ and remove any agent or attorneys for such purposes and with such authorities and for such period and subject to such conditions as it may think fit and to remunerate and to reimburse of the expenses of such persons.

(n) Employees :

To appoint, employ, suspend and remove such officers, clerks, servants and employees for permanent, temporary or special services on such terms and conditions as it may think fit and to make the necessary rules, regulations and provisions relating to the same.

(o) Bringing and Defending Actions :

To utilise, conduct, defend, compound, compromise or abandon any legal proceedings by or against the trust or otherwise concerning the affairs of the trust to arbitration and observe and perform any awards made thereon ; and

(p) Generally, to do such acts and things as it may consider or calculate necessary, expedient or conducive to the attainment of the objects of trust whether or not the same is specified or enumerated or illustrated herein above.

**8. POWER AND DUTIES OF TRUSTEE :**

*Praveen*

- i) That Sri PRAVEEN RAI shall be the managing trustee of the trust during his life time and he shall have overall powers of superintendence over the affairs of the trust and shall have in particular, the power to operate the bank accounts, borrow money for the trust, and to carry out the objects of the Trust.
- ii) That the Managing Trustee shall preside over the meeting of the Board of Trustees.
- iii) In the event of absence of the Managing Trustees in particular meeting of the Board of Trustees present there at may choose any of them to preside over that meeting.
- iv) The Trustees shall have powers to accept donation in money or otherwise for the purpose of this Trust.
- v) The Board of Trustees shall do such other lawful things as are incidental in carrying out the administration and management of the Trust.
- vi) The Trustees may open and operate current or saving or other accounts with any Scheduled Bank or Banks and by resolution authorise any one or more of the Trustees either singly or jointly or severally to operate on such accounts.
- vii) Meeting :  
The Board of Trustees shall meet as often as may be necessary or convenient to transact business. The Board of Trustees might transact business and take decisions by circulation of papers also.
- viii) Resolution :  
The Management and administration of the Trust shall vest in the Board of Trustees. All decisions of the Board of Trustees shall be taken by simple majority and if the Board is divided equally, the Managing Trustee shall be entitled to the second or casting vote.



ix) Quorum :

In all meetings two trustees will form a quorum. PROVIDED FURTHER that if the number of trustee fall below two then for the purpose of appointing a new trustee one will form a quorum.

x) Minutes :

That the minutes of all proceedings of the Board of Trustees shall be written in the Minute Book and shall be signed by the Chairman of the meeting at which the proceedings took place or by the chairman of the next succeeding meeting. Each page of the Minute Book shall be consecutively numbered.

xi) The Trustees may frame rules and regulations as to the duties and responsibilities of each Trustee, to appoint sub-committees, mode of conducting any other matters connected with the administration of the Trust and its management.

9. That the accounts of the trust shall be made up as on 31st March of every year and shall be audited by a Chartered Accountant appointed as auditor.

10. IRREVOCABLE TRUST :

That the trust is expressly declared to be irrevocable and public charitable trust and all the provision of this deed to be considered appropriately.

11. WINDING UP :

In case the trustee decide to wind-up the trust in future, they shall hand over the corpus of the trust fund with income upto that date to any one or more public charitable trust or institutions having similar objects that of this trust and no immovable property is hereby included in the aforesaid deed presently.

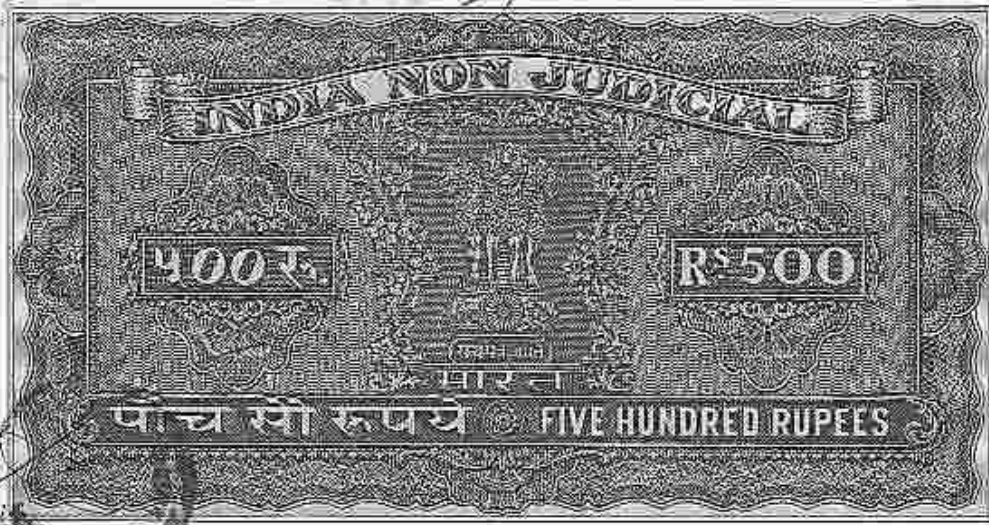

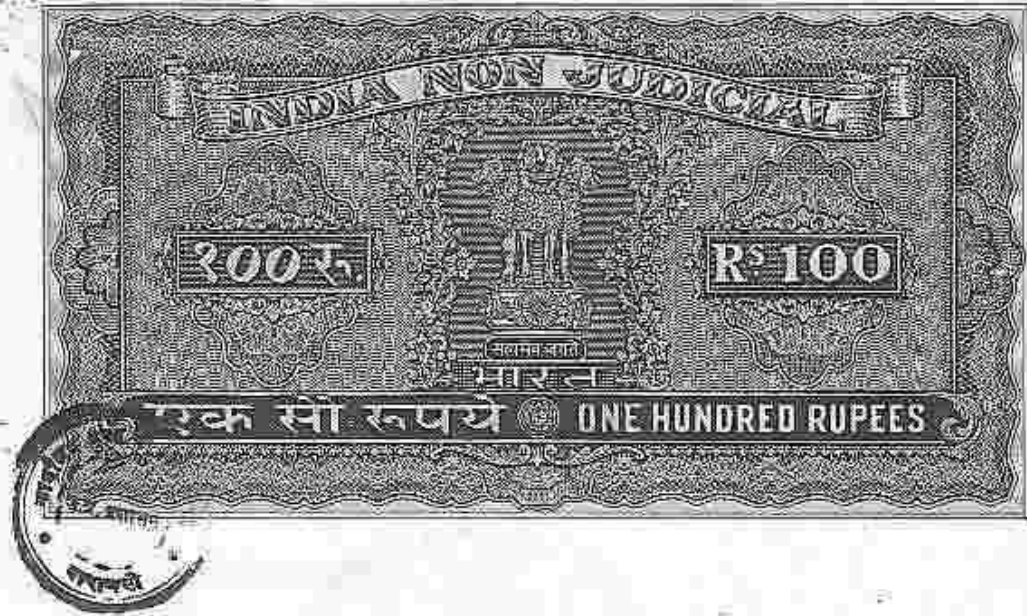
