(vi) The Trustees may open and operate current or saving or other accounts with any Scheduled Bank, Nationalized Banks and the resolution authorizing any one or more of the trustees either singly or jointly or severally to operate on such accounts.

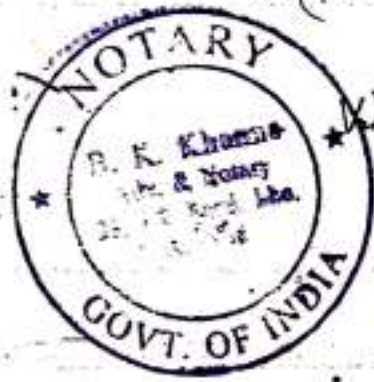
