AND WHEREAS the Trust was originally established on 8th May of 2000 registered on 17th May 2000 vide Book No. IV, Jild No. 1761, Page No. 711/ 758 Number 596; was revised on 16th September 2004 (registered at Book No. IV, Jild No. 1797, page No.479/ 516 number 506) and one Addendum dated 10th December 2010 was entered into (registered at Book No. IV, Jild No. 2895, page No. 167 to 174 , S.no 1835).

Whereas the present Trustees, in their meeting held on 1st December, 2020, have agreed to place a revised Trust Deed for the purpose of clarity and record.

NOW THIS DEED OF TRUST WITNESSETH AS UNDER:

- 1 That the Trust shall be known as "MANGALMAY FOUNDATION TRUST"
- 2 The Founder of the Trust named above, had conveyed and transferred a sum of **Rs. 11,000/- (Rs. Eleven Thousand only)**, in favour of "MANGALMAY FOUNDATION TRUST" for the objectives hereinafter mentioned and relinquished all claims or rights in the above said transferred sum. And whereas on the date of formation the trust is **not having any moveable and immoveable property except Rs. 11,000/- only** that the trust every member cant not take presently any benefit of the trust property.
- 3 That the Trust fund shall be the said amount donated by FOUNDER named above and all creations, acquisitions and other property movable and immovable which may under the trusts and powers of these presents (all of which are hereinafter in these presents designated as "The Trust Fund") and provision of these presents be substituted or added in the execution of the trusts, contributions, donation and bequeaths whether in cash or in kind as income of the Trust. That the donation towards corpus will not be treated as income. That the Trust shall have the inherent right to declare any donation as corpus fund to meet expenditure either of recurring in nature of otherwise. Any income generated from Corpus, may be retained as part of the corpus fund or may be used to meet the expenses of the trust as the need may be.

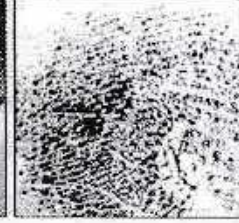



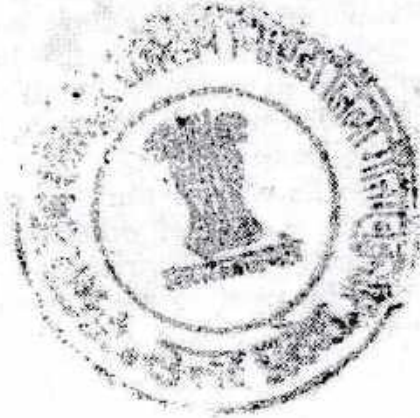

4 OFFICE OF THE TRUST:

The Registered & Administrative Office of the Trust shall be at **C-116, Sector 39, Noida DISTRICT GAUTAM BUDH NAGAR (U.P.)** and the same can be shifted to any other premises or land acquired / to be acquired for the purpose of the Trust in any other part of India with the decision of the Trustees of Second Party.

5 JURISDICTION:

The Jurisdiction of the Trust shall be *all India.* (amended from 8.9.2000)*

6 AIMS AND OBJECTS OF THE TRUST:


This Trust is created for carrying out all the objects, including the following objects, for public charity within India or outside India and for the benefit of the society.

a) To provide, promote and restructure higher education facilities in the field of Commerce, Medical, Engineering, Management, Computer Science, Teacher Education, Arts, Media & Communication, Economics, Fashion, Insurance, Healthcare, Law, Bio-Sciences, Life Sciences, Technical Subjects, Professional and Vocational Courses, Nursery, Primary, Middle and Higher /Sr. Secondary Education, Distance learning programme, part time programme for the needy students, intellectuals and other persons of the Society and to be supportive to the business eco-system inter alia by incubating worthy start-ups and other early-stage ventures.

b) To engage Teachers, Professors, Instructors, Professionals, Management Personnel, Technical Advisors and experts of good moral character and having capability to impart efficiently and economically up to-date knowledge to students in Medical Engineering, Management, Computer Science, Bio - Sciences, all Vocational Courses, Nursery, Primary, Middle and Higher/Sr Secondary Education, Distance Learning Education, Intellectual and other usual pursuits for the benefit of General Public.

c) To establish, acquire, construct, maintain and run group of Faculties, Universities in different fields, Colleges, Institutions, Polytechnics for imparting all sorts of education in the field of Medical, Para Medical, Engineering, Management, Vocational Courses and Nursery, Primary, Middle and Higher / Sr. Secondary Education in India or outside India to children, boys, girls and to men and women.

d) To establish, acquire, purchase, construct, maintain hospitals, Health Care Centres, Recreational Centres, diagnostic Centres, Study Centres, Branch Campus, Nursing School, Nursing Homes, Clinics, Old Age Homes and Convalescent Homes with up to date facilities, Maternity Homes, Working Women Hostels, Child Welfare Centres and Dispensaries for the benefit of public in General.

e) To establish, acquire, construct, maintain and run Auditorium, Sports Complex, Play Grounds for furtherance of skills of sports, athletics etc.

f) To establish, acquire, purchase, construct or maintain Community Centres, Dharamshalas, Rest Houses etc. for the benefit of members of the Society.



j) Rendering help or assistance for any public charitable purpose and national cause.

k) To do all such acts and activities for the upliftment schedule castes, scheduled tribes and other backward and minority classes of people.

l) To develop a healthy as well as critical attitude towards the development of mental, physical and moral upliftment of the students and those connected with the Institutions so as to make them good citizens.

m) To accept donations, grants, presents and other offerings and to deal with the same for the purpose of the trust.



n) To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of Institutions established or about to be established under this Deed.

o) To train and equip pupils so as to be self-supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.

p) To develop discretionary conduct and a habit to observe the rule of law and self-resistance.

q) To bring out, encourage and develop the inventive and research faculties of the pupils and teachers and to afford opportunity for research work in Medical Science, Art, Science Industrial and Information Technology and other allied areas of these types.

7. a) In the event of Trustee intending to withdraw from the Trust or submitting his resignation the same may be allowed by the Board of the Trustees by simple majority decision and prior approval of the Chairman of the trust.


 



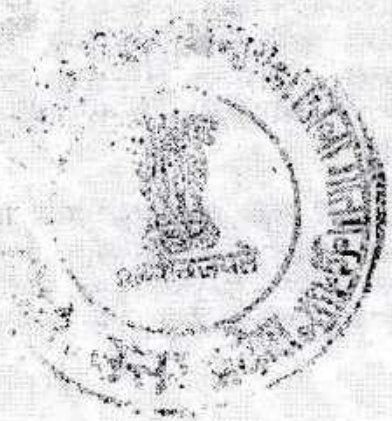

b) In case the Trustees feel that any other Trustee is not working in conformity with the aims and objectives of the Trust or otherwise feel that his working is not in the interest of the Trust, that particular Trustee in question may be removed from the Trusteeship by a decision of two third majority of the Trustees. However, the approval of the Chairman of the Trust shall be essential and binding to all for removal of any Trustee. In any circumstances and eventualities the Founder of the One Part cannot be removed or impeached by any resolution of the Trustees either in individual or by collective decision.

c) Any vacancy of the Trustee shall be filled up by an approval of simple majority of the existing trustees for the period upto the ensuing annual general meeting and the same shall be considered with the prior consent of the Chairman of the Trust.

The Administration of the Trust shall be vested in the Trustees, who shall not be less than two in number, inclusive of the founder or members or descendants of their family, and shall be known collectively as the Board of Trustees and all decisions of whatsoever nature pertaining to Trust shall actively be taken by the principle of simple majority in writing and in case of dispute of whatsoever nature, the decision of the "Chairman of the Trust" shall be final and binding in all respect. The number of trustees may be increased/reduced at the discretion of Chairman of the Trust at any point of time but not exceeding Ten.



8. OFFICE BEARERS OF THE TRUST:



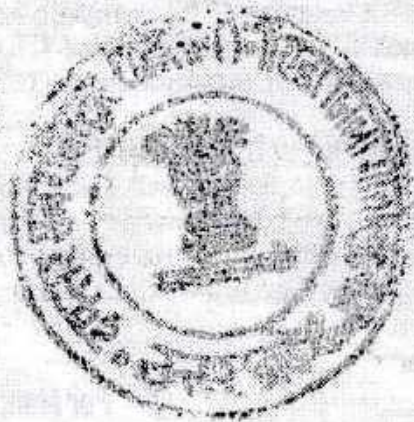

(viii) Such other posts as may be deemed necessary for the functioning of the trust or for all or of any Institution run by the Trust for a specified period of time in writing during such appointment.

(a) The post of Chairman shall be occupied by Mr. Atul Mangal, S/o Sh. L.S. Mangal,

Trustee of the other part.

(b) The Post of Vice Chairman/ Vice Chairperson* shall be occupied by Ms. Shikha Mangal W/o Sh. Atul Mangal, Trustee of the other part. (* from 20.8.2004)

(c) The Post of Vice Chairman* shall also be occupied by any of the Trustee to be appointed by the Board of Trustees of the Trust.. (* from 30.11.2020 after acceptance of resignation of Mr. Anuj Mangal wef 30.11.2020)

(d) The Post of Secretary* shall be occupied by Mr. Aayush Mangal S/o Sh. Atul Mangal, Trustee of the other part. (* from 29.10.2013)

9. POWER & FUNCTIONS OF THE CHAIRMAN OF THE TRUST:

The Director, Chief Executive Officer and all other executives shall be appointed by the Chairman of the trust to handle the objective of the Trust or Institution of the Trust to the best of all respects. The Chairman of the Trust shall be the link between the executive Officers viz. Chief Coordinator, Director etc. and the Board of Trustees etc. and will be having all powers which any Trustee or Trustees jointly or severally or any other Officer, called by whatever name can exercise in their powers for the interest of the Trust and for fulfillment of any or all aims and objects of the Trust. *All the powers of the Chairman including to hold authority to allocate or reallocate the duties shall be subject to the approval of the Board of Trustees. * (added on 8.9.2000)*

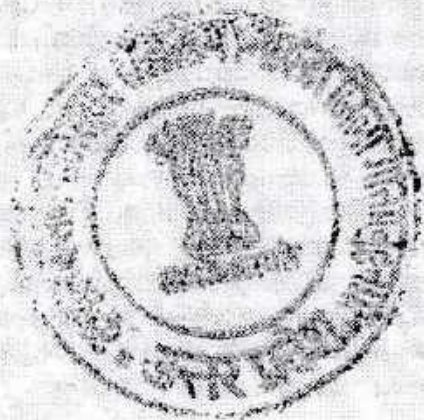

10. DIRECTOR AND CHIEF COORDINATOR* ETC. OF THE TRUST:

The appointment of the Director and the Chief Coordinator etc. shall be governed by the service regulations as may be adopted by the Board of Trustees on the recommendations of the Chairman. Once appointed, the Director and the Chief Coordinator etc. shall work for the Trust or Institution / Institutions of the Trust until they cease to be in the employment of the Trust or Institution / Institutions of the Trust in the following circumstances:

(i) That either of them resigns voluntarily in writing with specific reasons and it has been accepted by the Chairman.

(ii) The Director and Chief Coordinator absent himself for a continuous period of 30 days from the registered office of the trust.

(iii) The Director and Chief Coordinator goes abroad to stay there for a period of more than 30 days unless and otherwise the purpose of such stay abroad is official and approved by the Chairman of the Trust.

(iv) The Director and Chief Coordinator becomes lunatic or mad during such absence of the Director and Chief Coordinator the Chairman shall nominate or act himself to perform or to supervise all or such functions which are to be looked after by the Director and Chief Coordinator.


11. POWER AND FUNCTIONS OF VICE CHAIRPERSON

To act as Chairman in the absence of the Chairman and do any job as assigned to him by the Chairman.

12. POWERS AND FUNCTIONS OF THE SECRETARY:

Secretary shall be responsible for calling a meeting with the approval of the Chairman and recoding all minutes and resolutions passed or rejected in the house of meeting of the trust. And to implement the decisions of the Board of Trustee he will do the duties as are assigned by the Chairman / Vice Chairman / Board of Trustees.

13. POWERS AND FUNCTIONS OF THE TREASURER:

The Treasurer will be responsible to collect various funds, keep records of Accounts and keep balance of the accounts from time to time and perform such financial duties as and when directed by the Chairman or Board of Trustees.

14. POWERS AND FUNCTIONS OF MEMBERS:

Any Three Members* of the Trust may request the Chairman/ Secretary for calling emergency meeting of Board of Trustees within one week's time. The Chairman/Secretary will participate in the discussion for resolving matters of interest of the Trust. (amended on 10.12.2010)

17. POWER & FUNCTIONS OF THE DIRECTOR/CHIEF COORDINATOR # :


(i) The Director and the Chief Coordinator shall be independently functioning under the Chairman and shall report directly to the Chairman of the Trust regarding their official responsibilities.

(ii) The Director and the Chief Coordinator, the two senior-most incumbents in the Trust, shall implement and execute all policy decisions taken by the Board of Trustees from time to time and as per the direction of Chairman or Board of Trustees.

(iii) The Director shall be responsible for formulation and implementation of all scientific and technological projects, field demonstration projects as and when taken up in conformity with the aims and objects of the Trust and under the overall guidance of the Chairman of the Trust, whereas the Chief Coordinator shall be responsible for the execution of all administrative decisions taken by the Chairman and Board of Trustees. The Chief Coordinator shall also be supervising officially for the accounting and financial aspects of the Trust.

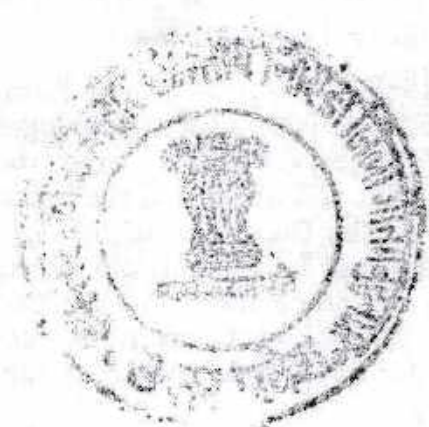

(iv) In relation to the day to day administration of the Trust, Chief Coordinator shall be supervising authority in disciplinary matters and shall act in consultation with the Chairman and shall also be answerable for the commission / commissions in respect of day to day affairs of the Trust.

(v) Beside the powers and functions of the Director and the Chief Coordinator by these presents, or otherwise expressly conferred upon the Chairman, they shall perform all such acts and duties which are not expressed otherwise for the interest and for achieving the goals of the Trust and as and when assigned by the Chairman.

(vi) The Chairman of the Trust shall hold the Authority to allocate or reallocate the duties and functions need be as may deem fit. *All the powers of the Chairman including to hold authority to allocate or reallocate the duties shall be subject to the approval of the Board of Trustees. * (added on 8.9.2000)*

18. POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES:

(i) All the policy decision shall be taken by the Board of Trustees and conveyed to the Chairman for its implementation and final approval.

(ii) The Chairman shall get the decision of the Board implemented through Director / Chief Coordinator or any other incumbent employed / working in the Trust. In case of any dispute arising out of any decision, the verdict of "Chairman" shall be considered as full and final and binding to the Board of Trustees.

(iii) Without prejudice to the General Power conferred by the last preceding clause and other powers conferred by these presents, it is hereby expressly declared that the Trustees shall have the following powers:

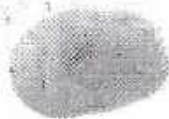

- a) To pass accounts of the Trust and consider any recommendation made in regard thereof at a General Meeting.
- b) To pay the expenses incurred in carrying out the objectives of the Trust and to make and give receipts, releases and other discharges on behalf of the Trust.
- c) To acquire for the trust land, property, rights or privileges on such terms and conditions as they deem fit.
- d) To invest in shares and stocks of companies, Mutual Funds, Golds, FDRs of Banks, units etc. and deal with moneys of the trust in such a manner as they deem fit and from time to time to vary or release such investments in the interest of Trust subject to the rules and regulations under Income Tax, 1961, or under any or all other govt. statutes.
- e) To enter into and secure the fulfillment of any contracts or engagements on behalf of the trust, compound or abandon any legal proceedings by or against the Trust and to refer any matters, claims or demands or to arbitrate, observe and perform the awards.
- f) To set up independently or in collaboration with Foreign Institutions or University, constitute and organize local branches in India or abroad of the Trust in such manner and on such terms as may be considered necessary in the interest of the Trust and to constitute committees consisting of two or more persons not necessarily members of the Trust and vary the same and delegate to them of such powers as may be considered for the purpose.
- g) To employ instructors and personnel as may be considered necessary for the paid purpose and to employ skilled workers and professionals, Advisors to carry out the objectives of the Trust and to pay such remuneration as may be considered expedient.

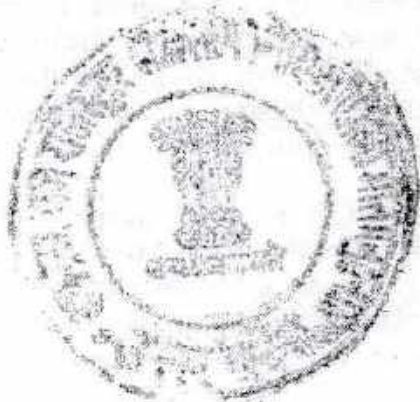

h) To accept grants, donations and contributions in cash or in kind from other public bodies, corporations, associations, institutions, companies or individuals within India or abroad, for the purpose of the Trust on such conditions as may be agreed to by the Chairman or Board of Trustees.

i) To provide for funds for all or any objectives of the Trust in such manner as may be considered expedient.

j) To draw, accept, endorse, discount, execute and issue promissory notes, bills of exchange and other negotiable transferable instruments in the interest of trust.

k) To purchase, take on lease or in exchange, hire or otherwise acquire any movable or immovable property, and in particular any land, buildings, workshops connected with privileges necessary for or consistent with the purpose of the Trust and to construct, erect, alter, improve and maintain any building and to manage, develop, sell, demise, let, mortgage, dispose off, turn to account or otherwise deal with the same and also to sell the undertaking to Trust for cash or any other consideration with a view to promote the objectives of the Trust.

l) To pay all expenses, preliminary or incidental to the formation of the Trust and its registration.



m) To establish, support or aid in the establishment of Trust Institutions, funds and Trusts, calculated to benefit employees or employees of the Trust or the dependants or connections or connections of such persons and to grant superannuation benefits and allowances and to make payments towards insurance of such persons.

n) To make rules and regulations and bye-laws for conducting smoothly and successfully the affairs of the Trust in a better and planned way and to amend or alter the same.

o) To appoint or make provision for the appointment of any person.

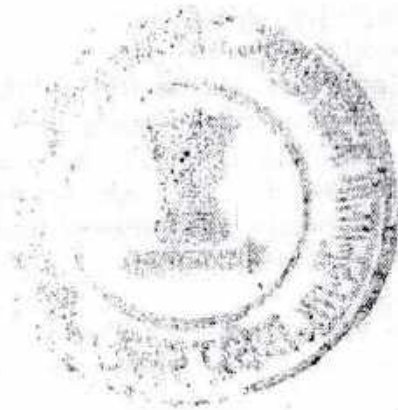

p) To borrow or raise or secure payments of moneys and also to lend money either with or without security *only for charitable purposes with the prior approval of Board of Trustees;** in accordance with rules and regulations and all statues application to the Trust. *(added on 8.9.2000)

q) Generally to do all such things as the Trustees may consider expedient for the purposes of carrying out the objectives of the Trust.

r) Trustees shall not do such things or acts which directly or indirectly accrue in any benefit or bad effect impliedly or expressly to the Founder Trustee of One Part and to other Trustee(s).

s) Trustees shall be empowered to do all such things and acts for public charitable purposes which are in the benefit and to provide all necessary relief and help to the needy and poor persons belonging to any caste, creed or religion.

t) Trustees are empowered to fulfill the objects of the Trust and to do all other things under the name and style of the Trust i.e. "MANGALMAY FOUNDATION TRUST" or to open separate Institutions independently or in collaboration with Foreign Institutions to be under any name and style to fulfill the aims and objects of the Trust.

19. RULES OF THE TRUST:

a. Every meeting of the Board of Trustees shall be chaired by the Chairman and in his absence Vice Chairperson shall chair the meeting.

b. Such a meeting shall be held once in three months or within a period as decided by the Board of Trustees.

c. Even two members of the Board of Trustees present in person shall constitute a quorum at any meeting of the Trust.

d. Chairman/Secretary may call on requisition in writing a meeting of the Trust at any time.

e. For official purposes, each year shall be deemed to commence from 1st April and terminate on 31st March.

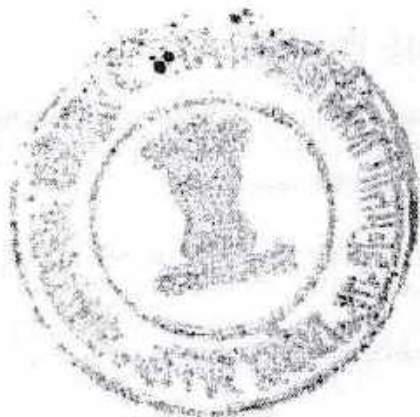

f. (i) Each member of the Board of Trustees shall have one vote.

(ii) Where there is a deadlock in regard to any particular issue, the decision of the Chairman, and in his absence the Vice Chairperson shall prevail and binding to all.

g. The Board of Trustees may by General or Special Order, direct that any resolution, to be placed before the meeting, may be passed by circulation amongst all the trustees. Any resolution so circulated and approved by a majority of the trustees signing the circular shall be as effective and binding as if such resolutions had been passed by at a meeting of the Board of Trustees.

h. (1) To establish and grant Scholarships, prizes for the students and other persons showing distinctive performance in education and other fields of Operation.

(2) To sponsor the deserving, needy students for their higher education in India or outside India and to pay them tuition fee and all other expenses.

i. To acquire on lease or by purchase or otherwise any immovable properties including pieces of land or build properties thereon of any kind under any name and style for the use of Trust and fulfillment of its objectives.

j. To manage, sell, transfer, let out by way of Tenancy, lease license or otherwise dispose off or deal with the assets / properties of any kind both moveable or immovable belonging to the trust.

k. To enter into any agreement or arrangement with any other Society, Foundation, or any other party having any legal entity or any individual for the functioning and achievements of the objectives of the Trust in a better way.

l. To take up any other activities as deemed appropriate towards public interest as and when decided by the Trustees.

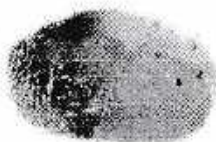

m. To receive and maintain in a fund or funds and to administer and apply the income and principal thereof for the furtherance of the objects of the Trust and to do all such acts and things which are incidental and conducive to the attainment of the above objects, specified hereinabove and promoting the general welfare and well being of the Society and uplifting the social, educational, cultural, moral or economic condition of the masses. Provide that if anyone or more of the purpose or objects specified hereinabove are held not to be the purpose or objects of a public charitable nature, the Trustees shall not carry out such purposes or objects by which the validity of the trust created by these presents as a Trust for Public Charitable Objects or Purpose shall be effected in any manner.

20. TRUSTEES AND THEIR APPOINTMENTS :

Trustees (the so called as the "Founder of One Part" the Trustees of the Other Part) above named, shall be the First Trustees of the Trust for their life.

21. RECORDING OF PROCEEDINGS:

The Chief Coordinator shall ensure minutes to be duly entered in the book provided for the purpose.

Such minutes shall be signed by the Chairman, Secretary and one from the Director and Chief Coordinator or any Trustee.

22. MEETING OF THE TRUSTEES:

(i) The Trustees shall hold the Annual General Meeting of the Trustees once every year at such time not being more than 15 months after the last preceding Annual General Body Meeting) at such place and time as may be prescribed by the Chairman of the Trust. In case of any dispute, the decision of Chairman will be full and final and binding upon all.

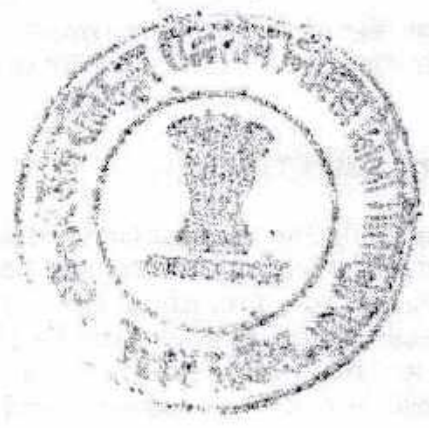

24. BANKERS AND OPERATIONS:

The Board of Trustees shall open/close/maintain account/accounts with any Nationalized/Scheduled/Cooperative Bank(s)/Private bank in the name of the Trust or in the name of any Institution run by the Trust for fulfillment of all or any object of the trust and the same shall be operated upon by the Chairman, or Vice Chairman either severally or jointly as may be authorized by the Board of Trustees from time to time, i.e. anyone of the trustees.

25. FUNDS OF THE TRUST:

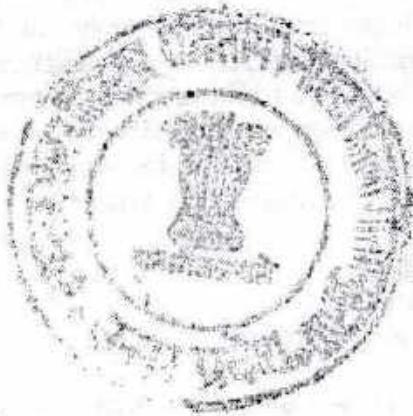

26. POWER TO MAKE RULES AND REGULATIONS:



A draft of the Annual Report, yearly accounts and its statements shall be prepared by the Secretary and presented to the Board of Trustees through Chief Coordinator and Director at least thirteen days in advance of the Annual General Meeting for information and Consideration.

30. INDEMNITY:

The trustees shall be fully kept indemnified and harmless by the Trust against any action and claim, loss suffered, or liability being against them, on account of anything done by them in good faith pursuant to the powers and authority conferred on them by these presents.

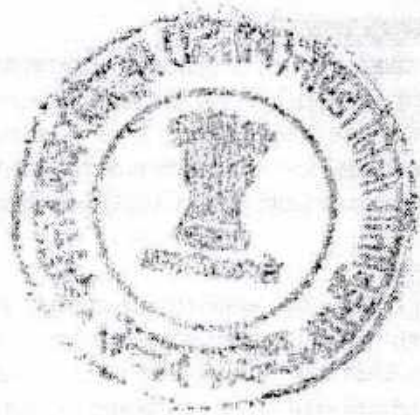
