THIS DEED OF DECLARATION OF TRUST executed on this 01" MARCH 2022 by RAUSHON KUMAR JHA, son of RAM DEO JHA and residing at SATYA MARG, BEHIND GRAMIN BANK, MOHADDIPUR, KHORABAR URF SOOBABAZAR, GORAKHPUR - 273008 (U.P.) Indian National, hereinafter called

"THE SETTLOR"

WHEREAS, the settlor is desirous of creating a Welfare and Charitable Trust with the primary object of educating, empowering the rural peasantry of our country, India, and execute the requisite deed of trust, setting forth the terms and conditions and provisions for the proper and efficient administration of the Trust.

I. NAME

The TRUST shall be called "PLATINUM EDUCATIONAL TRUST"

II. HEAD OFFICE

The Office shall be for the present at BILANDPUR, NEAR DURGA MANDIR, DAUDPUR, GORAKHPUR, 273001, UTTAR PRADESH and at such other place or places as the Trustees may decide from time to time.

III. THE BOARD OF TRUSTEE


The Board of Trustees including the Author/Settlor of the Trust i.e. First Party & Second Party shall not be less than 2 be called as The Board of Trustees. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

Following persons who are keenly interested and have agreed to work as the member of the trust in the interest of the trust have at the request of the settlor given their consent to be the trustees along with the settlor for administrating and executing the affairs of the said trust in accordance with the terms and conditions hereinafter provided:

IV CORPUS

WHEREAS the said RAUSHON KUMAR JHA set apart a sum of Rs. 10000.00 in cash towards constituting a Public Charitable Trust and handed over the same to the trustees herein after appearing and other trustee member a sum of Rs.1100.00 for Hfc time and approval of Managing Trustee;

AND WHEREAS the Trustees have also accepted the Trust Fund and property as stated above;

AND WHEREAS it has become necessary to declare the objects and terms of the Public Trust.

V OBJECTS OF THE TRUST

The Main Objects of the Trust shall be:

- A. To run and maintain Institutions to provide for education for any discipline food and clothing to them.
- B. To encourage handicrafts & music.
- C. To create a sense of brotherhood, social, communal harmony and peace in the Society.
- D. To promote the cause of national integrity and India.
- B. To motivate implementation of ideologies of great men and national leaders.
- F. To render & provide service to the women, children & youth of the society for upliftment of their moral, mental, socio- cultural and other human values so as to improve & persuade them to lead a happy, prosperous and sustainable, life style with their own economic reforms.
- G. To revive & encourage India art, cultural values and literature to promote literacy through organizing, seminar, competitions, exhibitions, conference, training, educational & upliftment.
- H. To socially develop schedule caste, schedule tribes & other weaker sections of society.
- I. To found and manage by Govt. permission, if required for various charitable educational, industrial, vocational and other community development programs/ activities like construction of community hails, Dharmshala, Sulabh shauchalayas, orphanage centers, low cost sanitation, old age hames, hospitals, libraries, reading rooms, stadium, yoga centre, play grounds, training and research centers for the attainment of objectives of the trust.
- J. To help for lawful steps for the eradication of social evils, corruption and illegal activities like Bal Vivah, child labour Dowry system, wastage of money on pomp & show, use of addictive substances and other drugs.
- K. To establish research & training courses for providing latest technical know-how to the society and for providing vocational trainings in various allied trades like sewing & tailoring, knitting making handicrafts, toys, wall hangings training based on food processing & preservation, making of various food products, with packing thereof & other allied small scale industrials trades like electronic, motor binding, radio T.V., audio/video, electronics, computer pumping set repairing and other training allied to agriculture / horticulture, food production, mushrooms, Bee keeping, animal husbandry, dairy, cottage, production of species, medicinal & ayurvedic plants, renewable and non conventional energy sources, to the rural youths/ girls and women for making them self-reliant.

L. To take up effective steps for free education, training & rehabilitation of various handicapped persons, deaf & dumb, leprosy person, destitute widows, old men & women, beggars and to provide all types of necessary assistance, with a view to make them

independent in all respect.

M. To promote the interest, organize awareness camps, yoga camps and drives in the rural areas of environment, sanitation, total literacy, family planning, mother and child care, AIDS, cancer, hepatitis B, fileria, other reproductive & child health services, breast feeding, sense of brotherhood, integration, importance of self employment, traffic rules for safe transportation role of Panchayat, women development, formation of self help group for their development and other various allied issues also to organize free medical checkup & immunization camps in the rural areas.

N. To arrange, establish & run primary, middle, higher secondary/ Inter school under U.P. Board, ICSE or CBSE, vocational schools & institutions and to provide general education to the students of all sections, girls and also to bring up the poor and backward people

especially in the rural areas

O. To establish and manage various types of educational, cultural, social, institutions, yoga centers and other research, training and demonstration centers in the fields of industrial, scientific, computers, medical technical, agricultural, horticultural, agro forestry medicinal & syurvedic plants, bio diversity conservation, environmental pollution and other issue of global concern.

P. With Government permission, protect the historical monuments, buildings, religious places & sports. Also to protect and conserve farming & production of endangered species, crops, herbs, medicinal & ayurvedic plants, promotion of flower culture promoting the use of free born oil seeds like mango, neem & castor, turmeric, tulsi and other plants for sustained development of rural people by optimum use of local available

plants and resources.

Q. To perform the activities related to optimum utilization of available local natural resources including crop residues, agricultural wastes and kitchen, house hold-organic wastes, dung and other waste products. For production of organic bio-fertilizer for Sustainable agricultural. Development.

R. To arrange, run and establish Degree College, P.H. college, Engineering, Medical of

Pharmacy College, Managing Institution under U.G.C./ Govt. Rules.


S. To carry out the all activities for the welfare of animals including domestic as well as wild animals.

T. To establish rehabilitation centers, cowsheds and other animal shelters, sheds for the street animals. The aims and object of the society shall be purely for charitable purposes, which shall be non-profit,

U. To produce documentaries for the objects of the society.

V. To implement programs of different agencies and organizations such as Ministry of Social Welfare, CAPART, SIPSA, NABARD, SIDBI, HRD Ministry, UNICEF etc. without limiting to these.

W. To donate to institutions having similar type of activities



VI RULES AND REGULATIONS

1. OFFICE BEARERS OF THE TRUST

SHRUTI SINGH shall be designated as the Managing Trustee, who shall be in charge of the day to day affairs of the Trust.

Membership fees shall be Rs.1001/- in every three year. Member trustee shall not be less than 2 and more than 11 at any time during the period.

2. VACANCIES

Any vacancy among the Members of the Board of Trustees may be filled by the Managing Trustee with the consultation of the Board of trustees.

Casual Vacancy aroused due to this removal shall be filled in the member nominated by the Managing trustee.

3. BENEFIT OF THE TRUST

The Benefits of the Trust are open to all irrespective of Caste, religion, race, sex etc. That the Trust will not carry on any activities with an intention of earning profit

4. APPLICATION OF INCOME AND TRUST FUND

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provisions of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

5. TERMINATION OF OFFICE OF THE TRUSTEES

Trustee shall cease to hold office:

- a. if he/she dies,
- b. if he/she resigns,
- if he/she is adjudged insolvent or found guilty of an offence involving moral turpitude.
- d. if he/she is found to have acted against the interest of the Trust.
- e. if it is unanimously decided by the Board of Trustees that his/her continuation in the Office is against the interest of the Trust.
- Upon expiry of the period up to which the Board of trustees have nominated the trustee.
- g. If he/she is member or becomes the member of a political party.

6. MEETING AND PROCEEDINGS OF THE TRUSTEES

The Trustees shall ordinarily meet once in 12 months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

 15 days Notice shall ordinarily be given in writing for a meeting of Board of Trustees.

8. QUORUM

The Quorum for the Meeting of the Board of Trustees shall be one third numbers. No quorum is required for a meeting adjourning for want of Quorum.

9. RECORD OF THE TRUST

A Minute book And Notice book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the Board of trustee shall be entered in the minute book and shall be signed by the President of the Meeting.

10. VOTING

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The President of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

11. POWERS, FUNCTIONS AND DUTIES OF THE BOARD OF TRUSTEES

All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the Managing Trustee/Chairman shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

In particular and without prejudice to the generality of the foregoing the managing trustees shall for the purposes of this trust have the following powers, duties and functions:

- a. To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
- b. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- c. To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- To raise loans, to receive monies, securities or other movable property on behalf of the Trust.
- e. To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consenance with the objects of this Trust. To award scholarship and make donations calculated to promote the objects of the Trust.
- f. To enter into contracts, or engagements on behalf of the Trust. And to consider such proposals submitted by Sub -committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- g. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.

h. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.

 To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of

the Trust.

j. To appoint a Committee / Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.

k. To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees

including the power of suspension, dismissal and removal.

To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.

To frame Bye-Laws and such other regulations as are required for achieving its objectives

Out of the income of the trust property the managing trustee shall be entitled to spend or incur the following expenses namely:

- i. All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part
- ii. The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.

iii. The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.

iv. The cost of making such additions/alterations or improvements to or in thebuildings forming part of the trust property, as the trustees shall think fit.

v. Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.

vi. Cost and expenses of keeping the trust property in good condition.

vii. Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.

viii. The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.

ix. All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes

hereof or which may be incidental thereto.

x. After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

12. BANK ACCOUNT

The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of "PLATINUM EDUCATIONAL TRUST" such accounts shall be jointly or severally operated by the President/Managing Trustee or any other trustee who will be appointed by the Board of Trustee for the same.

The trust may open Bank Account's in the name of institution / organization founded by the Trust. Such Bank Accounts shall be operated by the President/Managing Trustee or any other person to whom President/ Managing Trustee may appoint.

13. IRREVOCABILITY

The Trust is irrevocable.

14. BORROWING POWER

The Board of Trustees may borrow money or raise loans and funds required for any purpose, power or provision either directly or indirectly concerned with the object of this Trust and to charge the whole or any part of the property belonging to the Trust as security for repayment of the money borrowed. This is to further state that Personal Guarantee for such borrowing can be given by the Managing Trustee and Settlor only. No other trustee will be authorized to give personal guarantee for borrowing loan on behalf of Trust

15. APPLICATION OF THE PROPERTIES OF THE TRUST

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

16. ACCOUNTS

The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a Chartered Accountant every year i.e., commencing from 1st April to the 31st March of next year.

17. DEFECTS OF PROCEDURE IMMATERIAL

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

18. AMENDMENTS

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 11, 12 and 13 and of the Income Tax Act, 1961 as amended from time to time. However, other than the specified above amendment, may be issued which Board of Trustees may from time to time think fit.

19. DISSOLUTION

In the event of dissolution of winding up of the Trust, on account of death of all trustees, incapacity of the trustees, the assets of the trust remaining on the date of dissolution shall






