- (b) It shall be lawful for the TRUSTEES to borrow money either on the security of any property belonging to the Trust or otherwise to Fulfill any or all of the aims and object of the Trust, and if shall be lawful for the TRUSTEES to make these borrowing and the payment of any interest that may result on such terms and conditions as they think fits.
- (c) It shall be lawful for the TRUSTEES to apply to the Government, Public bodies, Local municipal, district and other bodies, Corporations, companies, or persons for And: to accept grants of money and donation, Gifts, subscriptions and other assistance With a view to promoting the aims and objects Of the Trust and to discuss and negotiable with the Government departments, public and Other bodies, corporations, companies or Persons, schemes and other works and matters Within the aims proper condition upon which Such grants and other payments may be made.
- (d) The TRUSTEES shall cause True and Accurate accounts to be kept of all moneys Received and spent and of all matters in respect thereof in the course of the management of the trust property or in relation to the carrying out of the aims and objects of the trust as well as of all assets, credits and effects of the trust property.
- (e) THE ACCOUNTING YEAR OF the trust shall be financial year that is year ending 31<sup>st</sup> march every year.
- (f) A firm of chartered Accountants engage by the TRUSTEES shall audit the Accounts of the trust every year.
