- (i) To create set up and maintain endowments and to disburse the income and corpus to arrange the management thereof on such terms and conditions as the business may stipulate for one or more of the objects of the trust;
- tm) To impart training in literature and science, industry, and vocational trades and professions in congenial environment;
- (n) For the progress and welfare of mankind, and for keeping the human being free from the evils of the society, the trust would start a center, where the like-minded persons may get together and exchange the thoughts through the via media of books, literature, yoga and resumes. For Promoting this activity the trust would coordinate with other similar type of organizations.
- to the carry on any other work which is deemed to be necessary and required to directly or indirectly, promote any of the above mentioned objects.
- 4- <u>Utilization of Resources</u>: All the donations, income, profit or gains, moveable or immovable properties of the trust shall be solely utilized and applied towards the promotion of aims and objects of the trust and no portion there of shall be -paid or transferred directly or indirectly by way of dividends or bonus, profit or in any manner whatsoever to the trustees or to any person chaining through any one or of the trustees. No trustees shall have any personal claim on any moveable or immoveable properties of the trust and by virtue of his trust or any profit there from whatsoever, by virtue of his being the trustee.




## 41 Founder Trustees :-

Founder trustees shall be competent to elect with 3/4th of their majority in a meeting convened for this purpose as many trustees as required from time to time.

#### 6.2 - Cessation of trustees :-

- Dropped when decided by 3/4th majority of the Board of trustees in a meeting convened for this purpose.

(Note 3/4 th majority of the Board of trustees would mean, 3/4 th of the total Board of trustees being alive at the time of the meeting).

#### 7.0 Meetings:

7.1 The meeting of the Board shall be convened by the chairman or in his absence by the vice chairman or on the request of 3/4 th majority of the total members of the trustees.

The meeting shall be held at least once in every year. Twenty One days notice shall be necessary for the meeting except in emergent cases. The notice shall accompany the agenda of the proposed meeting. All the decisions of the meeting shall be taken by 2/3 rd majority of the members of trustees.

The chairman will have powers of easting vote. The group of the Board of trustees at a meeting shall comprise of at least 3 members. In case on the appointed date, the quorum is not complete, the meeting shall be adjourned to another day and on the adjourned day the trustees present shall be the quorum. The meeting can be tallo any where in the world.



8.2 The member of the trust can be increased as decided by the board of trustees from time to time by 3/4 th majority, however the maximum number of the trustees can be increased to 21.

# 9.1 The Management Committee of the trust shall be as under :-

1- Smt. Chandramukhi

Election for all the office bearers, shall be held every two years at a special meeting convened for this purpose if any post is vacated due to any reason whatsoever between this period , the Chairman shall be at liberty to appoint any founder trustee temporarily for the remaining period .

# 9.2 Powers and functions of the Chairman:

The Chairman of the Board is the constitutional and administrative head of the trust and will remain the Chairman of the Trust for two years time. The Chairman shall be elected out of the founder Trustees

Unanimously. In case of difference, the Chairman shall be elected amongst the founder trustees by 3/4 th of the majority, however Smt. Chandramukhi will be the first chairman of the trust for lifetime.

It is to be noted that after Smt. Chandrmukhi, only Yogesh Chandra OR his legal beirs will be the chairman to the trust.


The Chairman will -

i) Preside over all meetings of the Board of trustees and the sub committees appointed by it.

ii) Convene a special meeting of the Board, if and when necessary

- iii) Perform such other functions as are entrusted by the Board.
- iv) be competent to authorize any person to act for better performance and to achieve the object of the trust.
- v) be competent to appoint, re-appoint and dismiss the staff and advocates and other professionals and do all other acts necessary to carry on the objects of the Trust.
- 9.3 In the abscence of the Chairman, his functions shall be performed by the vice Chairman .

## 9.4 Powers and functions of the Secretary are :-

- i) Conduct the day running of the Trust, Subject to the control and supervision of the Chairman.
- ii) Exercise general supervision over the functioning of the trust and general control and supervision of its properties.
- iii) Maintain office record and attend to the correspondence.
- iv) Convene meetings of the Board of trustees.
- v) Maintain a list of the founder trustees.
- vi) Perform such other functions as are assigned to him by the Chairman or Board of Trustees.
- vii) Record minutes of the meeting of the Board of Trustees.

## 9.5 Powers and Function of the Treasurer

The Function of the Treasurer of the Trust is :-

- i) Maintain accounts, cashbook and other accounts books.
- ii) Prepare annual budget statements and also arrange reappropriation from one head to another, If and when necessary.
- iii) prepare annual balance sheet, income and expenditure account and receipts and payment and also audit by a Chartered Accountant approved by the Board .

iv) Perform such other functions are assigned to him by the Chairman or from Board of Trustees.

## 9.6 Powers and Functions of Management Committee:

- i)To exercise over all supervision of the functioning of the trust.
- ii)To approve the audited annual income and expenditure statement and balance sheet presented by the treasurer.
- iii)To approve and finalize annual budget.
- iv)To consider and finalize the annual report about the programmers and activities presented by the secretary and assess the over all trust performance.
- v)To ensure the proper implementation of the decisions taken during the previous meeting.
- vi)To offer guidelines for future working.
- vii)To define ways and means to augment the trust resources and accelerate the tempo of implementation.
- viii)To interpret the construction and adjudiente in cases of any reference received by it.
- ix) To approve undertake final decision in matters concerning the acquisition/disposal of trust property both moveable and immovable:-
- x) To decentralize or delegate financial and other powers to the sub-committees of various office bearers.
- x ) To approve suggestions reading the amendments to the rules and regulations proposed.
- 9.7 The Board may constitute such sub- committees as may be deemed necessary for the efficient implementation of the programmers of the Trust.



## 10.0 Source of Income and Utilization :-

Provided there is no contravention of the rules and Regulations of the Central and the State Government.

## 11.0 Financial Year : April to March

## 12.0 Accounts of the Trust.

12.1 The Accounts of the Trust will be audited every year by the scullton Chartered Accountant approved / Retained by the Board on such terms /remuneration as the Board may decide.

13.0 Bank Accounts of the Trust shall be Jointly operated by any two of the trustees amongst the Chairman, Secretary, and Treasurer with the Chairman or an authorized by Board from time to time.

### 14.0 General:

- a) The Trust may collaborate with other recognized and well established organisations allied or akin to the objectives of the Trust.
- b) No office bearer has the power to sell, mortgage or in any other way transfer or dispose of any of the properties of the Trust, except as authorised by a resolution of the Board of Trustees, passed in a meeting specially convened for that purpose, with 3.4 th majority of the total trustees.
- The Board of trustees may form rules for the conduct of administration and articles of the Trust.
- d) The beneficiaries of the Trust shall be public in general without having regard to any caste, creed or community based on any religion.
  - c) All receipts in trust will be property of Trust.

(i) The activities of trust are capable of being extended/operated / conducted in whole of India and outside India.

g) For any matter of urgent nature a proposal may be circulated by the Chairman to the member of the trust and if approved by the

majority, it will be treated as passed in the meeting of the Board .

- h) The Trust may sue or be sued through the Chairman or Vice Chairman or any other person for and on behalf of the trust entrusted by board.
- The Chairman or Secretary of this trust shall be competent to sign, all the papers and documents concerning the central government, state government,

local authority and corporate body or bodies and such papers and documents shall

relating to the affairs of the trust.

- (j) The trust may enter into any agreement / contract , purchase/sale any movable or immovable assets in the name of the trust and the Chairman or Secretary of the trust shall be competent to sign on all the papers and documents to execute the above matters on behalf of the trust.
- k) For all other matters for which no provisions is made in this Deed, the necessary provision of Indian Trust Act. 1882, Act II of 1882 shall apply to the Trust.

## 15.0 ACCOUNTS / AUDITOR:

a. The Managing Committee shall keep proper books of account of the income and expenditure of the trust, which shall be closed every year on 31<sup>st</sup> March.

b. One external person or external auditing firm shall be appointed as Auditor/Auditors by the Governing Body of the Trust for the term of one year. The Auditor shall each year examine the annual financial records of the Trust and shall submit a written report to the Management Committee. The Management Committee shall present report to the Governing Body of the Trust at General Meeting for the purpose of information.

### 6.0 INVESTMENTS

#### 17.0 DISSOLUTION

a. The dissolution of the Trust shall be approved by the Governing Body of the Trust.

b. Upon the dissolution of the Trust, after the satisfaction of all the expenses incurred and accrued debts, liabilities and obligations, the balance of the assets of the Trust shall be distributed to such other institution or institutions having objectives similar to the objectives of the Trust, as determined by the sole discretion of the Governing Body of the Trust, provided that such distribution is consistent with distributions to organizations exempt from Income Tax under Section 11 of the LT. Act 1961 or any successor Sections, and the regulations there under, provided, however, that no part of the distributions shall inure to the benefit of any private organization, shareholder or individual, and shall not be inconsistent with Paragraph 3(j) hereof:

# 18.0 Matters not provided for in these Rules :-

The board of Trustees has full discretion to act in any manner not provided for in these Rules in the best interest of the trust. The Board of Trustees has the final

The Trustees shall be competent to make additions, alteration or extension to the objects, Rules and regulations of the Trust through special resolution passed by 3/4 th majority of the total members of the Trust in a meeting convened for the purpose. All amendments, additions, variations or extensions in the objects rules—and regulations of the Trust shall so far as possible be in conformity with the main objects of the Trust.
