That the settler does hereby direct and the Trustee do hereby declare that they shall hold and stand possessed of the said sum of Rs. 10,000/- (Rupees Ten Thousands) which are hereinafter for the sake of brevity referred to as the trust fund which expression shall also include cash and any other property and investments of any kind whatsoever into which the same or any part thereof might be converted, inverted or varies from time to time or such sum or property as may be acquired by the trustees or come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents upon the trust and with the subject to the powers, provisions, agreements and declarations hereinafter declared expressed and contained.

2. That Sri Chandrasekhar S/o Sri Shankar Ram, R/o Village & Post Kuruhua, City Varanasi (U.P.) shall be the Patron Trustee/ Managing Trustee and life time Chairman of the Trust; who may delegate his authority to any of the member of the Board of Trustee of the Trust by virtue of a "Registered Power of Attorney".
