In absence of such registered "Will and Testament" successor would be selected by the Board of Trustee amongst themselves followed by 2/3<sup>rd</sup> majority.

5. That the Patron trustee shall have power to second or casting vote in case upon a particular matter the Board is divided equally.

6. NAME : That the name of the Trust shall be "Indra Welfare Trust" (A TRUST FOR THE PURPOSE OF FACILITATING & PROVIDING ALL OF THE BEST MEDICAL AIDS & NURSING INCLUDING CLINICAL INVESTIGATION and for undertaking other related charitable and religious activities for the benefit the human kind) hereinafter for the sake of brevity referred to as the "Trust" and registered office shall be situated at present at Alkhari Bay-Pas Chauraha, Chunar Road, Varanasi with the power given to the Trustees to shift the same to any other place or places as and when it is found genuine in the interest of objects of the Trust in the state of Uter Pradesh and/or such other place or places as the Board of Trustee with the concurrence of Patron Trustee/Life Time Chairman herein may decide from time to time.

7. OBJECTS : That the objects for which the Trust is founded are:

- Publication of Journals and Books specially relating to recent inventions & innovations in the medical field and to educate the public or other similar works for the benefit of the public.
  - Establishment, conduct, maintenance of clinical laboratories, hospitals, nursing homes, dispensaries and institutions of similar nature and providing financial assistance to the deserving persons for medical treatment, in any medical institution.
  - Construction and running of Medical Schools, Medical colleges, Medical educational institutions, free dispensaries, Medical Centers, Hospitals for poor feeding and homes for the aged for the benefit of the public.
  - Providing for grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing medical education, vocational training, skill development etc.
  - Granting of financial assistance to any medical educational institution for granting scholarships, prizes, medals, awards for excellence in medical studies, sports and scientific research, distribution of books and note books for poor and deserving students.
  - Establishment, conduct, maintenance of old age homes, homes for physically handicapped men, women and children and persons with similar disabilities and also for granting financial assistance to institutions performing similar activities.

- (g) Grant of donation to any Temple, Mosque, Church, Guradwara and other places of worship and / or religious institutions. However, the Trust shall not undertake any religious activities.
- (h) Providing for or contributing to education and scientific research and development in medical field.
- (i) Providing relief to the poor and advancing any other object of general public utility.
- (j) The Trust will not carry out any activities with the intention of earning profit and will perform with service motive only.
- (k) To do all such things as are found incidental or conducive to the attainment of the above mentioned objects or any of them; and it is hereby declared that the interpretation of any of the aforesaid objects and in event of any ambiguity they shall be construed by the board of Trustee in such a way so as to widen and not to restrict the objects of the Trust.
- (l) For the removal of doubts it is hereby declared that this Trust, its objects and its implementation shall not be against the objects of the Trust as mentioned in above clause.

#### 8. TRUST:-

That the Board of Trustee shall be headed by Patron Trustee/ Managing Trustee and life time Chairman of the Trust and who shall hold and stand possessed of the Trust fund upon the Trust viz.

- (a) To manage the Trust fund and to collect and recover dividends, interest, rents, Profits, gains and income thereof
