




That the Patron trustee shall have power to second or casting vote in case upon a particular matter the Board is divided equally.

NAME : That the name of the Trust shall be "Indra Welfare Trust" (A TRUST FOR THE PURPOSE OF FACILITATING & PROVIDING ALL OF THE BEST MEDICAL AIDS & NURSING INCLUDING CLINICAL INVESTIGATION and for undertaking other related charitable and religious activities for the benefit the human kinds) hereinafter for the sake of brevity referred to at the "Trust" and registered office shall be situated at present at Akhari Bay-Pas Canarana, Chanar Road, Varanasi with the power given to the Trustees to shift the same to any other place or places as and when it is found genuine in the interest of objects of the Trust in the state of Utter Pradesh and/or such other place or places as the Board of Trustee with the concurrence of Patron Trustee/Life Time Chairman herein may decide from time to time.

(a) Publication of Journals and Books specially relating to recent inventions & innovations in the medical field and to educate the public or other similar works for the benefit of the public.





(d) Providing for grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing medical education, vocational training, skill development etc.



- (h) Providing for or contributing to education and scientific research and development in medical field.
- Providing relief to the poor and advancing any other object of general public utility.
- (j) The Trust will not carry out any activities with the intention of earning profit and will perform with service motive only.
- (k) To do all such things as are found incidental or conductive to the attainment of the above mentioned objects or any of them; and it is hereby declared that the interpretation of any of the aforesaid objects and in event of any ambiguity they shall be construed by the board of Trustee in such a way so as to widen and not to restrict the objects of the Trust.
- For the removal of doubts it is hereby declared that this Trust, its
 objects and its implementation shall not be against the objects of
 the Trust as mentioned in above clause.

8. TRUST:-

That the Board of Trustee shall be headed by Patron Trustee/ Managing Trustee and life time Chairman of the Trust and who shall hold and stand possessed of the Trust fund upon the **Trust** viz.

(a) To manage the Trust fund and to collect and recover dividends, interest, rents, Profits, gains and income thereof. —
