3. OBJECTS: The Objects for which the Trust is found are;

- a. To provide education (including computer education) to children of all communities irrespective of their race, religion caste or creed in general and to prepare them to become mature and responsible citizens of the country through all round physical intellectual academic moral and spiritual development based on values derived from the life.
- b. To establish takeover or manage, maintain and run Schools Colleges with an objective to provide sound pre-primary, primary, secondary, senior secondary, and higher education to children by seeking recognition and affiliation from the educational departments and concerned authorities.
- c. To establish run maintain or assist any educational social service centre industrial training centre or other institution for coaching guidance counseling or vocational training or to grant individual scholarship for poor, deserving and needy students for elementary and higher education.
- d. To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- e. To spread for promotion of education learning in all branches more specifically in science technology.
- f. To conduct research in education and other disciplines on the different subject relating to education.
- g. To open, found, establish, promote, set up, run, maintain, arrange finance, support and/or help or aid and help in life setting up the different kinds of technical, nontechnical schools, management college, medical colleges, nursing college and other establishment advancement of all kinds of education including vocational education center and knowledge.

h. To run maintain or assist any medical institution, nursing home or clinics or to grant assistance to needy and indigent persons for meeting the cost of medical treatment. The trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Author of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

4. NUMBER OF TRUSTEES:

The number of Trustees including the Author of the Trustees shall not be less than 2 and not more than 7 persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:

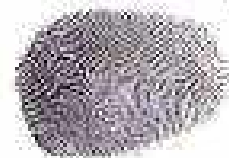
These Trustees shall hold office for such duration as may be specified by the board of trustees, any graduate at any discipline from recognized university.

11. QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be 2 numbers quorum is required for a meeting adjourning for want of Quorum.

A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute and shall be signed by the President of the Meeting.

12. VOTING:

The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. 14. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

- (a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- (b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:
- (i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
- (ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- (iii) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- (iv) (a) To raise loans, to receive money, securities or other movable property on behalf of the Trust.
(b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- (v) To award scholarship and make donations calculated to promote the objects of the Trust.
- (vi) (a) To enter into contracts, or engagements on behalf of the Trust.
(b) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- (vii) To appoint Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.

- (viii) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- (ix) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- (x) To frame Bye-Laws and such other regulations as are required for achieving its objectives.
- (xi) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely:
- All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
 - The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
 - The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
 - The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
 - Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
 - Cost and expenses of keeping the trust property in good condition.
 - Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.

- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.

After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

15. ROLES, RESPONSIBILITIES AND POWERS

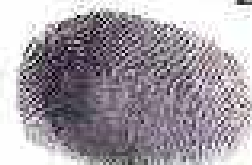
The Roles, Responsibilities and powers of all these officers is defined below. In addition to these, The Managing Trustee may grant additional roles, responsibilities and powers.

a) MANAGING TRUSTEE:

In addition to discharging normal duties of a trustee, the Managing Trustee shall preside over meeting of the Board of Trustees. The Managing trustee is authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government Institutions and other organizations, on behalf of the Board of Trustees. The Managing Trustee shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents.

1. The Managing Trustee is authorized to sign along with the Treasurer bank cheques, Deposit release vouchers etc. The Managing Trustee is empowered to remove any Trustee from the Trust and its offices, if he/she finds that his/her activities are not congenial to the activities of the Trust.

f) **TREASURER:**

The Treasurer will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

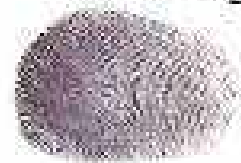
18. ACCOUNTS:
