The Sansthan has following aims & objectives:-

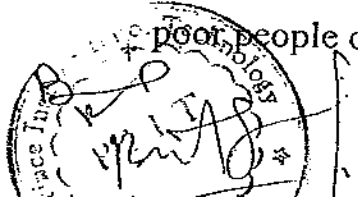
- (i) To act as a catalyst in projecting the students and people of India who shall Act as agents of change in the society.

- (iv) To help the Disabled Children, Widows, Widows Children and Needy poor people of India in the field of all level of education.

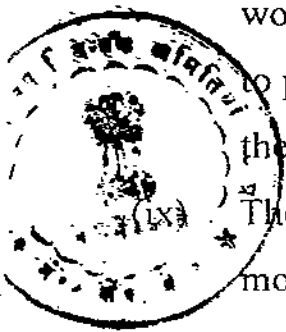
