The trustees in their meeting called for this purpose with at least fifteen days notice may adopt resolution for the amendments in the byelaws of trust with two their majority of the total numbers of trustees either present in person or by consent in writing or by both.

### 19. WINDING UP

The trust may terminate its activities if board of trustees deem it necessary in their meeting called and held off the purpose by giving at last twenty-one days notice and passing a resolution by at least three fourth majority of the total numbers of trustees either present in person or by consent in writing by both and may wind up its affairs.

On its winding up no part of the trust property shall be distributed amongst the trustees donors or their relatives and all the properties of the trust shall be handed over to a trust society institution or organization having or the present trust may amalgamate with some other trust having charitable objects for benefit of public at large all the assets and liabilities of the present trust will pass on to the successor trust society institution or organization.



Represent the trust together with all conditions and accretions thereto and all

2. MAIN OBJECTS:

- (A) To establish, run, supervise co-ordinate, affiliate, guide, aid in India or anywhere else the Engineering Colleges, Technical Education Institutes, Management Education Institute, Teacher Training Institutes, Pharmacy Education Institutes, Fashion Technology Institutes, Hotel Management Institutes, Medical Colleges, old age home, Institutions, schools, colleges, universities, academic, laboratories, exhibition centers etc.
- (B) To grant stipends, scholarship, studentships and other allowance, concessions or gratuities to deserving and/or financially poor students and candidates and to be send them anywhere in India or abroad for studies/advance studies.
- (C) To provide monetary help to poor person including help in case of illness in the family or otherwise rendering free medical aid to poor persons.
- (D) To organize various activities in the field of medical care medical research health education training of medical care and health personnel.
- (E) To take various steps and establish centers as necessary with a view to arresting the population growth and undertake various family planning and welfare activates with special reference to mother child care.
- (F) To inculcate awareness so as avoid pollution of the water, land and air.

- (M) To encourage and assist the rural people to carry on activities in connection with the development of village industries and other rural activities connected with or in any way incidental to such industries; to set up academic and other industries with the approval of the competent authority, all over India.
- (N) To organize cultural programmes, seminars, symposium, group discussion, exhibition etc. for the furtherance of the objective mentioned herein above charitable organization having similar aims and objectives.
- (O) To undertake Educational, Legal, environmental, agricultural and gross root level innovations in the field of agriculture and animal to initiate and encourage husbandry and to involve in alternative nature / Eco-farming and which will lead to sustainable development, and to take tree plantation programmes.
- (P) To create awareness about various social issues like child labour, bonded labour, alcoholism, mental health issues, disability, domestic violence, human rights violation, poverty, health and hygiene, unemployment, begging, trafficking, HIV / AIDS and all other issues affecting people's harmonious living.

### 3. ANCILLIARY OBJECTS:

To solicit, abstain or accept offerings, subscriptions, donations, grants, gifts, devices and requests from Settlor or any person, firm, company corporation, society or institution in India or abroad interested in any of objects of the Trust either in cash, security, investments etc. or in the form of, any moveable and immovable property towards the corpus of the trust or towards its activities or work.
- (A) To corporate, collaborate and enter into such agreements with Trusts, Societies, Company, Corporations, Firms, and Association, Institutions and any other bodies whether national or international, that may help in the pursuance of all or any of the trust objects.
- (B) To acquire by gift purchases exchange, lease, on hire or otherwise howsoever, any lands, buildings, apartments, rights of common play grounds parks and property moveable or immovable and any estate or interest, for the furtherance of all or any of the
- (C) To build construct and maintain buildings, hostels, houses, other buildings or any other immovable property belonging to or held by the trust and alter, extend, improve repair, enlarge or modify the same including any existing buildings and to provide and equip same with light, water, drainage, furniture, fittings, instruments, apparatus and appliances and all other necessities for the use of

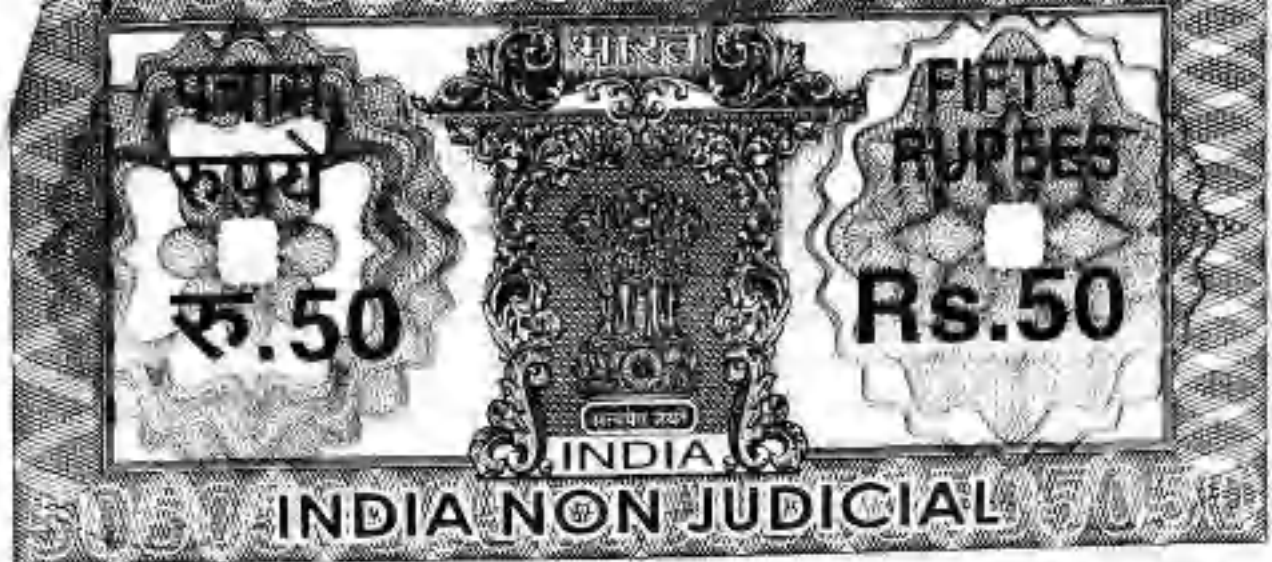

- (D) To sell, mortgage, let, lease, exchange, gift, and otherwise transfer or dispose of or Deal with all or any property movable or immovable, of the trust for the furtherance of the objects of the trust
- (E) To give remuneration, pension or gratuities to teachers, Staff and other employees and to make payments towards insurance and to form and contribute to provident and other funds for the benefit of the person employed by the trust.
- (F) To borrow and raise money without security or on the security of mortgage, charge or hypothecation or pledge over all or any of the immovable or movable properties belonging to the trust or in any other manner whatsoever from any bank, financial institution, corporate body or any other person of the furtherance of the objects of the trust. To pay out of the funds belonging to the Trust or out of any particular part of the such funds all types of loans borrowed, all expenses of or incidental to the formation of the Trust and towards management and administration of any of the foregoing objects and activities including all rents, rates, taxes, outgoing and the salaries of the employees etc.
- (G) To invest and deal with any money of the Trust not immediately required for any of its objects in such manners as may be thought fit and proper by the trustees from time to time, and allowable under law.
- (H) To raise funds to support the aforementioned Trust objects from within India and abroad
- (I) To appoint Bankers and to draw, accept, endorse and discount cheque, notes or other negotiable instruments;
- (J) To undertake and accept the management of any endowment, or trust fund or donation;
- (K) To join corporate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their directions think fit, particularly having similar nature & objects;
- (L) To take over or amalgamate with any other charitable trust, society or institution with similar objects.
- (M) To do all non-political, legal and peaceful acts and undertake other activities which may help to promote the objects of the trust and are incidental and conducive to the attainment of any of the

- (N) To take-up environmental education programs for children, Students, youth, women, NGOs and so on and to undertake nurseries and tree plantation programme in order to safeguard the Natural resources.

#### 4. THE TRUSTEES:

The Trustees shall consist of the following categories of Trustees:

- i. **Founder Trustee:** As mentioned herein before in the trust deed the trustees so mentioned will be the founder trustees. The founder trustees of the trust shall be the life trustee of the trust and after death of any founder trustee, legal heirs shall be the life time trustee of the trust.

The founder trustees can assign their trusteeship to others, however, such re-appointment will only be with the consent of majority of remaining trustees. Provided further that the Founder trustees shall have life term and shall not be liable for retirement or removal from the Trust till he voluntarily retire or become legally incompetent to be a trustee and after the death of any founder trustee, Board of Trustee (BOT) shall have power to fill the vacancy caused by the death of the founder member by majority of vote. The founder trustee will have right to attend participate and vote in Annual General Meeting of Board of Trustee.

- ii. **Nominated Trustees:** Founder Trustee if deem it fit in the best interest of the Trust may appoint nominated representatives of certain like-minded public and charitable institutions.

The Founder members will designate the institution as well as number of person that the designated institution may send to be trustee of that trust. This trustee will be called as nominated trustee and will cease to be trustee of that trust if the designated institution takes their name back and if founder members found him engaged in work that is against the interest and objects of the Trust. The Founder Trustee at any point of time may withdraw the designation so granted to any institution. The nominated trustees will not be eligible to attend the Annual General Meeting of Board of Trustees.

- iii. **Trustee Patron:** The founder trustees keeping in mind the best interest of trust will elect patron trustees. The Trustee patron will not be eligible to attend the Annual General Meeting of Board of Trustees.

- iv. **Trustee Scholar.** The Scholar trustees will also be elected by the founder members. The scholar trustees can be those people who are eminent personalities in their own field or who have provided valuable services to the community or the nation. The intention for such appointment is to give honour to these personalities as well to get the privilege of their association to the trust. Founder trustees can define the tenure of such trustees. The Trustee Scholar will not be eligible to attend the Annual General Meeting of Board of Trustees.
- v. Any person shall cease to be a trustee if (i) he without leave of absence does not attend five consecutive meetings of the Trust or remain out of meetings consecutively for five months whichever is longer if (ii) He is requested to, resign by at least 75 percent of trustees of the Trust. This clause will however not be applicable on Founder Trustees.
- vi. Any trustee being an Engineer, Doctor, Lawyer, Chartered Accountant, Scientist, Lawyer, researcher or other person engaged in any profession or business shall be entitled to be paid all the usual professional fees etc. for time expended, business transacted and act done by him or any of his partners (including act which a trustee not being in any profession or business could have done personally) in spite of the fact that he shall be a trustee of these presents.

5. **BOARD OF TRUSTEES:**

- i. The Board of Trustees will be highest authority to govern, control and manage the whole of affairs of the trust as well as properties of the trust and to take important decision in respect of running and even closure of the trust. All the trustees as eligible will collectively form the "Board of Trustees".

For better administration and management and for smooth running of operation of the trust, the board of trustees shall elect out of themselves the "Governing body" who will look after the affairs of trust. Moreover, if the board of trustees may think it proper, people other than trustee can also be inducted in governing body. These appointments will be by the majority decision, in general meeting of board of trustees. And the trustees and people appointed will hold their respective post till the conclusion of the next immediate annual general meeting of the board of trustees.

The Founder trustee will not be increased from Three as mentioned in this deed above. If it is increased it

## 6. ANNUAL GENERAL MEETING / AGM OF THE BOARD OF TRUSTEES:

- i. A meeting of the board of trustees may be held on the written requisition of any one or more of the trustees, for the time being otherwise the ordinary meeting of Board of Trustees will be held once in a year or otherwise think fit by 'Governing Body'.
- ii. A meeting of the Board of trustees shall be convened on seven clear days notice but an emergent meeting may, however, be convened on a shorter notice by the managing trustee by the consent of all the trustees for the time being.
- iii. Quorum of a meeting of the board of trustees shall be more than one half of the number of the eligible trustees. In the absence of the quorum the meeting shall be adjourned for some other date. The Quorum of any adjourned meeting shall be member present.
- iv. Resolution of the board of trustees shall be passed by acceptance of all the trustee of the trust.
- v. Minutes of each meeting of the board of trustees shall be kept, shall be recorded in the book mentioned for the purpose and shall be signed by the chairperson of the subsequent meeting.
- vi. The board of trustees will transact the following ordinary business during the annual general meeting:
  - (a) To nominate a governing body from different categories of the trustees or outside people, however as the scope, responsibilities and administrative work of the trust increase, the founder trustees as per the requirement may increase the strength of governing body. The constitution of the governing body as enlarged by the founder trustees would be as under:
    - (i) All founder trustees who shall have life term.
    - (ii) Nominated trustees (if any as may be proposed by the designated institution).
    - (iii) Remaining member of the governing body as may be decided by founder trustees, shall be elected from amongst other categories of trustees or from outside as well.To adopt the audited annual accounts and progress report.
  - (b) To appoint auditors for the year and to decide their remuneration.
  - (c) To consider and decide on any resolution which may be submitted to and recommended by the governing body.

(d) Any other business with the permission of the chairman presiding its meeting.

vii. The duration of the two annual meeting shall not in any case exceed 15 months.

viii. An extra ordinary meeting of board of trustees can be called on the written requisition of any of the founder trustees or on the instance of governing body if it seems necessary in their opinion. The other rules and formalities to call extra ordinary general meeting of board of trustees shall be the same in the case of other meeting as discussed above.

ix. That the trustee may decide any matter by circulation without meeting being held but resolution be passed by circulation without meeting being held if it is evidenced in writing under the hands of 2/3<sup>rd</sup> trustees of the trust and must be passed by the trustees in the next meeting held.

In the absence of quorum, the meeting shall be adjourned for some other date. The quorum of any adjourned general meeting shall be members present.

#### 7. POWERS

The Founder trustees shall have the following powers and in ordinary course will confer all the powers to governing body to handle the affairs of the trust, smoothly and effectively.

(a) To accept donation, contribution, grants, subscriptions in cash or in kind from any person, company, firm, association, association of person, GUF or family trust or trusts or corporate body, from govt. or cooperative society for the furtherance of the objects of the trust.

(b) To manage the properties and other assets of the trust and to do all such acts necessary for the preservation, maintenance and management of the trust and the trust properties.

(c) To sell or give on rent or on hire or less any immovable or moveable property of the trust for such period or periods on such terms and conditions as the trustees may think fit and proper.

(d) To invest trust funds or properties whether representing the corpus or income in such investment as the trustees shall think fit and proper in pursuance to the provision of income tax act.

(e) To borrow or raise loan (with or without securities) on such terms, such security and rate of interest etc. as the board determine and decide, for carrying out the objects of the trust from any bank, financial institution corporate body or any other person.

(f) To let out, lease sub-lease, mortgage, demise and otherwise deal with any immovable property belonging to the trust as per their absolute discretion.

- (g) The trustees may hold any of the properties of the trust for and on behalf of the trust in the name of anyone or more of them, as may be decided by the board of trustees from time to time.
- (h) It is expressly provided that the trustees may by an unanimous resolution, register a charitable society or trust under the societies registration act or any other relevant act with the object of the trust in which all or any of the assets and on income of the trust may be transferred and resolution where of shall be in conformity with the provision of this trust with such modification as may be agreed to by the trustees.
- (i) To open type of bank accounts, whether, current, fixed, saving loan, overdraft or otherwise in the name of the trust with any bank or banks and to operate the same jointly or severally or otherwise by appointing any authorized signatory or gent as the board or trustee at their discretion shall think fit and proper unless and until determined otherwise the bank account shall be opened jointly with the signatures of any two founder
- (j) That the trustees are authorized to give guarantees of the assets and property of the trust including the bank guarantee and security to the corporate bodies, person(s), firms, institution(s) and trust as they may have deemed fit time to time. The trustee shall not be personally liable for such guarantees or security otherwise then for their wilful negligence.
- (k) To adjust, settle compromise, refer to arbitration all action, suits, claims, demands and proceeding regarding the trust funds or any matter arising in connection with the management of the trust.
- (l) To amalgamate this trust and its properties with any other trust, society or charitable institution having objects and purposes similar to those of this trust as the trustees for the time being in the offices shall deem fit and proper.
- (m) To sell, gift, lease and transfer the immovable properties of the trust hereby created and all money received by such sale shall form part of the trust fund and shall be applied as the board of trustees may deem think fit.
- (n) To appoint lawyers, pleaders, advocates, to file and defend suits, filed for and against the trust and for in the name of trustees and also file suits for the realization of the rents and money(s) and other dues with the different parties and sign execute such applications, petitions, documents or such proceedings and delegate such powers or powers to employees staff and trustees for such proceedings



The trustee shall be respectively chargeable only for such money funds securities and other assets of the trust, as they shall actually receive notwithstanding their signing any receipt for the sake of conformity and shall be answerable and accountable only for their own respective assets, receipts neglects and wilful defaults and not for those of each other not for those of any bankers brokers or other person in whose hands any trust money or assets may be placed deposited or come not for the deficiency or insufficiency of any funds and security not for any other loss unless the same shall happen due to or through their or his her own wilful default or dishonesty respectively and in particular no trustee shall be bound to take any steps or proceedings against a co-trustee for any breach or alleged breach of trust committed by a co-trustee.

Where the trustee in the purported exercise of the trust discretion and owners hereby or by law conferred, act on the advice of any counsel, solicitor or other lawyer, engineer, surveyor or land or estate agent, broker, cashier, accountant or expert the trustee shall not be responsible for any loss that may result from acting on such advice but the act or omission shall be deemed to be authorized and proper and the advice shall operate to protect the trustees in the like manner as if the act or commission had been directed authorized under an order of court of competent jurisdiction.

## 9. GOVERNING BODY

To manage and control the affairs of the trust, there shall be a Governing Body. The Member of the


#### 11. MEETING OF THE GOVERNING BODY:


#### 12. FUNCTIONS OF THE GOVERNING BODY MEETING:

(1) To act as the supreme and final authority for all purposes and objectives of the trust.

### 13. FUNDS OF THE SOCIETY:

The funds of the society will be kept in a scheduled/Nationalised/Co-Operative bank decided by the governing body. The accounts shall be operated by any two founder trustee.

### 14. RULES AND REGULATION:

The rules and regulation will be framed by the governing body as per the direction given by board of trustees.

The governing body may delegate or withdraw the powers of various office bearers of the governing body from and dissolve various committees, sub-committees for the smooth working of the trust.
