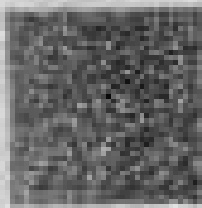

TRUST DEED

THIS DEED OF TRUST made on the 09th day of April 2022 by Sri. Sangeet Kumar Son Awasthi Prasad Shukla Son KCJIC Son P. C. Banerjee Head Manager Praying-211002 and Sri. Sangeet Devi Son Jagan Kumar Banerjee Son P. C. Banerjee Head Manager Praying-211002 hereinafter called the Author of the Trust which expresses their intention in the united or common mind and intention that they, donors and administrators, do, whereas Authors of the Trust are possessed of and referable and are sufficiently entitled to the sum of Rs. 20000 (Rupees Twenty Thousand only) hereinafter referred to as said property, Whence the Authors of the Trust desire to irrevocably employing the said funds everlast for public educational and cultural purposes as hereinafter expressed and intended in this present deed in pursuance of such funds have already transferred and handed over the said amount to the trustees mentioned below.

WHEREAS it is the desire of the Authors of the Trust that the Corpus of the Trust may be further augmented hereafter to wit by gift of funds and other assets including movable and immovable and any other kind by way of Gifts, or Donations, acquisition, donations, grant, exchange or otherwise.

WHEREAS the following persons are appointed by the donors for holding the said property in Trust for the purposes mentioned in this Trust Deed.

1. Sri. Sangeet Devi

NOW THIS DEED OF TRUST SET FORTH AS FOLLOWS:

- 1. **NAME:** The Trust hereby constituted shall be named as "MAA DULHAN'S TRUST"
- 2. **PLACE:** Office of the Trust shall be situated at 411101 Son P. C. Banerjee Head Manager Praying-211002 or at such other place in India as the Trustee may determine from time to time.
- 3. **OBJECTS:** The objects for which the Trust is constituted are:
 - (i) To establish, maintain and run Schools, Colleges, Grant under names Industrial Organizations.
 - (ii) To establish Training Centre, and other educational institutions.
 - (iii) To establish Cultural and Recreational centres.
 - (iv) To spread the progress of education and learning in all branches even specifically in Science and Technology.
 - (v) To advance Indian Culture and Literature, Service of the Country for the benefit of the Nation.
 - (vi) To train teachers and workers in which and progress of the ever growth of the industry and learning.

- (g) To conduct research and training courses for the betterment of education/teaching in its various fields/branches.
- (h) To undertake propaganda, training and education of the masses either on its own or in cooperation with similar agencies working for the cause of all round development of the Society.
- (i) To bring, publish and sell, distribute books, periodicals, bulletins, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- (j) To sponsor and finance researches and scientific projects for advancing and widening.
- (k) To advance any other objects of general public utility.
- (l) To create and use various facilities in the field of science, education, literature etc.
- (m) To conduct the colleges or other institutions in the area of higher education specially for women; and for the promotion, the welfare, and the education.

The trust shall be an accounting public educational institution run for the benefit of all persons belonging to various professions/occupations of Chauri Chaudhary Region. The Trustee shall avoid production of the trust income or surplus realized by the institution/department and will other purposes than economic and educational to any to be applied from time to time by the Trust for various including grant, donation, subscription, endowment, donation, contribution or in any manner or whatsoever of which shall be disposed in Trust properties on the Trust Informational.

D. NUMBER OF TRUSTEES:

The number of Trustees including the trustee of the Trustee shall not be less than Two and not more than 20 persons. The Board of Trustees shall nominate and elect successors to be the other trustees to be provided, in they are short of members.

E. TERM OF OFFICE OF THE TRUSTEES:

These Trustees shall hold office for such duration as they be specified by the Board of Trustees.

F. PRESIDENT:

There shall be a president for the administration of this trust, nominated by the Board of Trustees, who shall be any amongst trustees as specified in para (D) above for such period as such trustee or may be specified in the trust.



7. **MANAGEMENT TRUSTEE:**

(i) The liability and discharge of the Trustee shall be governed by the terms of the Managing Trustee's deed for the time being in force and the provisions of the Trust Deed in force.

(ii) The Board of Trustees of the Trustee shall be equally liable and responsible for the discharge of the Trustee's duties and the discharge of the Trustee's duties shall be governed by the provisions of the Trust Deed.

8. The Managing Trustee shall be entitled to receive, as remuneration, such fee as may be specified in the deed for the time being in force for the Board of Trustees.

- (110) To attend such repairs and such loads of the trees and to carry the provisions as and when a tree shall naturally or proper provided that such provisions shall be made with equal systematic propriety in equal situations as the board of trustees may deem fit under section 21 of the Indian Trust Act, 1882.
- (111) To call for and or otherwise obtain of any necessary property of financial particulars of the trustee statements worked that it is in the interest of the trust to do so in all or part, regarding or otherwise disposal of any movable and immovable properties of the Trust.
- (112) To appoint a Chartered Accountant of management for such term and with such powers as may be specified from time to time, for carrying out the trustee management of the affairs of the Trust.
- (113) To appoint such employees or such term and conditions as the Trustees may deem fit for carrying out the work of the trust and remove or suspend all such employees including the power of suspension, dismissal and re-appoint.
- (114) To delegate to the Managing Trustee or any authorized committee such powers, duties and functions as are vested in the Trustees.
- (115) To frame bye-laws and such other regulations as are required for carrying on the affairs.
- (116) One of the members of the trust proposed by trustee shall be entitled to attend or act as the following employees namely:-

- (a) All taxes, rates, dues, assessments, fees and levies if any payable to the government or any authority or other public bodies or request thereof or any part thereof.
- (b) The provision for the maintenance of the buildings or any other movable property forming or considered to be the trust being forming part of the trust property.
- (c) The cost of ordinary repairs and for providing any amenities to the buildings for the trust being forming part of the trust property.
- (d) The cost of making such additions alterations or improvements to or in the buildings forming part of the trust property as the trustee shall think fit.
- (e) Wages and salaries of any manager, supervisor, assistant clerk, servant or other employees employed by the trustee in the carrying out of the trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Fuel and expenses for heating and warming the electrical and other installations in the building for the trust being forming part of the trust property.
- (h) The salaries to the and legal charges and for providing to other professionals engaged in the course of administration of the trust.
- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes herein or which may be hereinafter.



Also including the costs charges and expenses incurred by the trustee in obtaining out of the trust, gross income received by them from the trust property the balance that is the net income will be subject to the claims of the trust as directed by the Board of Trustees.

16. BANK ACCOUNT:

- (i) The Board of Trustees may open such Bank Accounts or Accounts in any of the banks in the name of **NEHA DEWANI DEWA TRUST**. Such accounts shall be jointly operated by the Author of the Trust.
- (ii) The trust may open Bank Accounts in the name of any other organization created by the Trust. Such Bank Accounts shall be operated by such persons as authorized by the Board of Trustees from time to time.

17. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the Trust shall be applied only for the purposes of the Trust and for the due administration of its business affairs and purposes provided however that they shall not preclude payment of any maintenance or allowance or giving of residential accommodations or any property or any other benefit in connection with the work carried out by trustees for the purposes of the Trust.

18. ACCOUNTS:

The Trustees shall maintain a true and correct record of the receipts payments interests and expenses and transactions of the Trust. The books or accounts of the trust shall be audited by a qualified auditor or a Chartered Accountant every year or more frequently if need be on the 31st March of each year.

19. DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

20. AMENDMENTS:

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Sections 13, 14, 15 and 17 and 18 of the Trusts Act, 1951 as amended. Nothing to this effect.

21. DISSOLUTION:

In the event of dissolution or winding up of the Trust the assets of the trust remaining on the date of dissolution shall under no circumstances be distributed among the Trustees, but the same shall be applied to other Trust, Society, Association or Institution whose objects are similar to those of the Trust.

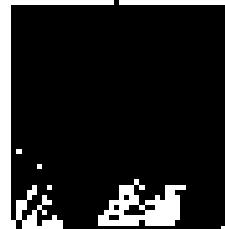

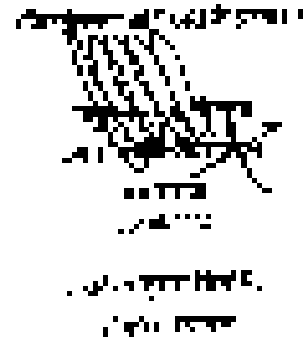

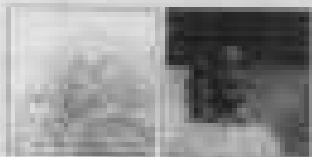
