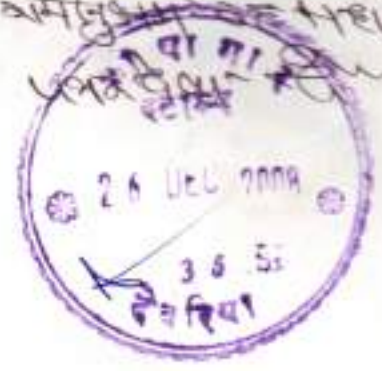

4. AIMS AND OBJECTS

- (i) To render services in the field of education by establishing and operating schools and educational institutions irrespective of any reservation for any caste, creed, religion or language.
- (ii) To establish and run educational institutions to promote student mental, social and moral upliftment.
- (iii) To promote such educational activities as may result in mental and/ or physical well being of the members of the society in general.
- (iv) To acquire, consent and maintain hostels / buildings for providing temporary accommodation and fooding to persons for the purpose of persons studying in such aforesaid school and educational institution.

Trust and for this purpose, the Trustee may secure repayment of these loans in any manner, as may be decided from time to time.

(viii) The Trustee shall be entitled and be at liberty to accept gifts voluntary contribution from any person firm or institutions or government and to collect subscription, donation or aid from State Government, Central Government to augment the Trust-fund and use such money for the objects of the Trust.

(ix) To do all necessary acts for incidental or conducive for the attainment of above objectives of the Trust.

TRUST PROPERTY

The settler hereby vests finally and irrevocably a sum of Rs. 5.000 from his own funds.

BOARD OF TRUSTEES

(a) The administration, management and control of the Trust and its properties shall vest in the hands of a committee to be called the Board of Trustee, consisting of following persons for the time being:-

(b) The Trustees shall hold office during their life unless any of them desires to be discharged of his duties or becomes mentally or physically incapable or working or is declared insolvent or is convicted or a criminal offence.

(c) In the event of vacancy arising in the Board of Trustees from whatsoever reason, the remaining Trustees shall co-opt another person to fill-up the vacancy who may be member of the family of the said trustee temporary likely to be permanent often the period of two year. Temporary trustees will not have any power to vote.

(d) The number of Trustees shall never be less than three and more than eleven.

(e) The Trustees shall work in honorary capacity, but they shall be entitled for reimbursement of expenses incurred by them in the conduct of their duties or in promotion of the objects of the Trust or on behalf of the Trust.

No Trustee shall be entitled to take loan from the Trust or to take any advantage for himself or any member of his family in whatever form or manner from the Trust.

(f) If a Trustee who by his conduct as a Trustee or in his personal life, adversely reflects on the reputation of the Trust may be asked by the Board of Trustees by a resolution passed by a majority to submit his resignation, failing which he shall cease to be a Trustee with effect from the date of passing of such resolution.

(a) If a Trustee who by his conduct as a Trustee or in his personal life adversely reflects on the reputation of the Trust may be removed by the Board of Trustees by a resolution passed by a majority to submit his resignation, failing which he shall cease to be a Trustee with effect from the date of passing of such resolution.

(b) The number of Trustees shall never be less than three and more than eleven.

(c) Temporary trustees will not have any power to vote.

- (g) The Trustee may institute, conduct defend, compound or abandon any legal procedure by or against the Trust or Trustees and allow time indulgence for payment or satisfaction of any debt or passing of such resolution.
- (h) The Trustees of the Trust may obtain payment of money from all Courts and Departments of the State and Central Government including local authority or authorities.
- (i) The Trustee may purchase, construct, alter, lease rent partly or fully immovable or movable property from time to time. They shall have a power to sell movable or immovable property of the Trust by passing of resolution by two third of the majority in the best interest of the Trust as when necessary and to use these proceeds for the objects of the trust only.
- (j) The Trustee may authorize any of the Trustee to appear before the Registrar or sub Registrar of any other officials appointed for registration of deeds, document and other instruments and to execute, present, admit and resister or cause to be registered any deed, document etc. in which the Trust is interested or involved.
- (k) The Trust shall be empowered to employ time or part time employees or professional on retainer ship basis according to the requirement of various institutions time to time. The Trustees shall have power to accept honorary services of any person volunteering to do the work in the Trust or in the charitable institutions run by the Trust. The Trustees shall have full disciplinary control and powers for such staff, employees workers honorary of otherwise.

(1) The Trustees with 2/3rd majority can add or amend or make any by-laws or the clause of the trust and needed from time to time for smooth functioning of the trust. The aforesaid sum or Rs. 5.000 will be initial fund of the Trust. Any further sums received in form of money or money's worth by way of donation gifts and grants or acquired by any other mode by the Trust, will be property of the Trust. The property of the Trust shall vest in the Trustee only.

MEATINESS

1. The Trustee may meet together as and when they may thin necessary, but they shall hold at least two meetings in a year.
2. The quorum at a meeting of the Trustee shall be of two, when the strength to the Trustees is three. The quorum shall be three if the strength is more than three.
3. Ajeet Kumar Singh shall be the First Director / Security of the Trust. Further he has nominated his wife Rajendra Singh the nest Chairman after his retirement or death and then Smt. shall takeover as chairman after the retirement of death and of similarly further nominate any member to takeover as Chairman after they take charge. In the absence of all the above persons, the Trustees shall act according to the decisions of the majority of the Trustees. When the trustees are not unanimous the Chairman shall have the casting vote in case of tie.
4. There will be no need of a quorum for adjourned meeting wherein agenda of last meeting will be discussed or decided.
