- 31- **TRUST PROPERTY:** The settlor vests finally and irrevocably a sum of Rs 11,000/- (Rupees Eleven Thousand Only) from his own fund. The aforesaid sum of Rs 11,000/- (Rupees Eleven Thousand Only) will be the initial fund called corpus of the Trust. Any further sum received in form of money or money's worth by way of donation, gift, grants or acquired by any other mode by the Trust, will be property of the Trust.

4- **AIMS AND OBJECTS :**

1. To render service in the field of education by establishing and operating schools, Engineering Colleges, Medical colleges, Law colleges, Management colleges, Nursing and Para-medical colleges, Science & Arts Colleges of any level and other vocational and educational institutions and research institute with maintaining affiliation, undertaking, approval or grant aid in cash or kind to hospital, medical institutions, child welfare, widow homes, old age homes and/or and similar charitable institutions for benefit and use of General Public.
2. To establish and run educational institutes to impart technical education and to promote cultural and artistic subjects/works like drawing, painting, music show, dramatic performance and dances reflecting/evolving Indian cultures/traditions.
3. To promote such educational activities as any result in mental and/or physical well being of the members of the society in general.
4. To acquire, construct, maintain Buildings and Hostels for providing temporary accommodation and food to persons studying in aforesaid schools and educational institutions.
5. To set up laboratories, purchase and acquire equipment and instrument required for carrying out research activities in any field such as science, medical, arts, social etc. in aforesaid school/colleges and educational institutions.
6. To grant stipend, scholarships or any other assistance or otherwise to deserving students or scholars, to further continue the course of study and/or research.
7. To render services in the field of education irrespective of any reservation for any caste, creed, race, religion or language.

- 8. To preserve and uphold ancient Indian Vedic Culture and Bhakti Practices through Discussion Cultural Programmes, Book Publication, Audio, Video and other Electronic Media.
- 9. Any other activity which promote/s uplifts the moral values and ethics in the society.

**5.- BOARD OF TRUSTEES:-**

- All Trustees collectively shall be called the Board of Trustees. On important issues like appointment of new Trustees or making substantial alterations to any of the provision of the Trust Deed or otherwise the Board of Trustees shall act through a resolution which shall be passed by the 2/3<sup>rd</sup> majority in a meeting of the Board of Trustees having a proper quorum. At the same time this should be very clear that for all above proceedings the final decision will be given by Chairman and Secretary only, means appointment of new Trustee or making substantial alterations to any provision of the Trust Deed or otherwise will be performed by Chairman and Secretary (Governing Body).

5.1:- The Trustees of the Trust who have accepted to be the Trustees shall be as below:-

The above Trustees are at par in all respects shall be known as Trustees collectively. In case a Trustee is expired or not fit to work as Trustee or non cooperative to operate the objects of Trust will be removed from the Trust by Governing Body, the heir of all Trustees will be finalized by Governing Body only. The heir of Chairman and Secretary will be their eldest son or otherwise any Person nominated by Chairman and/or Secretary by their will or desire.

**5.2:- GOVERNING BODY:-**

- The Board of Trustee shall select the Governing Body of the Trust. It shall consist of two Trustees having the designation as Chairman, and Secretary. The members of the Governing Body shall hold the office for five year term. After each five years term the board of trustee will select new members for Governing Body, but the consent of founder Chairman & founder Secretary will be must & compulsory for final selection of Governing Body, without their consensus the selection of Governing Body will be illegal.

The Governing Body shall have sole right to manage the Trust. It shall be responsible for the property, built it, dispose it, lease it, finalize the accounts, manage all day to day affairs and take decisions as may be necessary for smooth functioning of the Trust.

The Governing Body will take policy decisions. The Governing Body can make rules for day to day working and delegate to its member/members as may be necessary. The Governing Body shall fix the power and responsibilities of its member from time to time. All decisions in Governing Body shall be taken by majority. All the rights of the Governing Body shall be executed by the secretary.

Because of substantial contribution Ram Antar Singh will be first Chairman(founder Chairman) at the Governing Body and Anoop Singh will be the First Secretary(founder Secretary) at Governing Body.

For the removal of doubt it is hereby cleared that the term Governing Body also means managing committee.

5.3:- The Trustees shall hold office during their life unless any one of them desires to discharge of his duties or become mentally or physically incapable of working or is declared insolvent. In such case the nominee of the Trustee shall take his place. However any Trustee can be removed from the board if he is found non-cooperative in the smooth running of Trust or any other sufficient reason by 2/3<sup>rd</sup> majority of the Board of Trust, but removal will be finalized with the consent of Governing Body, means Governing Body must be present in that important meeting.

5.4:- The number of Trustee shall be decided by the board, by consensus which can be increased.

5.5:- The member of the Governing Body shall not be entitled for the remuneration and other Trustee rendering professional services shall also not be eligible for remuneration but they shall be entitled for the re-imbursment of expenses incurred by them in conduct of their duties and to attend the meetings.

5.6:- The Secretary at the Governing body of the Trust may institute, conduct, defend, compound or abandon any legal procedure by or against the Trust. They can allow time& indulgence for payment or satisfaction of any debt or passing of such resolution.

5.7:- The Secretary at the Governing Body of the Trust may obtain and acknowledge payment from any court, and department of the state and central Government including local authority authorities.

- 5.8)- The Secretary at the Governing Body may purchase, construct, offer lease, and rent, partly or fully immovable or movable property from time to time. He will have power to sell movable or immovable property of the Trust by passing of resolution by 2/3<sup>rd</sup> of the majority in the best interest of the Trust only.
- 5.9)- The Secretary himself will appear before the registrar or any other official appointment for registration of deeds, document and other instruments and to execute, present, admit and register or cause to be registered and deed, document etc. in which the trust is interested or
- 5.10)- The Secretary shall be empowered to employ full time or part time employees or professionals on retainer ship basis according to the requirement of various institutions time to time. The Governing Body shall have power to accept honorary services of any person volunteering to do the work in the Trust or in the institution run by the Trust. The Governing Body shall have full disciplinary control and power over such staff employees and workers honorary or otherwise.
- 5.11)- The Board of Trustee shall be empowered to add, amend, delete the clause of this Trust Deed or frame any other by-laws for smooth running the Trust by 2/3<sup>rd</sup> majority, and by the consent of Governing Body.
- 5.12)- The Secretary at Governing Body may borrow, raise loan from any other person, bank or financial institutions in such a manner as the Secretary may think proper or convenient for the further rise of object of the Trust and for this purpose the Secretary may secure repayment of these loans in any manner as may be decided from time to time by Governing Body.
- 5.13)- The Governing Body shall be entitled and be at liberty to accept gifts, voluntary contribution from any person, firm or institution or Government and to collect subscription, donation or aid from State/ Central Government to augment the Trust, and use such money for the objects the Trust.
- 5.14)- The Secretary at Governing Body can invest fund of the Trust in securities, banks, immovable properties or in any other manner as decided by the Governing Body.
- 5.15)- The Trustee May give unsecured loans to the Trust or make payment on behalf of the Trust for the purpose of the Trust. On that they shall be paid 18% interest accumulated annually or as decided by the Trust board in consensus from time to time.

5.16:- The Secretary will be authorized to apply for loans in any Bank for expansion/ operation/ opening of the projects (i.e. schools, colleges of any level, hostels, old age homes, widow women homes) with the consent of Chairman.

6:- MEETINGS:-

- The Board of Trustee shall meet at least once in three months.
- The meeting shall be called on behalf of the board by the Secretary by giving seven days notice or such shorter as agreed by the Trustee.
- An annual meeting of the Trustees shall be held every year within six months from close of the financial year for approval of the accounts of the preceding financial year and other activities of the Trust.
- There will be no need of a quorum for adjourned meeting however therein the circulated agenda will only be discussed and decision taken.
- A resolutions passed by circulation by the trustees shall be valid and effective as a resolution passed a meeting of Trustees.

Quorum:- The quorum at a meeting of the Trust shall be 1/3<sup>rd</sup> of the total strength or two whichever is higher.

7:- The Secretary at Governing Body shall have all powers to manage day to day working of the Trust including signing of agreement, operating bank account, appointing or dismissal of employee, accepting donations, investing fund, making rules for day to day management of the Trust, appointing committees and sub committees to do all other acts as authorized by the Governing Body. The Governing Body may delegate such power as may be necessary to any person for fulfillment of its purpose.

8:- FINANCIAL YEAR:-

The financial year of the trust shall commence from 1<sup>st</sup> April and close on 31<sup>st</sup> March of every year.

9:- BANK ACCOUNT:-

The Secretary of the Governing Body will open bank accounts in the name of the Trust in any bank which will be operated by the signature of the Secretary only.

**10- ACCOUNTS & AUDIT:-**

The Trustees shall maintain proper accounts; a chartered accountant appointed by Board of Trustees after fixing his remuneration will annually audit the accounts.

**11- APPOINTMENT OF ATTORNEY:-**

The Board of Trustees through resolution can authorize a person to act a attorney by board of Trustees after fixing his remuneration will annually audit them.

**12- RECORD OF THE TRUST:-**

All records of the Trust will be in office of the Trust under supervision of Secretary.

**13- DISSOLUTION of TRUST:-**

In case if the Trust is dissolved for any reason the entire Trust fund including moveable and immovable properties shall be passed in handover to one and more than one institution having the similar objects. However under no circumstances any of the Trust's funds/ properties shall used for the benefit of the settlor or heir of the settlor. This should be clear that on dissolution of Trust its property will be distributed among institutions run by the Trust or whole property will be given to founder Chairman and founder Secretary or their heir by taking consent of founder Chairman / founder Secretary or their heir.





