1. The name of the Trust shall be SATYAPRABHA CHARITABLE TRUST and its office shall be for the present at Anapur Narayanganj, Post Kothara, Tehsil Larribhua, Distt Sultanpur (U.P.) and at such other place or places as the Trustees herein may decide from time to time.
2. The First Trustees of the trust shall be:

4. The Managing Trustee is empowered to Co-opt Trustees for the trust and fix the terms of their Appointment
5. The Managing Trustee shall have power to administer the Funds of the Trust and any power exercisable by the Board of Trustees as may be delegated to the Managing Trustee.
6. The Managing Trustee shall hold office till life or until he/she resigns therefrom.
7. The Managing Trustee shall have power to fix the terms of the other Trustees of the Trust.
8. The Managing Trustee during the lifetime shall Name the successor to the Managing Trustee and on his/her failure to do so, may be Appointed by the Board of Trustee, on such Terms and Conditions as the Managing Trustee or, as the case may be, the Board of Trustees deem fit.
- 8 (A) Not with standing any above para Senior male trusty who attend the majority shall empowered to gain designation of managing trusty. If his not desire to take above designation of managing trusty of para A or para 8 shall enforce and applicable.

In the further event of any Managing Trustee Dying or ceasing to be a Managing Trustee without leaving in his place any of his/her Male/Female Lineal Descendant Surviving him, the remaining Members of the Board of Trustees shall elect a person to be a Managing Trustee from amongst the then surviving Male/Female lineal descendants of Managing Trustee.
10. In the Contingency of the office of Managing Trusteeship, in Accordance with the above, depending upon any person who may be a minor then, during his minority, the Natural Guardian, or in case of one or more Guardian, whosoever may be Appointed by the Court as the guardian of the property of the minor shall act as Trustee until the minor(s) attained majority. Such person who was minor shall, on attaining majority, act as trustee.
11. Who is next and further trusty a who male blood relative & his wife, legal heirs only in title are qualified person next trusty. In absent of male blood relative female legal heirs are in title inter in the trust.
12. Proper Accounts for the Trust shall be kept at the office of the Trust.

13. Which is moveable and immovable property purchase favour of trust with property shall be Govern by Manager/Secretary / Managing Trusty
14. The trustees of the trust shall also member are institution till the life which established by trust
15. Which person not blood related no empower to enter the trust except the order of District Court.
16. The Managing Trustee shall have overall power of Superintendence over the affairs of the Trust and shall have in particular, the power to operate the Bank Accounts, Borrow Monies for the Trust and carry out the objects of the Trust
17. Proper Accounts for the Trust shall be kept at the office of the Trust.
18. The Initial Contribution of Rs. 5001.00 made by the author of the Trust shall hereby vest in the Trustees and shall constitute the Initial Trust Fund at the time of declaration trust have no immovable property
19. The Trust Fund may be augmented by the income from the Initial Fund and Also by Donations and other Contributions from time to time
20. The Funds of the Trust shall not be applied for any purpose other than the object of the Trust stated in Para 22 below:
21. In case absent of male are female major legal heirs, The minor legal blood relative lega heirs in title refer in to trust as the trusty.
22. The objects of the Trust are as under:
  - (i) To open, Run, Continue an Educational and Vocational Institution that is a High School, Intermediate College, Degree College ETC. B.Ed, B.P.Ed in healthy surroundings, Job oriented course

- (II) To provide Technical Education.
- (III) To provide Computer and Information Education.
- (IV) The Board of Trustees may seek affiliation of any recognized Institution, University, Educational Boards, or other Institution conferring and the information at standard for better functioning, of the Institution.
- (V) To establish, maintain and run a Boarding House and Residential Accommodation for Students and those connected with the Institution.
- (VI) To Accept Donation, Grants, presents and other offerings and to deal with the same for the purpose of the Trust.
- (VII) To Train and equip the pupils so as to be Self-Supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.
- (VIII) To Agricultural farming, product of seed and other development of agricultural.
- (IX) To work for social welfare.
- (X) Medical care maintenance Yoga modification, Satsang Etc for the senior citizen available.
- (XI) To making an old age home for old age citizens.
- (XII) To provide education, training and self dependence to physically Handicapped, mentally weak and blind children.
- (XIII) To provide employment and self depend training to all categories of the society.
- (XIV) To women employment work to upliftment of the socially weak women.

23 Rules may be framed for the proper Administration of the Trust, but such Rules shall not be against the objects of the Trust as in Clause 16 above.

24. For the Removal of doubts it is hereby declared that this Trust, its objects and its Implementation shall not be for the benefit of any particular caste or religious community as such.
25. The Board of Trustees shall meet as often as may be necessary or convenient to transact business. The Board of Trustees might transact Business and take decisions also by Circulation of papers.
26. All decisions of the Board of Trustees shall be taken either Unanimously or by majority and if the Board divided, the Managing Trustee will have the casting vote.
27. Without prejudice the powers of the Board of Trustees the Managing Trustee shall manage and Administer the affairs of the trust and shall also exercise such power and function as may be delegated to him by the Board of Trustees.
28. The Management and Administration of the Trust shall vest in the Board of Trustees.
29. The Funds of the Trust shall be invested in Bank Deposits, Government Bonds or such other Appropriate Security as the Board of Trustees may decide.
30. The Board shall have power to borrow Monies for the purposes of the Trust.
31. Without Prejudice to the generality of the provisions contained above the Board of Trustees may also empower the Managing Trustee to represent or Act for the Trust in any matter concerning the properties, Funds, investments, Borrowings and the making or Cancellation of any Instruments for any of these purposes.
32. The Managing Trustee may authorize any of the Trustees to act on his behalf and to operate Bank Accounts etc. If the managing trustee finds that some property is making a loss or it is not possible to manage that property properly then the managing trustee would be empowered to sell that property and would invest that amount for welfare of the trust.

34. The Trustees shall have power to accept Donations in Money or otherwise for the purposes of this Trust
35. The Trustees shall have power to Appoint personnel to organize and promote the objects of the Trust and to regulate their conditions of service, including matters of discipline.
36. Managing Trustee can get donations and other economical support by State Govt. Central Govt., Khadi Gramodyog, Economic Institution, Persons, Banks, Foundations & Social evolutors etc.
37. Account of Trust will be governed & mentioned by Managing Trustee Only
38. All Acts and proceedings of the Trust shall be taken and conducted in the name of the Trust.


