Any Trustee who acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or is otherwise unfit to continue as Trustee shall be liable to be discharged from its office by a resolution passed by the least $3/4^{\text{th}}$ majority of the total Trustees for the time being except the Trustee

Any question arising in the administration of the trust shall be decided by the majority of the trustees acting for the time being.

That the founder shall be the Chief Trustee/ Chairman of the Board of the Trustees for his life time or till he resigns or feels himself incapacitated or incapable of performing his duties. The Chief Trustee/Chairman of the Board of Trustees shall be entitled to nominate some other trustees as the Chief Trustee/ Chairman of the Board of Trustees during his lifetime or after his death.
