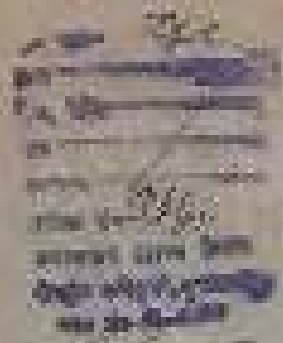

- 8A- Not with standing any above para Senior male trusty who attend the majority shall empowered to gain designation of managing trusty. If his not desire to take above designation of managing trusty of para A. of para 8 shall entered and applicable.

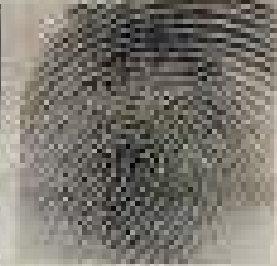

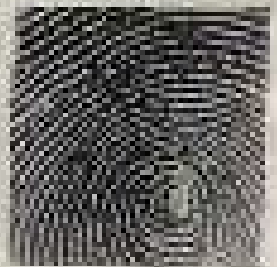

- 24- For the Removal of doubts it is hereby declared that this Trust its objects and its Implementation shall not be for the benefit of any particular caste or religious community or such.
- 25- The Board of Trustees shall meet as often as may be necessary at convenient to transact Business. The Board of Trustees might transact Business and take decisions also by Circulation of papers.
- 26- All decisions of the Board of Trustees shall be taken either Unanimously or by majority and if the Board divided, the Managing Trustee will have the casting vote.
- 27- Without prejudice the powers of the Board of Trustees the Managing Trustee shall manage and Administer the affairs of the trust and shall also exercise such power and function as may be delegated to him by the Board of Trustees.
- 28- The Management and Administration of the Trust shall vest in the Board of Trustees.
- 29- The Funds of the Trust shall be invested in Bank Deposits, Government Bonds or such other Appropriate Security as the Board of Trustees may decide.

- 31- Without Prejudice to the generality of the provisions contained above the Board of Trustees may also empower the Managing Trustee to represent or Act for the Trust, in any matter concerning the properties, Funds, Investments, Borrowings and the making or Cancellation of any Instruments for any of these purposes.
- 32- The Managing Trustee may authorize any of the Trustees to act on his behalf and to operate Bank Accounts etc. If the managing trustee finds that some property is making a loss or it is not possible to manage that property properly then the managing trustee would be empowered to sell that property and would invest that amount for welfare of the trust.
- 33- The managing trustee is empowered to lease the property of the trust to generate money for the welfare of the trust and to purchase the immovable property in favor of Trust.
- 34- The Trustees shall have power to accept Donations in Money or otherwise for the purposes of this Trust.
- 35- The Trustees shall have power to Appoint personnel to organize and promote the objects of the Trust and to regulate their conditions of Service, including matters of discipline.
- 36- All Acts and proceedings of the Trust shall be taken and conducted in the name of the Trust.

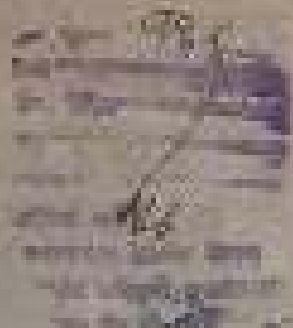
