The Trust is hereby specifically declared to be a public charitable trust and all the Provisions of this deed are to be constituted accordingly".

That notwithstanding anything here in before the contained income as also the corpus of the Trust Estate shall be applied and be applicable only to or for such territories only and subject to such conditions or limitations, if any as from time to time to be laid down in the Income Tax Act, 1961 or any other Act governing taxation of income






6. REMUNERATION TO TRUSTEES


7. ARBITRATION


