- (iii) The trustees shall employ such staff as they think necessary for giving the necessary human resource infrastructure and setup in the field of education and service to fulfill the object of the trust and replace them whenever they deem it necessary.
- (iv) The Trustees may accept any gift donations, aids, grants, etc. from individual, concern body corporate or government institutions or otherwise from any sources based in India and abroad for and on behalf of the Trust for the objects of the Trust.
- (v) Out of the receipts of the trust fund which will also include aids, grants, donations etc. received by the Trust, the Trustees shall defray the expenses for the running and managing of the institutions and other set ups as aforesaid and capital expenditure for erecting building and creating other infrastructure for purpose of the objects of the trust. but if the receipts are insufficient for that purpose the trustees may use such portion of the trust fund as may be necessary.
