(23) In the professional execution of the Trust and powers hereof no trustee shall be liable for any loss to the trust property arising by reason of any other matter or thing except wilful fraud or wrong act on the part of the trustees who is ought to be made liable.

(24) The trust can sue and be sued for the safe guard of interest and property of the trust. The chairman is only entitled to represent in the courts on behalf the trust or any other trustee authorised by the chairman to that effect.

(25) In the event of any dispute between the trustees regarding trust's property and

its management, no person is entitled to file any suit in any court. If any dispute arises for the property of the trust & its management it will be decided by Panch Paisala (Arbitration). The arbitrators shall be appointed or nominated by the all the trustees and the chairman.

But if any time the trustees find or come to know that any provision herein invalid or to law it shall be their duty to or all such particular provision so that the other provisions here of may not be rendered invalid or

(27) The Founder/Chairman may within the basic structure of this deed framed, alter add, substitute any clause in the list of the trust.

(28) In the event of dissolution of the Trust for any reason, the assets of the trust shall reback to original donors and trustees or either in absence of their heirs and legal heirs that would be settled by arbitration and decision of chairman would be absolute.
