DEED OF A TRUST

This Deed of Public Charitable Trust executed on this 10 day SEPTEMBER of 2020 by Shri ARUNESH KUMAR YADAV son of Shri RAMLAL YADAV Resident of NEW SHANKARPUR COLONY, BEHIND HIMCITY, NEAR MADIYAON POLICE STATION, SITAPUR ROAD LUCKNOW, UTTAR PRADESH (INDIA) and Mrs. RICHA YADAV W/O ARUNESH KUMAR YADAV Resident of VILL- PAHARAPUR, PO- KHALGAON, TEHSEEL- MAHMOODABAD DIST- SITAPUR, UTTAR PRADESH (INDIA) hereinafter called the 'Author cum Chairman Trustee and Managing Trustee of the Trust' respectively.

Whereas the Authors (Chairman Trustee and Managing Trustee respectively) of the Trust are desirous of establishing a trust for public charitable objects with these trustees.

And whereas it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents.

Now this indenture witnesseth as follows:

1. That, in order to effectuate his aforesaid desire, the settlors have set apart sum of Rs. 1100/- each hereinafter called the 'Trust Fund' which expression shall include cash and any other property or

- investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents, and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.
- 2. That the name of the trust shall be "RG TRUST" (RAMLAL GYANWATI TRUST) and its office shall, for the present, be situate at VILL- PAHARAPUR, PO- KHALGAON, TEHSEEL- MAHMOODABAD DIST- SITAPUR, Pin Code- 261301, UTTAR PRADESH (INDIA) and/or at such other place or places including Union States and Union Territories in India or any where of the World as the trustees may decide from time to time by 2/3 majority.
- 3. That the objects trust is established are:
 - A. The object of the Trust is open to all irrespective of caste, creed, colores, religion, area, sex etc.
 - B. To establish, maintain, run or grant help to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
 - C. To promote Non-Violence, compassion to living creatures, vegetarianism etc.

- E. To coordinate with institutions, trusts, organizations, societies, etc having similar objects of this trust.
- F. To take care, establish, support, run, maintain, grant help to the monuments of national, cultural, religious, spiritual importance of any nation, culture, religion, sect and organize street theatre folk arts and cultural programs in order to proclaim the social awareness.
- G. To grant help to the farmers directly or to establish, support, run, maintain, grant help to institutions, organizations, committees for the promotion & betterment of farmers, agriculture and nature.
- H. To Stablish, Organize, Consolidate, Start, Re-start, Develop, Takeover, Conduct, Equip, Endow, Improve, Alter, Administer, Extend, Run, Manage, Maintain with or without charges and with or without aid, Schools, Colleges, Univesities, medical Colleges and Universities, Engineering Colleges and Universities, pramedical Institutes and Universities, Farmacy Colleges and Universities, Agriculture Colleges and Universities, Colleges and Universities for Physically Handicaps, Laboratories, Hostels, Libraries, Reading Rooms, Resorch Centres and other Institutions and centers for Pre Primary to Class Eight (class 8th), Secondary Education, Higher Education, Commerce Education, Technical Education, Technological Education, All branches of Science, Engineering, Theological, Scientific resorch, Medical, Legal, Management, Machine, Accounting, Music, Painting, Spritual, Moral, Cultural, Ethical, Social, Sculptural, Architectural, Electronics, Computer, Physical, Audio Visual adds.

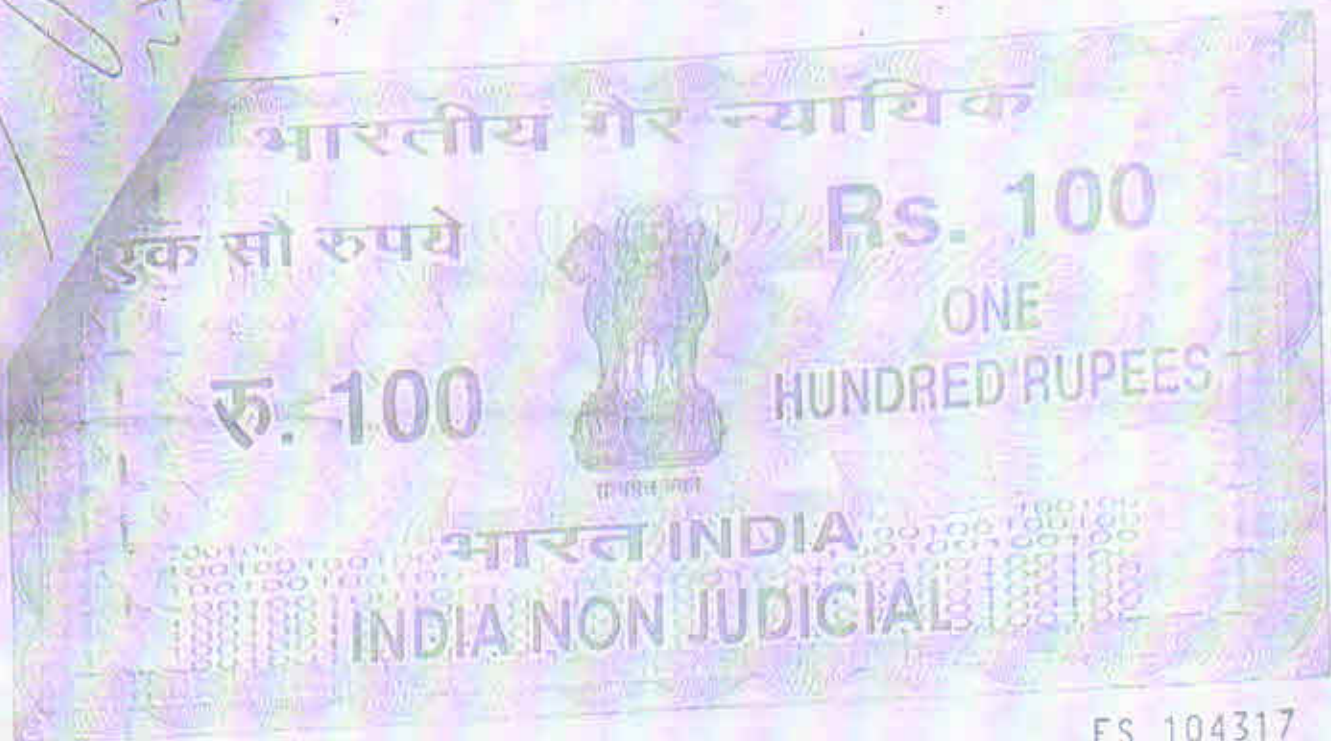
