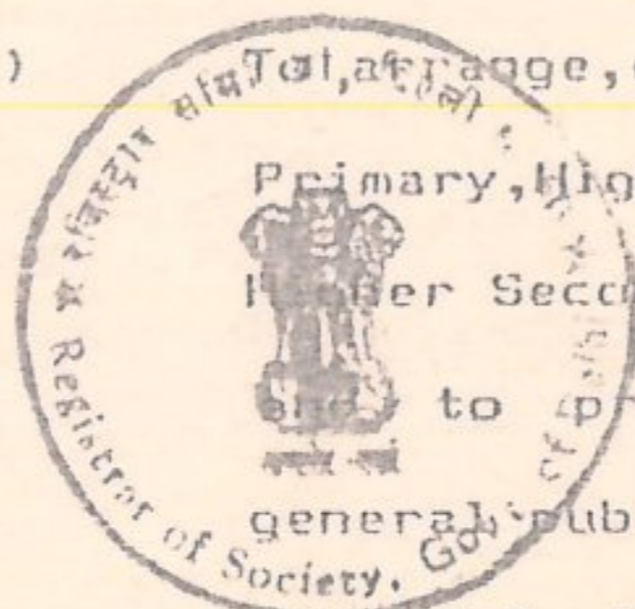

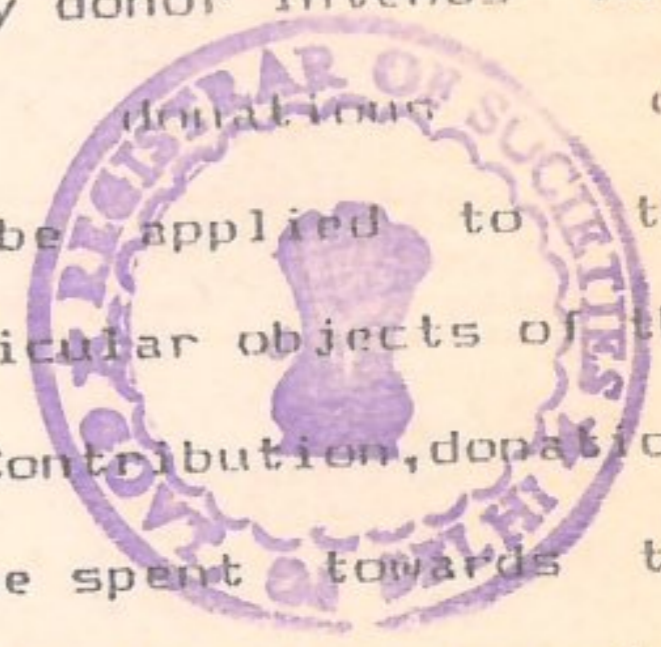
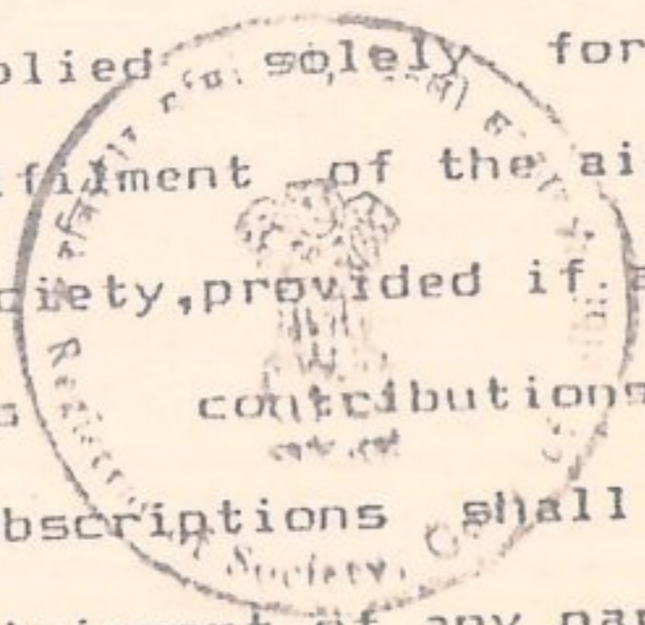

(ii) To acquire by purchase, take on lease, hire or by gift and hold any moveable or immoveable properties of any right, or privileges that may be deemed necessary or useful for the advancement of the objects of the Society.

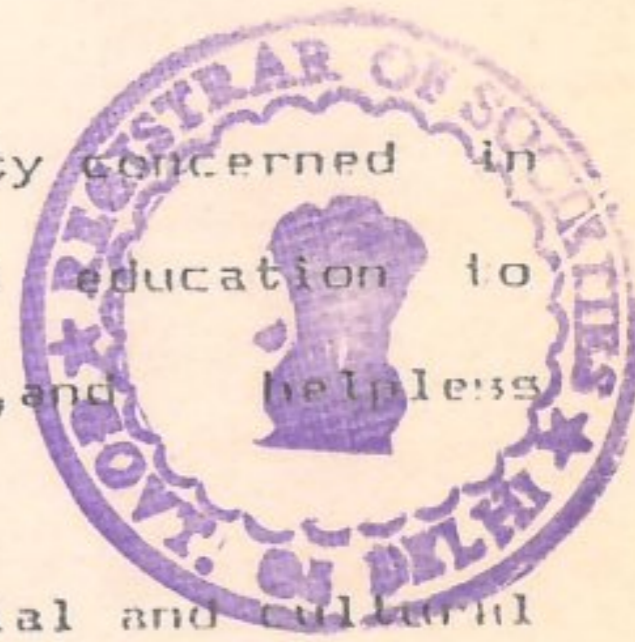
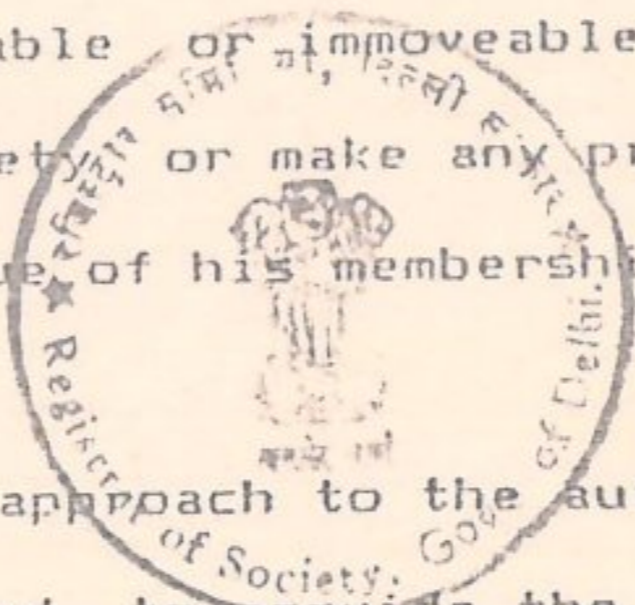

No member of the Society shall have any personal claim on any moveable or immoveable properties of the Society or make any profits, whatsoever by virtue of his membership.



- (iv) To approach to the authority concerned in regard to provide the Adult education to the un-educated adults, and helpless children.
- (v) To arrange and organise social and cultural programmes from time to time.
- (vi) To Publish Books, Charts, Illustrations, Periodicals and other Publications.
- (vii) To establish and maintain institutions for the handicaped to rehabilitations of young boys and girls.

(viii) And generally to do other acts, Deeds and things for attainment of the aims & objectives of the Society.

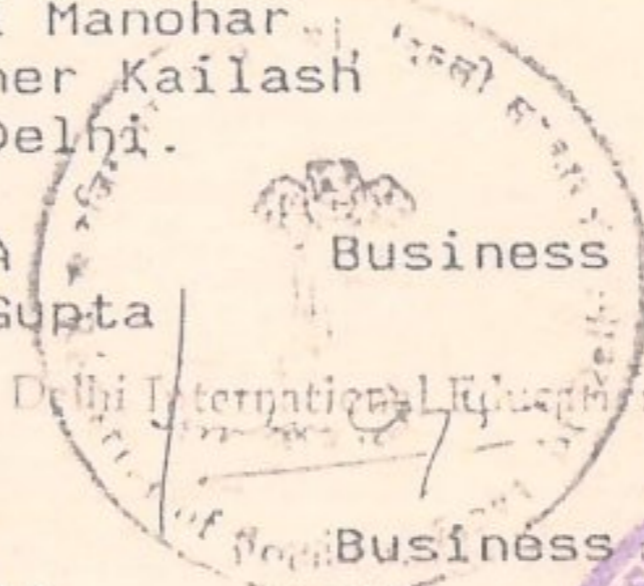

SUBSCRIPTIONS :- Admission fee Rs.1000/-at the time of admission.

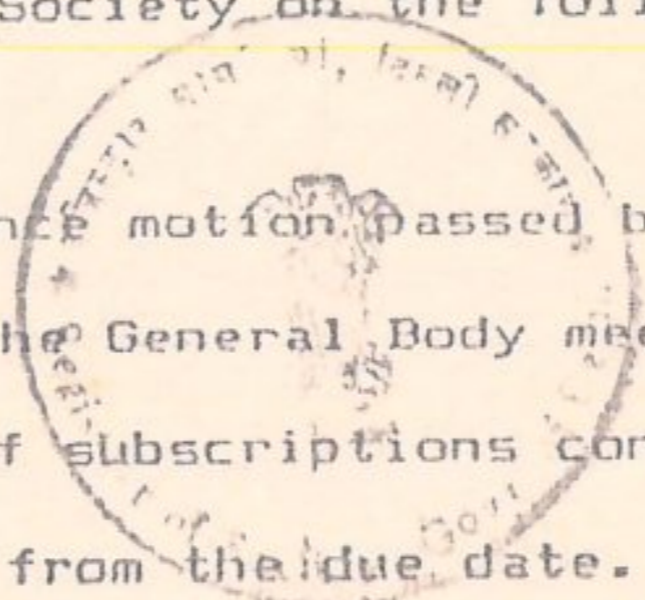
Subscriptions Rs100/-per month.

TERMINATION OF MEMBERSHIP:

The Governing Body shall have the power to expel a member from the Society on the following terms and conditions :-

- a) By no confidence motion passed by 2/3rd majority of votes, in the General Body meeting.
- b) Non payment of subscriptions continuously for three months from the due date.
- c) On his/her written resignation.
- d) He/She has not attended three consecutive meeting of the General Body without intimation.

The reason of termination from the membership shall be communicated to the member concerned.

All the appeals should be preferred to the general body of the society, the decision of the General Body shall be final. The reason for rejection shall be communicated to the member concerned.

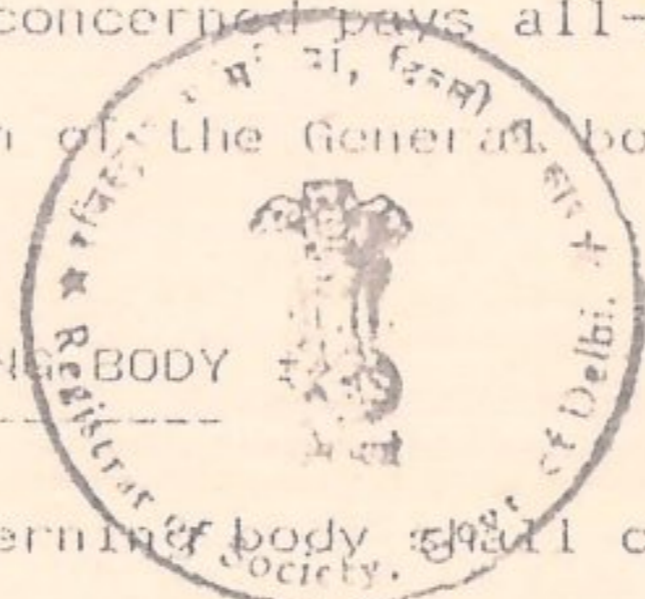
5. READMISSION :

7. BANK-ACCOUNT :

The Bank-Account of the Society shall be operated by the Treasurer and any one out of the General Secretary and the President.

8. GENERAL BODY:

All the members of the Society will constitute the General Body.

9. FUNCTIONS OF THE GENERAL BODY :

- a) To consider any business brought forwards by the Governing Body.
- b) There shall be an annual meeting of the General body in the month of March of every year.
- c) Not less than 15 days prior notice shall be given to the member before the date of General body meetings enclosing the Agenda specifying date, time and place and the quorum shall be 2/3rd.

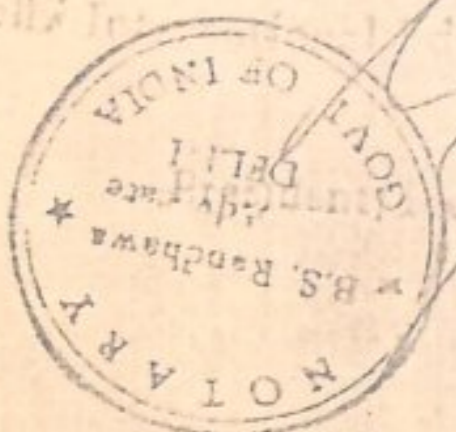
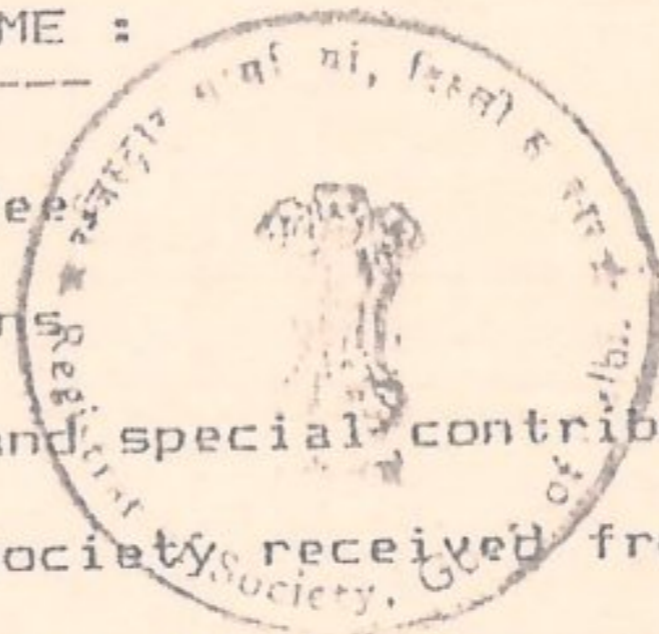
10) SOURCES OF INCOME :

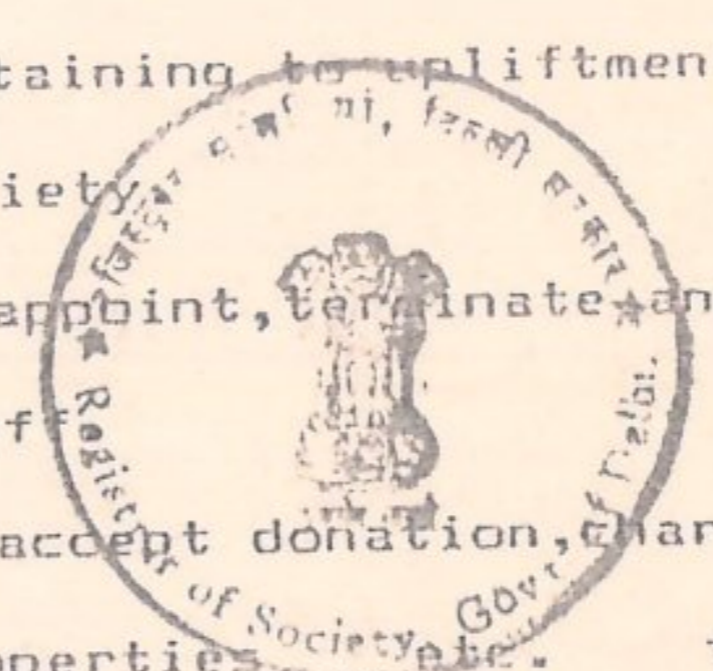

12. ELECTION AND QUORUM :

The General Body in its annual meeting will elect its President and all the office bearers, and members after two years by secret ballot papers. The quorum of the General Body and the Governing Body shall be 2/3rd.

13. FUNCTIONS OF THE GOVERNING BODY :

- a) To arrange finance if required from other Bank(s), Institutions or Individuals on reasonable terms and conditions and the Governing Body as a whole shall be liable for its return.
- b) The Governing Body shall make plan for the future programmes of the Society.
- c) The Governing Body shall meet at least once in a month.
- d) To publish literature and to propagate the system, to approach the public pertaining to upliftments of status of the Society.
- e) To appoint, terminate and fix duties of staff.
- f) To accept donation, charities, loans, properties of Society, Govt. of Punjab, Associations, Agencies, Govt. Deptt., in the interest of the promotion of aims and objectives of the Society.

All the income of the society shall be deposited in the Nationalised Bank.

14.a) REGISTER OF MEMBERS :

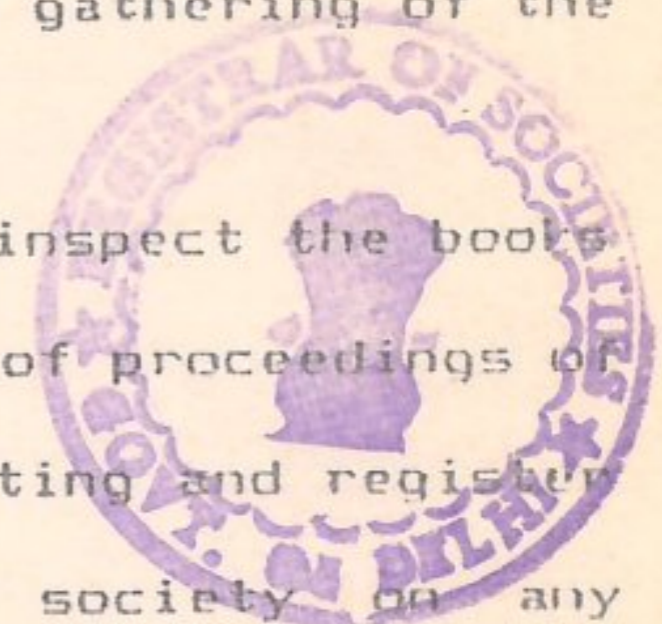
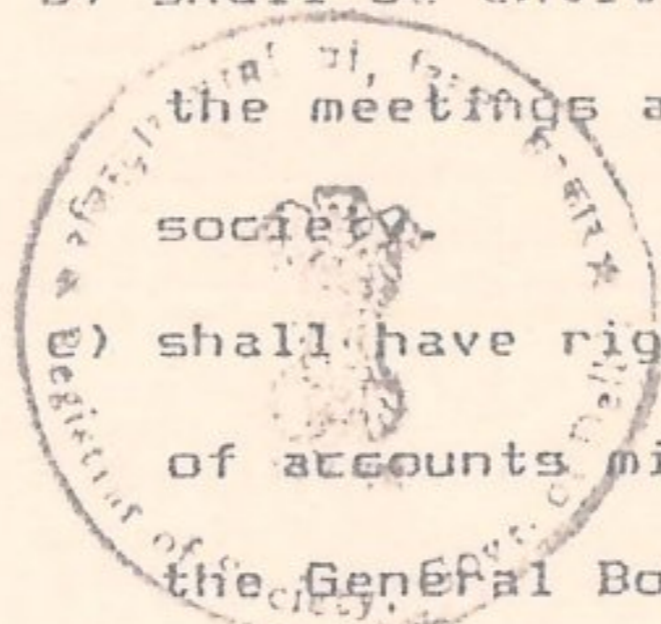
The Society shall maintain at its registered office, a register of its members and shall enter therein the following particulars :

The casual vacancies may be filled up by the resolution passed by both the Governing Body and General Body.

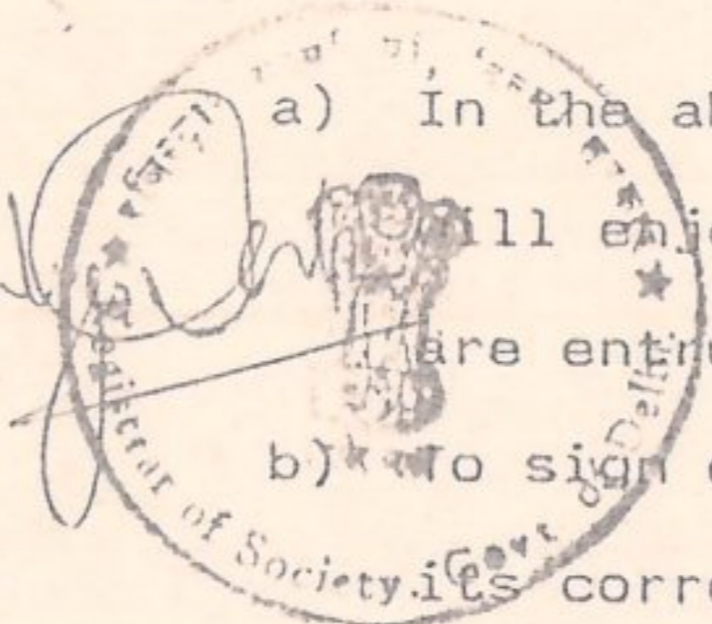
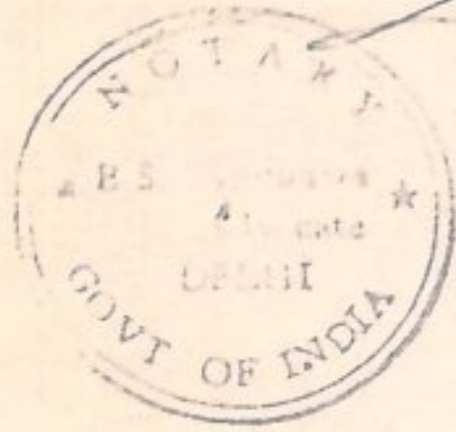
15. POWERS AND DUTIES OF THE OFFICE BEARERS :

CHAIRMAN :

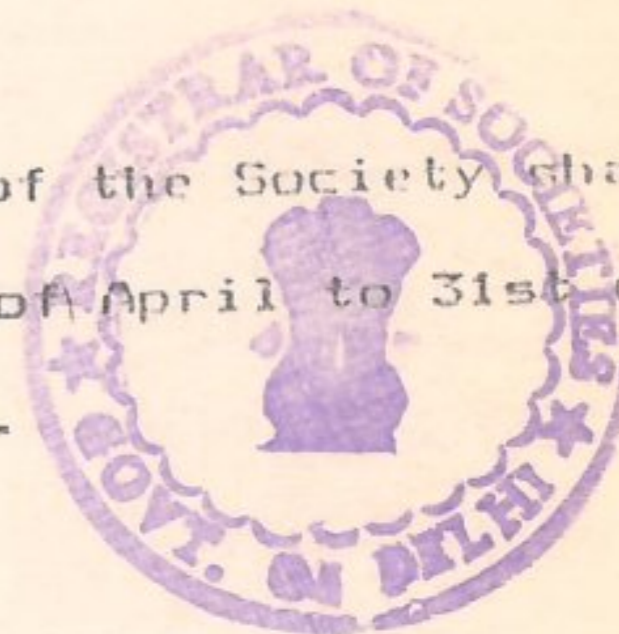
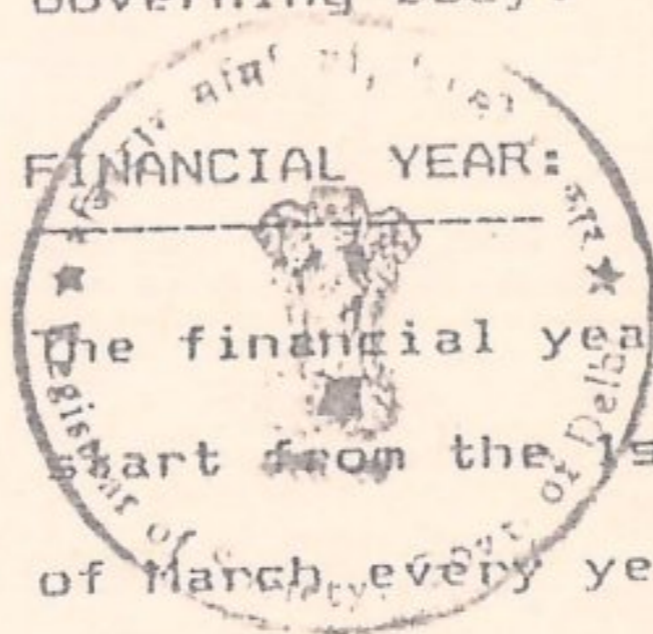
AUDIT :
